









#### Conclusions of the Steering Committee Meeting

On 5 March 2024, the Fourth Steering Committee Meeting (SCM) of Child Project 1.1 "Reducing Pollution from Harmful Chemicals and Wastes in Mediterranean Hotspots and Measuring Progress to Impacts" (GEF ID 9684) of the Mediterranean Sea Programme (MedProgramme): Enhancing Environmental Security (GEF ID 9607) was held in Athens. The Meeting was organized by UNEP/MAP Secretariat/MedPCU.

Further to its deliberations, the SCM reached the following conclusions and recommendations:

- 1. The SCM took note of work progress achieved to date by the Executing Partners under the three components (Chemical and Waste, International Waters and Monitoring and Evaluation) of the MedProgramme's Child Project 1.1 and agreed on the importance of continued collaboration among the different partners for the efficient implementation of the activities.
- 2. The SCM welcomed the appointment of the Midterm Review Consultant and committed to providing necessary information and data as required.
- 3. The SCM agreed to hold an extraordinary Steering Committee Meeting in September 2024 further to the conclusion of the mid-term review with the aim to review the disposal contracts as well as the new POPs prevention pilots. The MedPCU is requested to propose the modality, agenda and date/venue of the meeting.
- 4. With regards to disposal activities of PCB and Hg, the SCM:
  - i. Endorsed the decision for engaging UNOPS for procurement of Phase 2 disposal contracts of the PCB stocks in Albania, Bosnia and Herzegovina and Montenegro, as well as Mercury and PCB in Tunisia. The SCM requested MedPCU to immediately initiate the procurement process.
  - ii. Confirmed the need to hire national consultants in participating countries to coordinate with governmental agencies and oversee/report on disposal activities. To this end, the MedPCU is requested to update the three budget line descriptions to stipulate "national/regional consultants" (currently listing "regional consultants" only).
  - iii. Confirmed that the final waste quantities to be included in the tender documentation may be updated flexibly pending confirmation of PCB stocks availability in Albania, Bosnia and Herzegovina, and Tunisia. The MedPCU was requested to confirm when the final tender documents will be submitted for the procurement process. Tunisia was requested to provide existing inventory data for potential 400 tons of PCB waste, no later than 20 March 2024.
- 5. With regards to prevention activities of PCB and Hg, the SCM:
  - i. Requested the development of knowledge products on new POPs by MedWaves.
  - ii. Requested the Countries to engage MED POL and/or MedWaves to propose pilot projects for further consideration as part of the work undertaken by MedWaves. Proposal(s) to include workplan, required budget, and outcomes in terms of tones of POPs prevented, to be reviewed and decision taken in the September SCM.
- 6. The SCM agreed with the proposal of MedPCU to support funding Small Scale Financing Agreements (SSFAs) for 9 GEF Countries in order to develop National Action Plans in accordance with Article 15 of the LBS Protocol. To this aim, the SCM took note that the NAPs will address national transboundary priority issues and impacts which will be considered in the reformulation of a summary TDA report for the Mediterranean.
- 7. The SCM reviewed the work plan of CP1.1 for the year 2024. The SCM approved planned activities subject to incorporating the above-mentioned recommendations.
- 8. The SCM took note of the budget forecast and expressed its concern on the high balance unspent by end of March 2025 (approximately USD 3 million) and endorsed the proposal to extend the project for one additional year (March 2026).

- 9. Regarding the proposed budget revisions (depicted in document: UNEP/MED WG.580/3), the SCM:
  - i. agreed with the proposal of the Secretariat/MedPCU to reallocate a total of USD 185,000 from the three budget lines for the regional experts for POPs, Hg and capacity building to compensate for the technical work undertaken by the Programme Officer CW (P3) in 2022-2023.
  - ii. Agreed with the proposal of the Secretariat/MedPCU to reallocate a total of USD 387,155 from the Programme Officer CW (P3) PMC to the Finance Budget Officer and Finance Assistant of the MedPCU.
  - iii. Noted that the proposed budget revisions require further time for review. The SCM requested an additional one week to provide feedback and agreement to the remaining proposed budget revisions under CW and IW, with a silent approval procedure.
- 10. The SCM confirmed that the Implementing Agency has the authority to approve in line with GEF and UNEP financial rules, the re-categorization of individual budget lines within the Umoja classes as proposed by the Executing Agency, countries and project partners, provided that there is no re-purposing in the total amount, substantive activities and component totals.
- 11. The SCM requested the MedPCU to provide a detailed procurement plan for the year 2024 for their consideration with a silent approval procedure within 2 weeks of receipt.

#### Report of the Meeting

#### Introduction

- 1. In the framework of the Global Environment Facility (GEF) funded Mediterranean Sea Programme (MedProgramme): "Enhancing Environmental Security (GEF ID 9607), and Child Project 1.1"Reducing Pollution from Harmful Chemicals and Wastes in Mediterranean Hot Spots and Measuring Progress to Impacts" (GEF ID 9684) executed by UNEP/MAP, the MedProgramme Coordinating Unit (MedPCU) held its 4<sup>th</sup> Project Steering Committee Meeting of Child Project 1.1 in Athens, Greece on 5 March 2024.
- 2. The primary objective of the Project Steering Committee Meeting was to take stock of work progress and to review and validate the work plans and budgets of the Child Project 1.1 for the forthcoming year.

#### **Participation**

- 3. The Steering Committee Meeting was attended by representatives from the following GEF-Participating Countries: Albania, Bosnia and Herzegovina, Lebanon, Montenegro, Morocco, Tunisia and Türkiye. The Meeting was also attended by the United Nations Environment Programme (UNEP), including the Mediterranean Action Plan/ Barcelona Convention Secretariat (UNEP/MAP) as well as the Programme for the Assessment and Control of Pollution in the Mediterranean Region (MED POL). Also represented in the meeting were the Regional Activity Centre for Sustainable Consumption and Production (SCP/RAC MedWaves), and GRID Geneva (UNEP Partner).
- 4. The full list of participants is attached as Annex I to the present report.

#### Agenda item 1: Opening of the Meeting

- 5. The Meeting was opened at 9:30 AM on 5 March 2024 by UNEP/MAP Coordinator, Ms. Tatjana Hema. In her opening remarks, she welcomed the participants and provided a summary overview of the changes currently underway for the management of the MedProgramme at UNEP/MAP and MedWaves. She praised the work accomplishments of outgoing officers and indicated that work progress will continue and gaps in vacant posts will be promptly filled. She made note of the ongoing midterm evaluation requesting the cooperation of the countries in providing information and reporting of data. She stressed the need for the project to succeed and requested the meeting to adopt the necessary provisions in that direction.
- 6. Ms. Eloise Touni, UNEP-GEF Chemical and Waste (CW) Task Manager indicated from her side that work progress in 2023 was an important step forwards in the disposal activities of PCB and mercury, but that further attention is needed, particularly in relation to the Basel notifications. She made note of the current expenditure rate at 15% while indicating that it should be at 75% in view of the start and end dates of the MedProgramme. She noted the ongoing mid-term evaluation, and the need to contribute to reporting of results. She referred to the ratification of the Minamata Convention by the Countries and inquired about delays they are facing about proceeding forward with ratification seeking their explanations during the discussions.

#### Agenda item 2: Adoption of the Provisional Agenda and Organization of Work

7. The Steering Committee Meeting elected Ms. Tamara Brajovic from Montenegro as Chair of the Meeting.

- 8. The proposed agenda appearing in document UNEP/MED WG.580/1 was presented by the MedPCU Programme Coordinator, Mr. Mohamad Kayyal. The Steering Committee Meeting reviewed and accepted the agenda as included in Annex II to this report.
- 9. The discussions were held in two daily plenary sessions, convened over one day, from 9:30 to 12:30 and 14:30 to 17:30. Simultaneous interpretation in English and French was available for both sessions. The meeting was recorded for future reference.
- 10. The Meeting addressed all Agenda items. The Meeting closed on 5 March 2024 after adopting its Conclusions and Recommendations appended in Annex III to this document.

#### Agenda item 3: Review of Child Project 1.1 Implementation Progress

- a) Component 1: Chemicals and Waste
- 11. Under this component of agenda item 3, the MedPCU Programme Coordinator presented work progress achieved to date in both Algeria and Lebanon for Phase 1 disposal activities and provided an overview of work planned under Phase 2 in Algeria, Albania, Bosnia and Herzegovina, and Montenegro as well as Tunisia. He gave an update of the status of preparation of the PCB inventories and the Environmental Sound Management (ESM) reports for Mercury. He provided an overview of the procurement status, noting the signature of the two contracts in 2023 for disposal of PCB in Lebanon and Algeria which is a major milestone of the project. He proposed engagement of the United Nations Office for Project Services (UNOPS) for undertaking Phase 2 disposal contracts in these countries due to their relatively rapid procurement processes. The Steering Committee endorsed the engagement of UNOPS for Phase 2 of the disposal activities in Albania, Bosnia and Herzegovina, and Montenegro as well as Tunisia for both mercury and PCB disposal.
- 12. At the conclusion of the presentation, countries' representatives provided an update of the status of work progress in their individual countries. Tunisia inquired about the possibility of including additional quantities of approximately 490 tons of PCB. Albania provided information about status of preparations of its PCB inventory. Montenegro briefed about two assessments on mercury and PCB in the Port of Montenegro area and updated on the ESM preparations for mercury. MedPCU took note of the countries report for further follow-up.
- 13. UNEP/MAP Coordinator indicated that additional quantities from Tunisia can be included if details on inventory can be provided without delay. UNEP-GEF CW Task Manager indicated that additional quantities can be incorporated into the new contract for Phase 2 up to 10% of total agreed amounts; noting that the additional quantity provided by Tunisia would enable the MedProgramme to achieve the target PCB quantity to be disposed of 2000 tons. The Meeting requested Tunisia to provide inventory data for the potential additional amounts of PCB no later than 20 March 2024. Tunisia confirmed its commitment to meet the above deadline.
- 14. Mr. Jordi Moles Matinero, Project Manager at MedWaves gave a presentation on work progress related to the new POPs prevention pilots. He explained the challenges facing MedWaves to proceed in completing this work including change of officers in charge; procurement of services of local laboratories; the complex national regulatory frameworks; and delays in execution due to restrictive contractual frameworks and administrative structures governing the operational processes of MedWaves.
- 15. MedWaves Project Manager discussed implementation of three case studies/pilot projects in Lebanon, Morocco and Tunisia, noting that these countries were selected further to the recommendations of the 3<sup>rd</sup> CP1.1 Steering Committee Meeting in 2023. In response, UNEP-GEF CW Task Manager inquired whether these case studies are based on existing plans or entail new activities. Morocco indicated that they will confirm implementation after checking with relevant national agencies. Bosnia and Herzegovina inquired whether the pilot projects can be expanded to more than 3

countries, noting that river monitoring of new POPs can be included, which would address also transboundary aspects between countries.

- 16. UNEP-GEF CW Task Manager inquired whether the countries have national entities technically qualified to implement the pilot projects, noting that these pilots should be implemented further to the approval of the countries, with the aim to reduce generation of new POPs.
- 17. With regards to other countries wishing to join in implementation, UNEP-GEF CW Task Manager requested countries' representatives interested to join to contact MedWaves and/or MED POL directly by submitting proposals, workplans and budgets to prevent generation/contamination with new POPs in their countries, including outcomes in terms of tonnage of POPs to be prevented. Based on this submission, MedWaves would assess budget availability and a decision can be reached on the way forward.
- 18. Several countries requested that MedWaves develop knowledge products on new POPs. The MedPCU concurred with this request.
- 19. UNEP-GEF CW Task Manager proposed to include the case studies/pilot projects, including proposals for new pilot projects, in the agenda of the extraordinary Steering Committee Meeting which will be called to convene in September 2024 further to the conclusion of the mid-term review. She also proposed to review the disposal contracts for Phase 2 during this extraordinary Steering Committee Meeting. The Meeting agreed with the proposal as stipulated in the conclusions and recommendations presented in Annex III of this report.
  - b) Component 2: International Waters
- 20. The UNEP/MAP Coordinator provided an overview of the offshore consultancy activity, noting that the aim is to develop an offshore monitoring strategy culminated with the selection of 20 monitoring stations in all GEF-participating countries, from which 5 stations will be piloted for developing concrete monitoring programmes. With regards to the data sharing policy included as one of the outputs of this component, the UNEP/MAP Coordinator noted that InfoRAC has already developed this policy; nevertheless, they can assist in the implementation of the related activity. The MedPCU took note for further follow-up.
- 21. Libya inquired whether they can participate in offshore monitoring. The UNEP/MAP Coordinator noted that Libya is indeed eligible. Morocco inquired whether countries are involved in the selection of the monitoring stations. The UNEP/MAP Coordinator responded that these stations are selected jointly, noting that by September 2024, it is anticipated that the 20 monitoring stations and 5 pilot stations would be selected.
- 22. The MedPCU proposed to provide support to MED POL by funding Small Scale Funding Agreements for the GEF-participating countries in order to develop National Action Plans (NAPs) in accordance with Article 15 of the LBS Protocol. The Meeting approved the proposal by MedPCU noting the need for the NAPs to address national transboundary priority issues and impacts to be considered in the reformulation of a policy summary document for Transboundary Diagnostic Assessment (TDA) report.
- 23. The conclusions and recommendations under this agenda item for Component 2 of CP1.1 are presented in Annex III of this report.
  - c) Component 3: Monitoring and evaluation and information dissemination
- 24. Further to the presentation by MedPCU of the work progress of activities implemented under this component, the participating countries did not provide any comment. Note was taken by the Meeting for the convening of the upcoming annual stocktaking meeting and the recommendations of the mid-term review in June 2024.

#### **Agenda item 4: Workplan 2024 - 2025**

- 25. Under this agenda item, the MedPCU Programme Coordinator and MedWaves Project Manager presented the Workplan of Child Project 1.1 for Components 1 on PCB and mercury disposal/reduction; Component 2 on International Waters; and Component 3 on Monitoring and Evaluation.
- 26. The Steering Committee Meeting approved the proposed Work Plans included in Annex IV as per the conclusions and recommendations under this agenda item presented in Annex III of this report.

#### Agenda item 5: Budget for Workplan 2024 - 2025

- 27. Under this agenda item, the MedPCU Programme Coordinator presented the expenditure status and budget forecast for CP1.1 for Q2 to Q4/2024 and Q1/2025.
- 28. The MedPCU presented proposals for budget revisions under UMOJA classes of personnel, travel, contractual and operational. Several countries requested that the allocated budget for recruitment of regional experts is expanded to cover national experts too. The MedPCU took note of the countries request for implementation in future recruitments.
- 29. One country requested MedPCU to submit a detailed procurement plan for 2024 for their consideration. MedPCU concurred with the request. The procurement plan is included in Annex V of this report for the consideration and approval of the Countries with the silent approval procedure within 2 weeks.
- 30. The Steering Committee Meeting approved the revision of the budget and the budget forecast for 2024. The revised budget updated further to the conclusions and recommendations of this meeting, along with the budget forecast are included in this report as Annexes VI and VII, respectively.
- 31. The Steering Committee Meeting, and further to its deliberations on the status of implementation and budget expenditures to date, approved the proposed MedPCU extension of the CP1.1 for one year (till March 2026) as stipulated in the conclusions and recommendations presented in Annex III to this report.
- 32. The Meeting agreed to amend the Internal Cooperation Agreement between the Implementing and Executing Agencies in order to accommodate the proposed one-year extension of the project duration to complete activities by March 2026, as well as accommodate the budget revisions as presented and endorsed by the Steering Committee Meeting.

#### Agenda item 6: Any Other Business

33. No issues were raised for this agenda item on "any other business".

#### **Agenda item 7: Conclusions and Recommendations**

34. The Meeting reviewed, commented on, and approved the draft Conclusions and Recommendations as amended and attached to the present report as Annex III.

The SCM confirmed that the Implementing Agency has the authority to approve in line with GEF and UNEP financial rules,<sup>3</sup> the re-categorization of individual budget lines within the Umoja classes as proposed by the Executing Agency, countries and project partners, provided that there is no re-purposing in the total amount, substantive activities and component totals.
- 11. The SCM requested the MedPCU to provide a detailed procurement plan for the year 2024 for their consideration with a silent approval procedure within 2 weeks of receipt.
