## "Choking in plastic: Addressing water pollution to ensure the right to a healthy environment and the achievement of SDG 6 for youth"

## Wednesday 26 April 2023, 1:30 - 2:45 p.m. EST

#### 1. Background

The UN Environment Programme (UNEP) and the Office of the United Nations High Commissioner for Human Rights (OHCHR), in partnership with the UN Department of Global Communications, will hold a virtual youth-led side event to discuss how plastic pollution in water impacts the right to a clean, healthy, and sustainable environment (right to a healthy environment) and the achievement of the 2030 Agenda for Sustainable Development.

Plastic pollution negatively impacts human health and the environment and compromises our ability to achieve the Sustainable Development Goals (SDGs), including SDG 6, SDG 7, and SDG 3, and to enjoy our human rights. In recent decades several studies have brought to light the risks of plastic pollution to human health through water and food systems. In 2021, UNEP published a global assessment report titled <u>"From Pollution to Solution"</u> which found that about 80% of total marine litter constitutes plastics which is ingested by marine life, and ends up inside the human body through consuming them. UNEP also published a <u>technical report</u> in 2020 which looks at potential solutions to address the contamination of drinking water by microplastics.

The United Nations Environment Assembly (UNEA) has considered the topics of the threat of plastic pollution to aquatic ecosystems and access to clean water for almost a decade. These efforts included identifying knowledge gaps, strengthening coordination, and assessing the effectiveness of global and regional governance on the topic. In 2022,

a process towards the development of a legally binding instrument on plastic pollution, including in the marine environment, was initiated by UNEA.

Plastic pollution not only intoxicates the environment but also creates an impact on human physical well-being through contaminating drinking water and damaging sustainable food systems. The plastics cycle has become a major threat to all human rights, including the rights to a healthy environment, life, health, food, water and sanitation, equality and non-discrimination, and housing.

All people everywhere have the right to a healthy environment as recently recognized by the Human Rights Council in its resolution 48/13 and the General Assembly in its resolution 76/300. The realization of the human right to a healthy environment, which is interlinked with the right to water, is a pathway to addressing plastic pollution and the achievement of the SDGs, including SDG 6. In this context, the panel will consider the opportunities, as well as challenges, presented through advancing implementation of the right to a healthy environment, expectations for the negotiations of the new legally binding instrument on plastics, and the various actions being taken by youth actors to support the achievement of the SDGs, with a focus on SDG 6.

# 2. Objectives of the side event, including relation with the SDGs identified in the Guidelines

The objectives of the side event are to have an interactive dialogue and to showcase youth-led actions and policy recommendations on how to address plastic pollution in water that ensure the right to a clean, healthy, and sustainable environment and advance the achievement of SDG 6. The side event will bring together youth representatives from different sectors, media personalities, entrepreneurs, and civil society.
