

OEWG on a Science-Policy Panel to contribute further to the sound management of Chemicals and Waste and to prevent Pollution (SPP-OEWG)

Background - UNEA Resolution 5/8

Decided that a Science-policy panel should be established to contribute further to the sound management of chemicals and waste and to prevent pollution (para. 1)

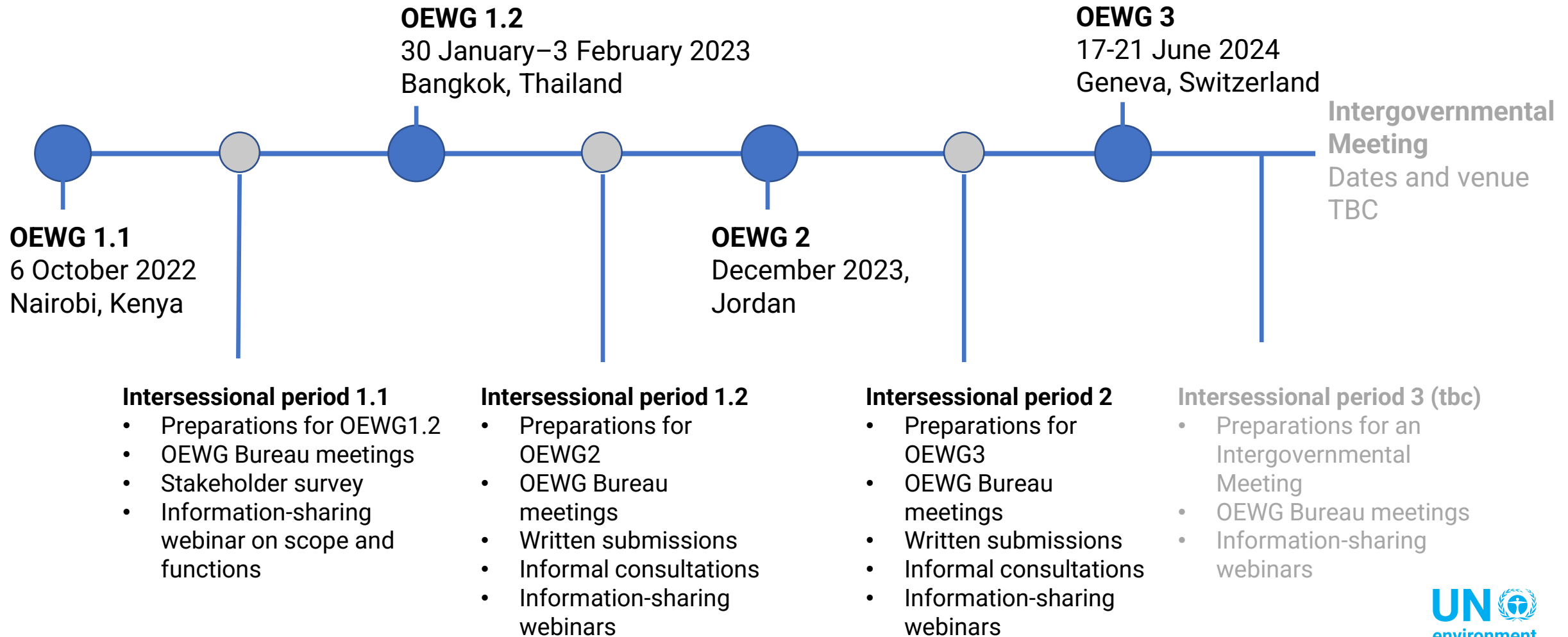
Decided to convene, subject to availability of resources, an ad hoc open ended working group that will begin work in 2022 with the ambition of completing it by the end of 2024 (para. 4)

Background - UNEA Resolution 5/8, Para 5

Decided that the ad hoc open-ended working group will prepare proposals for the science-policy panel to consider the following issues:

- (a) Institutional design and governance*
- (b) Name and scope*
- (c) Principal functions*
- (d) Relationships with relevant key stakeholders*
- (e) Processes for determining and executing the work programme*
- (f) Arrangements for identifying and engaging with experts to contribute to the work*
- (g) Procedures for the review and adoption of reports and assessments*
- (h) Arrangements for secretariat support*
- (i) Options for voluntary financing of the work*
- (j) Rules of procedure and the operating principles governing the work*
- (k) An indicative budget*
- (l) Any other relevant matters*

OEWG 1.2 Outcomes: scope and functions

- **The OEWG agreed on the following objective of the panel**
 - [The objective of the panel is to strengthen the science policy interface to contribute to the sound management of chemicals and waste and to prevent pollution for the protection of human health and the environment, with the following functions:]
 - The text on objective has been left in brackets with the understanding that future discussions of the OEWG may continue to inform the objective.

OEWG 1.2 Outcomes: scope and functions (*cont'd*)

The OEWG agreed on the following principal functions of the panel:

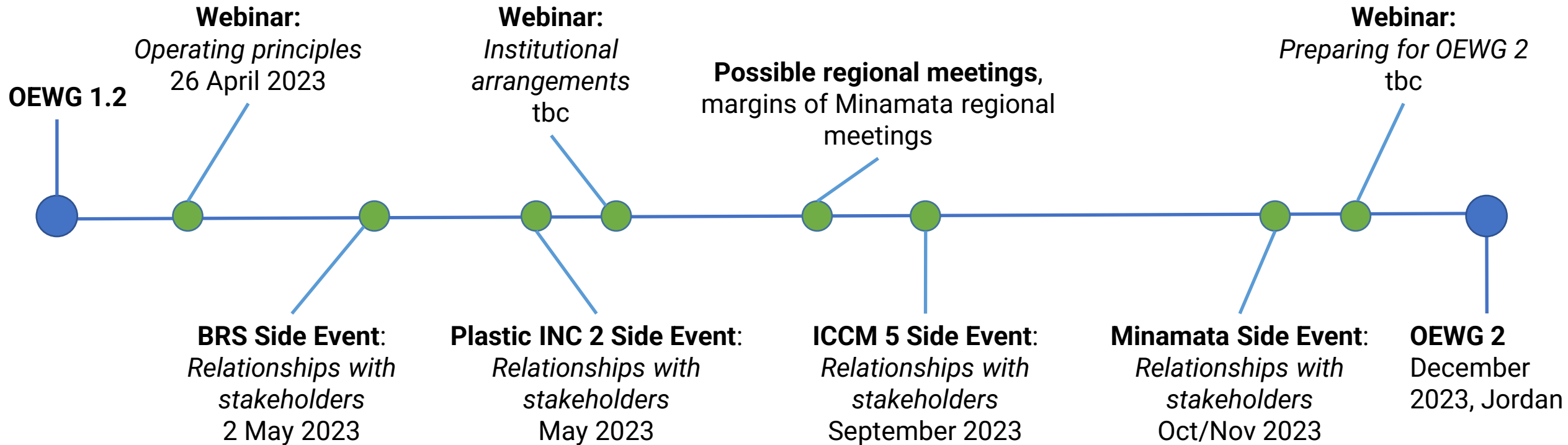
- **Undertaking “horizon scanning”** to identify issues of relevance to policymakers and, where possible, proposing evidence-based options to address them
- **Conducting assessments** of current issues and identifying potential evidence-based options to address, where possible, those issues, in particular those relevant to developing countries
- **Providing up-to-date and relevant information**, identifying key gaps in scientific research, encouraging and supporting communication between scientists and policymakers, explaining and disseminating findings for different audiences, and raising public awareness
- **Facilitating information-sharing with countries**, in particular developing countries seeking relevant scientific information
- A fifth principal function on **capacity building** was included, however further discussions are needed to finalize the text of this new principal function

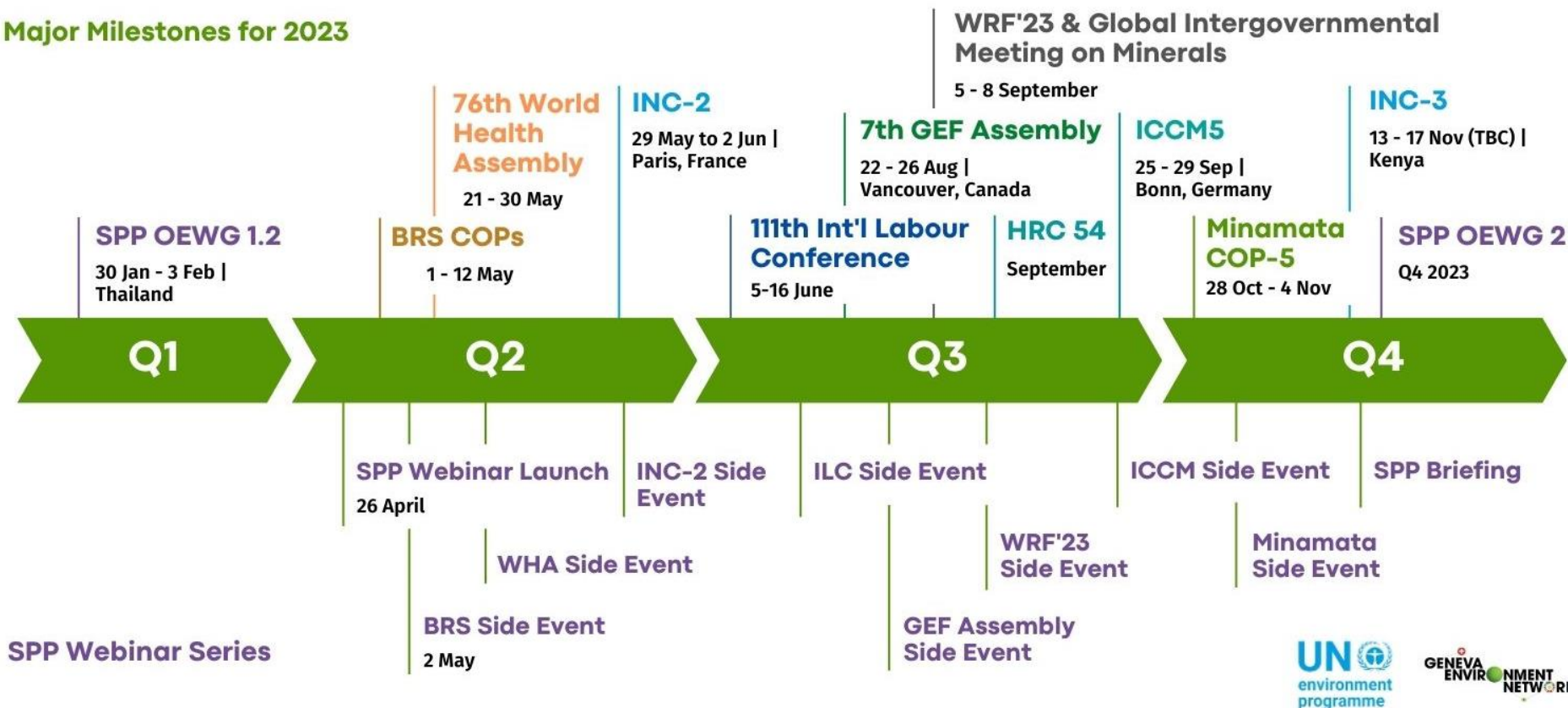
