Guidance to the co-organizers of thematic side events for INC-2 (9 May 2023)

Dates and room locations:

Twelve thematic side events will be held on the margins of INC-2 from 1:30-2:45pm daily, 29 May-1 June 2023 at UNESCO headquarters, Paris. In-person and in English only.

The themes have been chosen based on the discussions at INC-1, the written submissions received, and were decided in consultation with the Chair and the host country.

Participation in the thematic side events

In addition to the individual meeting badges for INC-2, secondary floating badges are needed to enter the meeting premises to present and participate in the thematic side events.

Role of the co-organizers

- Work together to develop an inclusive event that can inform the INC process, including the discussions of the INC-2.
- Appoint one focal point for communication with the INC secretariat (submit name and contact information to the secretariat by 15 May).
- Prepare an agenda for the side event, submit it to the secretariat through the focal point by 22 May. The agenda should include time for questions and dialogue with the participants in the

event. The secretariat will post the agenda on the INC website. The event must take due account of gender considerations and regional balance.

- Strictly respect the timeframe allotted, from 1.30 2.45 pm.
- The focal point for each session is requested, in consultation with the co-organizers, to prepare a summary of the event (proposed outline for the summary included in the Annex to this guidance note) and submit it to the secretariat no later than 9 June 2023. The secretariat will make the summaries available on the INC website.

No lunch will be provided by the host country or the INC secretariat for the side events. If co-organizers of the side events wish to provide lunch for their event, one of the co-organizers must arrange and pay directly to the catering facilities at UNESCO.
