Dear UNEP Global Mercury Partnership,

We in Diálogos would like to join the partnership. Diálogos is a Danish NGO working with health and environment. We are doctors, geologist, philosophers, anthropologists, engineers, and public health specialist. We are all researchers and use our skills in Diálogos. We have projects where we work with integrating traditional medicine with more modern medicine, we have projects trying to minimise use of pesticides in agriculture. Most importantly though we work in partnership with local NGOs and gold miners to eliminate mercury use in small-scale gold mining.

We have worked in the Philippines, in Bolivia, in Mozambique and in Uganda. We implement the Benguet mercury-free method which is a technology which is showed to work very well for artisanal and small-scale gold miners. We have documented this in different scientific papers. In the project expert miners from Benguet in the Philippines train the miners, some of them to become miner trainers, in an effort to use the south-south exchange to promote a common mining community. Our dream is a training school to where miners can come to learn and exchange experiences and skills.

Our experience supports the education of health care professionals, teachers and local leaders which together with advocacy and collaboration at local, district and governmental level is an important and integrated part of our projects. We are mostly supported financially from the Danish Foreign Ministry.

Recently we organised an international meeting, the Tiira Summit in Uganda. We brought together international, national and local stakeholders to witness the Benguet method working in an artisanal small-scale mining setting. Several suggestions for projects came from this, among them one in Kenya where the mining community Osiri Masanga will be able to lease equipment using a leasing model from Impact Facilities, Kenya. After 18 month the miners acquire the equipment for 1US\$. This pilot project supports the partnership's goal of integrating the ASGM sector into the formal economy. Just like the other projects we have worked with, this aims to formalise ASGM, enabling the miners and the country to benefit from the mining.

We support the UNEP Global Mercury Partnership and are committed to make artisanal and smallscale gold mining safer, cleaner, and more profitable.
