I would like to thank you for your very valuable written inputs on the zero draft ministerial declaration and for the comments made from the floor at the first informal consultation meeting held on 20 June 2023, which guided my team and me in preparing a **first full draft** of the ministerial declaration.

On this basis, it is my great honour to circulate a first full draft UNEA-6 ministerial declaration, with an open invitation to all Member States delegations and Major Groups and Stakeholders to review the draft and provide written inputs and comments on the draft, preferably **in track changes**, by **close of business on Friday, 15 September 2023**, to the email address of Mr. Rachid Firadi, Director of Partnership, Communication and Cooperation, Ministry of Energy Transition and Sustainable Development of Morocco (firadi@environnement.gov.ma), with a copy to UNEP (unep-unearesolutions@un.org).

All written comments received will be made available online on the UNEA-6 website [<https://www.unep.org/environmentassembly/unea-6>] under the "Resources" tab.

I also have the honour to inform you that it is my intention to circulate a revised first draft by the end of September and to convene second informal consultations in September/October, chaired by H. E. Mr. Abderrazzak Laassel, Ambassador and Permanent Representative of Morocco in Nairobi. The date and venue for the second informal consultations will be communicated in due course.

I look forward to your engagement in this important process.
