

## Report on the Sub-Regional Workshop to support African Countries to Implement and Finance Multilateral Environmental Agreements

Report prepared by UNEP Liaison Office to the African Union Commission, Economic Commission for Africa and Ethiopia in collaboration with the Regional Development Coordination Unit under UNEP Regional Office for Africa

27 - 30 June 2023 Lomé, Togo









## Introduction

Workshop for strengthening technical capacity and collaborative work of National Focal Points and United Nations Country Teams for implementation of Multilateral Environmental Agreements, financing the Global biodiversity Framework, and attaining the Sustainable Development Goals.

Under the ACP-MEAs Programme Phase III, United Nations Environment Programme (UNEP) – through the Africa Office regional Coordination Unit and Liaison Office in Addis Ababa, with support from UNEP's Environmental Policy Unit – spearheaded a new workshop format and model rolled out through two Sub-Regional training workshops for West and East African countries. By bringing together national focal points for Multilateral Environmental Agreements (MEAs) and representatives from the UN Country Teams (UNCTs) in the respective countries, the workshops were sought to promote synergies and collaboration between diverse stakeholders to implement MEAs more efficiently

within their country context. To further support this process, participants received training from experts on the contribution of MEAs to implementation of the Sustainable Development Goals (SDGs), tools for MEA integration into United Nations Sustainable Development Cooperation Framework's (UNSDCFs) and National Development Plans, tools for strengthening science-policy interfaces in Environmental Governance, and capacity building on how to fund implementation of MEAs, including the post-2020 Global Biodiversity Framework (GBF).

The Sub-Regional workshop targeting countries from the West African region (Benin, Burkina Faso, Côte d'Ivoire, DRC, Mali and Togo), was held between 27 – 30 June 2023 in Lomé, Togo. This was followed by a second Sub-Regional workshop Sub-Regional workshop for East African countries part of the Intergovernmental Authority on Development (IGAD) region, organized in Addis Ababa, Ethiopia, between 25 – 28 July 2023.

The workshop was organized under the **ACP-MEAs Programme**, a multi-year, multi-country partnership Programme established in 2009 with UNEP as the coordinating agency, in support of 79 Member States of Africa, Caribbean and the Pacific (ACP) regions. Covering 49 countries in Africa, the ACP-MEAs Programme is now in its third phase and works in the region through the Africa Hub led by the African Union Commission (AUC) with its headquarters in Addis Ababa. The Programme is funded by the European Union and supported by the Secretariat of the Organisation of African, Caribbean and Pacific States (OACPS).

## **Participants**

## **Sub-Regional Workshop for West African Countries in Lomé, Togo**

The workshop in Lome, Togo, was attended by UNCT representatives and national focal points for MEAs related to biodiversity and chemicals/waste from seven of West African countries – Togo, Benin, Cote d'Ivoire, DRC, Mali, Burkina Faso. In addition, United Nations Environment Programme (UNEP), The African Development Bank (AfDB), and other representatives from the UN system participated in and presented during the workshop.

## **Objective**

The overall objective of the training was to strengthen the technical capacity of UNCTs together with national MEA focal points to support host countries to mainstream, implement and adhere to MEA obligations, including raising adequate finances to implement the MEAs in general and the Convention on Biological Diversity's Kunming-Montreal Global Biodiversity Framework (GBF) in particular.

Specifically, the workshop had the following objectives:

- 1. Increase coherence and synergy of actions on environmental issues through strengthening collaboration between national MEA focal points and the UNCTs.
- 2. Establish the link between environmental statistical data generated for MEAs and the UN Common Country Analysis (CCA) as a strategic intervention framework for the implementation of SDGs in the region.
- 3. Conduct in plenary a self-assessment of the current capacities of national institutions (National Directorate of Statistics, Ministry of Environment, Water and Forests) to generate and use environmental statistics for CCA, UN CF implementation and national development planning.
  - **4.** Identify tools to be promoted for strengthening the capacity of national institutions, including MEA Focal Points, to conduct integrated environmental assessments (identification of indicators and baseline data and their intelligence) in support of national development planning, produce periodic reports in support of the implementation of the UN Country Frameworks and the MEAs.
- **5.** Contextualize MEA financing and explore innovative financing mechanisms to enhance/support MEA implementation at national and regional level.
- **6.** Lead participants to formulate actionable recommendations with immediate effect and identify the role of each key stakeholder in the implementation of these recommendations.
- 7. Bring together stakeholders, including the national focal points and financing institutions to raise capacities for additional financial resource mobilization.

## **Technical Sessions**

UNEP together with the representative of Togo's Minister of Environment supported by the UN Resident Coordinators Office in Togo kicked off the meeting with welcome remarks to all and highlighted the main objective of the workshop which was to build country capacities and understanding of the various Conventions and to foster interlinkages and compliance with other related Conventions. UNEP is uniquely positioned to support countries negotiate these processes for synergies towards Sustainable Development Goals (SDGs). Hence the key findings that emanated from the workshop are as follows.

### 1. Increased coherence and synergy of actions on environmental issues through strengthening and support collaboration between National Focal Points for MEAs and the UNCTs.

Key sessions that target this objective sought to bring participants to understand the benefit of working together in the future and ensure that MEA national focal points and UNCT members define workable mechanisms for an enhanced integration of MEAs in Common Country Analysis and UN Sustainable Development Cooperation Framework (UNSDCF) in the involved countries. Indeed, the workshop provided an opportunity for UNEP to highlight the importance of this training of trainer's workshop on environmental management and provided an opportunity to develop strategic knowledge on environmental sustainability and the importance of strengthening the implementation of MEAs for the protection of the Planet and the People. Unfortunately, they are under threat and to remedy this it is necessary to adopt the principle of circular economy, policy coherence, the integrated approach and the strengthening of domestic resources, among others. The meeting demonstrated how those tools need to be integrated in national development plans including the VNR and on the UN team side the CCA and the CF which justifies the need for both sides to work together .This is very strategic since in the current

situation, UN focal points and country representatives do not even know each other in the

majority of countries. The various sessions in groups and plenaries led participants to be convinced of the fact that a synergy between the national side and the United Nations System will generate a series of medium- and long-term benefits including, among others:

- The possibility of joint assessment of MEAs' contributions to accelerate the achievement of the SDGs.
- Exploring opportunities for the UN programme management team to better support the integration of strategic planning for multilateral environmental agreements and the formulation of UNSDCF outcomes with better definition of results.
- Joint exploration of how environmental financing, especially on biodiversity can be aligned with the approach to financing the SDGs.

The UNCT representatives from Togo also took the opportunity to share their experience of strong collaboration with the national bodies during their recent formulation of their CCA and UNSDCF. As part of this experiment, a variety of data from national side were used. A strong consultation with various partners involved also took place. This expercise made it possible to better define the priorities of the UNSDCF, to develop a stronger Theory of Change and to consolidate cohesion. It was concluded that to ensure a stronger collaboration between MEA focal points and the UN system, it is necessary to consider the role of policy and legislative coherence in engaging nonstate actors to stimulate their engagement in a harmony that would ensure both implementation of MEAs and win-win partnership

Finally, a session on the Regional Assessment of the most relevant MEAs was held, taking into account the case of the countries of the Horn of Africa (IGAD). It emerged from this session that IGAD countries have significant biodiversity and have ratified many conventions. However, the periodicity of reporting on the conventions varies from one convention to another. The evaluation revealed weak political will, lack of funding and coordination, which are gaps that could be filled by better collaboration between the MEA national focal points and the United Nations country teams.



## 2. Participants gained improved awareness and capacity to use the statistical tools needed to generate and use environmental data in the implementation of MEAs, both at national level, and in support to UNCT activities.


The workshop sessions offered the opportunity for an increased awareness on the importance of statistics for the implementation of MEAs objectives and regulations. Nevertheless, the implication was still that a joint work plan with regular meeting is required to improve awareness about UNCT and MEA linkages to support MEA implementation (such as monitoring and reporting) and uptake of MEA in UNCT planning and prioritization.

The meeting offered the opportunity for both sides (Government representatives in the form of national MEA focal points and UNCT representatives) to enhance capacities on ways to better handle identification and access to data sources, ensure data generation and data utilization, and ways to minor risks from the use of "Big data" including the risk for its use for climate change modelling. Participants came to realize that in general, there is no national data system on the MEA (no single data platform compiling all MEAs) in most of the countries.

Participants noted the need to put in place a data cooperation and sharing framework, guided by national data governance principles and approaches and a national environmental data policy that would link to the databases located within respective ministries. A digital platform is required for sharing datasets, and one that is underpinned by a data governance framework. Togo noted for example that financial support for data collection should be part of national budgets and maintained by relevant ministries. Data coming through project should also contribute to national databases.

For coordination across UNCT members, it was proposed that UNCT members should brief their colleagues on MEA inclusion in CCA after their return from the workshop to their respective countries. At a group meeting, MEA focal points can be invited to brief the UNCT's on MEA importance to SDG implementation. A network should be formed from this initial contact.

Participants noted highlighted that UNEP could assist countries by providing technical assistance to meetings of MEA focal points and UNCT members that would promote awareness on the importance of integrated data for informing policy.





# 3. Contextualize MEA financing and explore innovative financing mechanisms to enhance and support MEA implementation at national and regional level.

The Participants received strong knowledge on available global possibilities to mobilize funding to design and implement projects and programmes that support an enhanced implementation of the the MEAs targeted by the workshop with a particular focus on biodiversity related MEAs. The sessions recognized the great value of the UN Common Approach to Biodiversity and recommended integrated financing for biodiversity restoration in the countries involved. It also recommended strong collaboration with

development banking institutions with a particular focus on domestic resource mobilization initiatives.

Participants stressed the need for financial support that would cover both policy and data development to support MEA implementation, highlighting that financial support should be directed at building capacity for developing and applying standards, data sharing and reporting.

# 4. Lead participants to formulate actionable recommendations with immediate effect and identify the role of each key stakeholder in the implementation of these recommendations with concrete follow up actions as post seminar work.

The workshop identified current challenges that need to be addressed to ensure stronger collaboration and synergy between MEAs national country focal points and UN country teams. Some of those challenges are highlighted as follows:

- Environmental challenges remain the core
  of issues seeking to be addressed as a
  stronger implementation of MEAs can
  unblock various SDGs.
- Multiplicity of Conventions how can these be grouped tying each to a specific agenda. There is also a need to learn from each other to improve efficiency.
- Harmonization of Conventions the importance of exploring and harmonizing

different types of data that serves different needs.

- 4. Exploring and noting collaboration and coordination challenges at country level.
- 5. Data capture, statistics, and information sharing to necessary stakeholders, participants, and implementing agents.
- Lack of funding to accelerate capacity building of UNRC offices, particularly the UNCT's Programme Management Team (PMT) and the UNSDCF monitoring group including to enhance their knowledge on MFA.

## **Key outcomes and recommendations**

The objectives of the workshop were successfully met because of the collaborative efforts of UNEP Environmental Policy Unit (EPU) and UNEP Regional Office for Africa (Regional Development Coordination Unit and the Liaison Office in Addis Ababa) The workshop provided an avenue to create awareness and capacity on resource mobilization to support the implementation of MEAs and the role of data management for stronger GBF domestication and integration at a national and regional level. National focal points for MEAs and representatives from UNCTs, facilitated by UNEP and supporting agencies like Multilateral development Banks, request continued sessions/workshops to acquire up to date information and strengthen their understanding of data governance and nature financing for integrated and coherent implementation at the country level. According to the direct feedback provided by workshop participants, the overall objective of the workshop was met including the following specific key outcomes and recommendations.

#### Recommendations and follow up actions

#### For UNCT Representatives:

- Reporting on the workshop outcomes to UNCT during a monthly UNCT meeting. This should be
  followed by a close meeting with the Environment Result group to agree on specific steps on ways
  to elaborate a joint workplan with the National focal points to ensure a stronger integration of
  environment MEAs in CCA and CF implementation and resources mobilization.
- Organize a first meeting with the National focal points to agree on key activities to be undertaken
  jointly with them depending on the key issues of the countries (elaboration of data management
  policy, sensitization of data users, installation of MEAs data system, elaboration of governance
  system and infrastructure, data collection policy, harmonization on data policy, to name a few).
- Collaboration with the Ministry of Finance to support MEAs implementation in the various technical Ministries.
- Collaboration with country donors including the bilaterals and banking systems to support Biodiversity financing.

#### **For National MEA Focal Points:**

- Elaborate and submit a mission report to the national Supervisory entity and request meeting between high level national entities and the chair of the Environment result group.
- Discuss with the UN team to set a joint collaboration platform with them to undertake the implementation of the outcomes from the workshop.
- Reach an agreement on strategic activities to enhance resources mobilization in support to biodiversity agenda.
