CONCEPT NOTE

Background and the context

The world is facing multiple, interconnected and overlapping crises. Besides, the triple planetary crises of climate, rapid biodiversity loss and pollution, uneven recovery from COVID 19 pandemic, sovereign debt crisis and cost of living crisis, and wars and conflict have impacted the lives of billions of people adversely and have reversed hard earned development gains over the last decades. Despite a better understanding of the relation of development and environment, development drivers continue to threaten breach of more and more planetary boundaries. Though we have notable achievements in multilateral processes in climate, biodiversity, plastic pollution, conservation of biodiversity in the oceans and the high seas, chemicals and waste; we do still have mammoth challenges in preventing climate catastrophe and pollution, implementing global biodiversity framework and in achieving the SDGs.

Asia and the Pacific has been the global engine of growth for the past decades making higher economic development than the rest of the world. However, the cost of this growth has been immense environmental degradation. The region has been plagued by rapid climate change impacts, unprecedented biodiversity loss and pollution. More than 60% of the population in the

region is dependent on climate sensitive sectors. On an average 43,000 persons are killed every year in the region due to storms, floods and landslides also imposing economic losses worth \$ 675 each year due to disasters. A person living in Asia Pacific is six times more likely to be affected by disaster than other regions. Land degradation has affected about 850 million ha or 28% of land area in the region. About 40 countries in the region have pledged to achieve carbon neutrality in the region but only a handful of them have enshrined these pledges in law. Most of the Asia Pacific countries are unprepared to face extreme weather events, which is growing in intensity, frequency and scope. Though rich in biodiversity, it's projected that 42% of all the species in South East Asia could be lost by the end of the century risking up to 60% loss in the regional GDP. 149 out of the 150 most polluted cities in the world are in the Asia Pacific, which witnesses 6.5 million out of 9 million excess mortalities due to causes related to pollution. Hunger, poverty, inequality and gender based violence has been rising consistently in the region due to a variety of crises mentioned above and exacerbated by the COVID 19 pandemic.

We cannot overcome the interlocking crises without a strong political will for addressing systemic challenges, fostering transformative policies and action in a "whole of government" and "whole of society" approach rooted in human rights and gender rights.

Sixth Session of the United Nations Environment Assembly (UNEA 6) and the 5th Forum of Ministers and Environment Authorities of Asia Pacific

It is in this backdrop that UNEA 6 will take place in Nairobi, Kenya from 26th February to 1st March 2024. UNEA is the highest platform for discussing intersection of environment and development, and for environmental law making and spurring action on multilateral environmental agreements. The UNEA is preceded by regional consultations of environment ministers (and high officials).

The 5th Forum of Ministers and Environment Authorities in Asia and the Pacific will be organized by UNEP in collaboration with the Ministry of Environment, Government of Sri Lanka from 3rd to 6th October 2023 at Colombo and online. The theme of this Forum follows the theme of UNEA 6 "**Effective, inclusive and sustainable multilateral actions to tackle climate change, biodiversity loss and pollution**." The 5th Forum will provide regional perspectives and will contribute to the outcomes of the UNEA 6.

As in the previous Forum of Ministers and Environment authorities in Asia Pacific, Asia Pacific Regional CSOs Engagement Mechanism will organize a one day Asia Pacific Major Groups and Stakeholders (MGS) Forum on 3rd October, 2023 in hybrid manner in collaboration with the UNEP and the Ministry of Environment, Government of Sri Lanka.

The Forum is intended to provide a platform for major groups and stakeholders to discuss and organize their positions and provide strategic inputs towards 5th AP Forum and towards the preparation of the UNEA.

The Major Group and Stakeholders' Forum will aim:

- 1. To enable major groups and stakeholders and grassroots representatives to prepare their collective views and positions on the UNEA 6 Theme and regional inputs.
- 2. To ensure that the voice and views of major groups and stakeholders and grassroots communities in the region are shared at the senior officials and ministerial Forum and reflected in the outcome of the 5th AP Forum.
- 3. To provide opportunities for major groups and stakeholders and grassroots representatives from across the region also to deliberate and provide inputs to to the UNEA process including draft resolutions and draft Ministerial Declaration.

Asia Pacific Regional CSOs engagement Mechanism (APRCEM)

APRCEM is a platform of more than 500 CSOs from Asia and the Pacific. The platform is committed to promote development justice including advocating ensuring economic, environmental, social and gender justice and accountability to people. The Platform comprises a wide variety of major groups and stakeholders across 17 constituencies, 5 sub-regional groups and various thematic groups. The APRCEM has, since 2012, engaged extensively with Agenda 2030 at global (UN) and at Asia Pacific (ESCAP level). It has also worked closely with the UNEP and UNEP ROAP facilitating MGs participation in the UNEA and Regional Forum respectively. APRCEM is considered as a model engagement mechanism at the regional level and has inspired other regions to develop regional engagement mechanisms. Selection of Participants for the Forum

UNEP will support the travel of a few MGS from APRCEM for participation in the MGS Forum and the 5th Forum. The selection will be conducted by the APRCEM based on the considerations of diversity, (sub) region, gender, age, capacity and skills, and grassroots representation. An open call for nominations/registration of participants (till 9th August) will be followed by selection on above criteria by a selection committee in a transparent and fair manner. Besides the participants supported by UNEP, APRCEM will also encourage MGS and CSOs from Sri Lanka and other countries in Asia and the Pacific to register and participate.
