Draft Decision 26/14: Programme of Work and Budget for 2024 - 2025

### Note by the Secretariat

In accordance with the mandate given by the Contracting Parties through Decision IG.25/19 of COP 22 (Antalya, Türkiye, 7-10 December 2021) on the Programme of Work (PoW) and Budget 2022-2023, and in line with the general directions shared with the 94th Bureau Meeting (Izola, Slovenia, 20-21 June 2023), the Secretariat has prepared the proposed 2024-2025 Programme of Work (PoW) and Budget which is submitted to the meeting of the MAP Focal Points for their consideration.

The proposed 2024-2025 PoW and Budget is aligned with the UNEP/MAP Medium Term Strategy (MTS) 2022-2027 and is built taking into account the principles and planning and programming directions provided for in the Governance paper adopted by Decision IG.17/5 of COP 15 (Almeria, Spain, 15-18 January 2008) and with the Financial Rules and Procedures of the Barcelona Convention adopted by Decision IG.21/15 of COP 18 (Istanbul, Türkiye, 3-6 December 2013).

Its implementation is based on the Mediterranean Trust Fund (MTF) resources complemented with external resources, which have been partially mobilized or are under negotiation. Details on the external resources mobilized are contained in the attached narrative and in the tables of the proposed PoW.

The implementation of the proposed PoW will be led by the Coordinating Unit to achieve coherence and integration, maximize efficiency, and deliver as one as MAP system, through strong collaboration with all MAP Components and relevant partners.

As per Procedure 2 of the Financial Rules and Procedures of the Barcelona Convention, the Secretariat has consulted UNEP Headquarters and submitted the attached proposed Programme of Work and Budget 2024 – 2025 for clearance, that was received on 11 July 2023. This document is composed of a draft Decision and an Annex, containing the tables of the proposed PoW and Budget 2024-2025 and relevant details. A narrative part providing the rationale for the proposed activities and the corresponding budget is presented below.

The proposed PoW reflects to the extent possible suggestions received by three Contracting Parties, namely Greece, Italy and Türkiye, during the online consultation with the MAP Focal Points, carried out in April/May 2023, on the basis of the letter sent by the Coordinator on 13 April 2023, as well as recommendations provided by relevant MAP Components Focal Points meetings that were held in May/June 2023 on issues related inter alia to the state of play of marine renewable energies at large (not only focusing on windfarms), the protocols for desalination sector, the integration of oiled wildlife response in National Contingency Plans (NCPs), the SPAMI evaluation format revision, the sharing of best practices for nature-based solutions for climate change adaptation and mitigation, the modalities of interaction with other MEAs Compliance Committees, the state of play of funding mechanisms and opportunities for climate change adaptation, the contribution of MAP to the Our Ocean Conference 2024 in Greece, the addition of reference to "coastal" forests, the addition of relevant Components in the Lead/Other Components columns, as well as some clarification and editorial revisions.

Some proposals and clarifications are maintained with footnotes in the respective Programmes, including the potential addition of reference to a new RAC on Climate Change, among the MAP Components' list in relevant activities, pending approval by the Contracting Parties of the establishment of the new Center as proposed by Türkiye through a formal request sent to the Coordinator to submit to the MAP Focal Points meeting, a draft decision for the establishment of the new CC/RAC to be hosted by Türkiye, with operational costs fully covered by Türkiye, together with a package of full documentation to support this proposal; the addition of some elements on Mediterranean forests and megafires, in line with a new project for the Mediterranean, which is under development by UNEP in cooperation with UNEP/MAP; the proposal of removal of references to PAMEx and PLIFF from some activities, the removal of deliverable (f) under activity 2.2.2 and

deliverable (b) under activity 6.3.13, as well as clarifications on activities 2.1.1 deliverable (c), 2.3.2 deliverable (i) and 6.3.12 deliverable (c), as proposed by Italy.

#### Rationale for the Proposed Programme of Work 2024-2025

- 1. Decision IG.25/19 "Programme of Work and Budget for 2022-2023", adopted by the 22<sup>nd</sup> Meeting of the Contracting Parties (COP 22) in December 2021, in Antalya, Türkiye, mandated the Secretariat to prepare, in consultation with the Bureau, for careful consideration by the MAP Focal Points and, after further refinement, approval by COP 23 a result-based Programme of Work and Budget for 2024 2025, explaining the key principles and assumptions on which it is based and taking into account the progress achieved during the implementation of the 2022-2023 Programme of Work, providing information on the consultation process followed for its preparation, and in full alignment with the MAP Medium-Term Strategy (MTS) 2022-2027.
- 2. It further requested the Secretariat, in consultation with UNEP Headquarters, to explore possible ways of simplifying the structure of the Programme of Work and Budget to ensure that Contracting Parties have a clear understanding of the priorities and the relationship with the MTS when adopting the budget.
- 3. In line with this Decision, the proposed 2024-2025 Programme of Work (PoW), being in the middle of the new MTS cycle, was designed to ensure its continued effective implementation and achievement.
- 4. Its preparation takes into consideration the following elements:
  - a. Full alignment with the MTS 2022-2027;
  - b. Status of implementation of the MTS 2022-2027 and current PoW 2022-2023;
  - c. Reliable resource mobilization (including also not yet secured external funding);
  - d. Relevant regional and global commitments;
  - e. Regional progress and achievements on environmental and sustainable development agenda in the Mediterranean;
  - f. Comparative advantages;
  - g. Balanced distribution, to the extent possible, of activities around MTS Programmes and Outcomes.
- 5. The proposed 2024-2025 PoW is built around 27 Outcomes to be delivered through the implementation of 104 main activities, distributed over the MTS Programmes as shown below:

6. In response to the request of COP 22, on the potential simplification of the PoW structure, the Secretariat aims at maintaining the list of deliverables in the PoW Tables until their review and approval by the MAP Components/Thematic Focal Points meetings, while the working document to be submitted to the MAP Focal Points and COP 23 for review and approval will go up to the level of main activities and present the list of deliverables only as information document. To address the request of COP 22 to strengthen RBM, the activities have been further aggregated and their number reduced from 116 in PoW 2022-2023 to 104 in the PoW 2024-2025.

# <u>Thematic Programme 1: Towards a Pollution and Litter Free Mediterranean Sea and Coast Embracing Circular Economy</u>

- 7. The main objective of the proposed 2024-2025 PoW for this Programme is to support integrated responses for prevention and reduction of plastic pollution and marine litter, including emerging sources of pollution, in the framework of the Regional Plans and NAPs under the LBS Protocol, the Mediterranean Strategy for the Prevention of, Preparedness, and Response to Marine Pollution from Ships (2022-2031); the Mediterranean Offshore Action Plan; and the Regional Action Plan on SCP, while ensuring links and synergies with other relevant regional and global instruments and processes, including those under the IMO, the BRSC, UNEA Resolutions, as well as the anticipated global Treaty to address plastic pollution. The proposed activities further aim at promoting a transformational change embracing circular economy and contributing to the implementation of the One Health Approach, linking human and ecosystems health with pollution reduction and prevention, taking into account lessons learnt from the COVID-19 pandemic.
- 8. More specifically, the proposed 2024-2025 PoW envisages:
  - a) Supporting the implementation of 2021 Regional Plans under the LBS Protocol, through local, national, subregional and regional actions;
  - b) Analyzing the state of play of offshore windfarms' operations, including socio-economic aspects, and supporting the sustainable development of the sector;
  - c) Undertaking pilot actions to prevent, eliminate and dispose in an environmentally sound manner obsolete chemicals under the MedProgramme;
  - d) Strengthening the capacity of individual coastal states to respond efficiently to marine pollution incidents; improving pollution event follow-up and enhancing the level of enforcement and the prosecution of discharge offenders;
  - e) Further supporting the ratification and effective implementation of MARPOL Annex VI, facilitating the entry into effect of the Mediterranean Sea Emission Control Area for Sulphur Oxides and Particulate Matter (Med SOx ECA);
  - f) Delivering studies for a possible designation of the Mediterranean Sea Emission Control Area for Nitrogen Oxides (Med NOx ECA) pursuant to MARPOL Annex VI;
  - g) Supporting public and private actors in preventing marine litter, plastic pollution and toxic chemicals, addressing the circular economy approach;
  - h) Implementing the One Health approach in the Mediterranean in relation to links between pollution and human health, with an initial focus on health impacts of polluted seafood consumption, and analysis of potential health-related indicators in line with Regional Plans and NAPs;
  - i) Supporting the creation and development of circular economy businesses in key sectors of activity which are main sources of pollution.

## Thematic Programme 2: Towards Healthy Mediterranean Ecosystems and Enhanced Biodiversity

- 9. The main objective of the proposed 2024-2025 PoW for this Programme is to contribute to the effective implementation of the Post 2020 SAP BIO and to support the Contracting Parties in their efforts in establishing, expanding and efficiently managing a comprehensive, coherent and effective Mediterranean network of Marine and Coastal Protected Areas (MCPAs) and other effective area-based conservation measures (OECMs). This Programme also places a particular focus on the enhancement of ecosystem resilience through restoration, in line with the UN Decade for Ecosystem Restoration, as well as on the improvement of the status of conservation of Mediterranean endangered and threatened species and key habitats.
- 10. More specifically, the proposed 2024-2025 PoW envisages:
  - a) Undertaking a state of play on existing practices and measures for biodiversity/ecosystems restoration including their scientific evaluation; identifying innovative actions and supporting replication and sharing of successful practices, including pilots and demonstration actions, taking into consideration synergies with the UN Decade on Ecosystem Restoration;
  - b) Updating and implementing Regional Action Plans/Strategy on Species and Habitats and supporting elaboration of sub-regional and national ones;
  - c) Implementing targeted priority measures to minimize non-indigenous species introductions and control their introduction pathways in line with the Regional Action Plan concerning species introduction and invasive species, and the Ballast Water Management Strategy for the Mediterranean Sea (2022-2027);
  - d) Supporting elaboration and/or updating of national strategies and action plans for MPAs and OECM networks, based on the orientations and priorities of the Post-2020 SAPBIO, Post-2020 Regional Strategy for MCPAs and OECMs, the Kunming-Montreal Global Biodiversity Framework, and other relevant global frameworks and targets;
  - e) Expanding the MPA/SPAMIs and OECM networks, designating protected areas with enhanced protection levels, and enforcing efficient management measures for their long-term conservation;
  - f) Strengthening effective SPAMI management through continuing and fostering SPAMI Twinning Programmes:
  - g) Guiding enforcement activities through technical tools, standards, criteria, guidelines, tailored at regional or sub-regional level, as needed and relevant;
  - h) Ensuring continuous knowledge enhancement, and conservation status assessments of marine and coastal species and habitats covered by Regional Action Plans or by the Annex II and III of the SPA/BD Protocol;
  - i) Using the functionalities of the Mediterranean Observatory for transversal analysis between human induced pressures and conservation status, and contributing to the definition of criteria for identification of sites with highest ecological relevance and/or regeneration potential;
  - j) Organising capacity building programmes (scientific symposia, workshops and thematic regional, sub-regional and national training sessions) and improving the science-policy interface;
  - k) Improving and adapting measures to mitigate the impact and interaction with coastal and marine human activities and/or climate change and enhancing their adoption by the Contracting Parties.

## **Thematic Programme 3: Towards a Climate Resilient Mediterranean**

- 11. The main objective of the proposed 2024-2025 PoW for this Programme is to support Contracting Parties in their efforts to prevent or reduce the impact of climate change on coastal and marine ecosystems and increase resilience to climatic change and variability. It also aims at ensuring that Contracting Parties are provided with up-to-date scientific knowledge on related climate change. One major outcome foreseen under this Programme is the delivery of an updated Regional Framework for Climate Change Adaptation.
- 12. More specifically, the proposed 2024-2025 PoW envisages:
  - a) Building a region-wide common understanding of and promoting nature-based solutions for climate change adaptation in the Mediterranean; Assessing and disseminating nature-based technical solutions and best practices applicable to Mediterranean specific context;
  - b) Developing and promoting guidance on nature-based solutions applicable to different coastal typologies to be considered in the preparation of coastal plans;
  - Observing and analyzing emerging issues (mainly in relation to offshore activities and climate change) and identifying appropriate measures to address their impacts on marine biodiversity and ecosystems;
  - d) Supporting elaboration of national ICZM plans and strategies aiming at increasing resilience to climatic variability and change;
  - e) Mainstreaming climate change adaptation into local ICZM plans;
  - f) Mobilizing and implementing innovative solutions to reduce GHG emissions from ships in selected ports, including through energy efficiency and decarbonisation;
  - g) Supporting the operation and activities of the scientific network MedECC and developing sciencebased assessments and policy recommendations on thematic impacts of climate and environmental change in support of informed decision-making;
  - h) Contributing to climate change mitigation efforts through circular economy approaches, increased resource efficiency and carbon neutrality business strategies.

## <u>Thematic Programme 4: Towards the Sustainable Use of Coastal and Marine Resources Including</u> Circular and Blue Economy

- 13. The main objective of the proposed 2024-2025 PoW for this Programme is to assist Contracting Parties in achieving the sustainability of coastal and marine resources through the synergetic implementation of planning and management approaches and integrating circular economy measures and solutions in key Blue Economy sectors. It also aims at supporting Contracting Parties' efforts to implement the Offshore Protocol and the Mediterranean Offshore Action Plan.
- 14. More specifically, the proposed 2024-2025 PoW envisages:
  - a) Promoting integration of circular economy into key Blue Economy sectors, including through recommendations, pilot actions and sustainable entrepreneurship support;
  - b) Implementing the ICZM Protocol and its Common Regional Framework, focusing on the preparation or updating National ICZM Strategies and coastal plans and vulnerability analyses for selected areas, supported by participatory foresight activities;

- c) Supporting on-the-ground activities in selected coastal areas through Coastal Area Management Projects (CAMP), including transboundary CAMP;
- d) Undertaking methodological work for ICZM focusing on the update of matrices from the Common Regional Framework for ICZM;
- e) Strengthening of the Marine Spatial Planning (MSP) implementation through training, capacity building and strengthening of a community of practice for MSP in the Mediterranean;
- f) Implementing key targeted measures of the Mediterranean Offshore Action Plan and maintaining its governance, cooperation and partnership framework sustainable and operational;
- g) Promoting sustainable tourism and sustainable marine renewable energies in the Mediterranean, in conformity with the UNEP/MAP Barcelona Convention framework and developing relevant guidelines;
- h) Supporting the development of national policies and pilot actions on SCP and circular businesses, as well as the implementation of SCP, circular economy and innovative sustainable economies at regional and national levels;
- i) Supporting effective and systemic use of economic instruments such as subsidy policies, conservative easements and other tools for nature conservation and sustainable development.

## **Foundational Programme 5: Governance**

- 15. The main objective of the proposed 2024-2025 PoW for this Programme is to ensure the effective implementation and enforcement by the Contracting Parties of the Barcelona Convention, its Protocols, MAP Strategies and regional policies and measures and relevant COP Decisions, while supporting policy coherence and complementarity among relevant work at global, regional and national levels and enhanced efficiency with the use of new digital approaches. It also aims at strengthening public institutions and enhancing partnerships and multi-stakeholder engagement, including with civil society organisations, the private sector, and science policy interface. Major outcomes foreseen under this Programme are the development of a revised Roadmap for ecosystem approach implementation in the Mediterranean and a revised Mediterranean Strategy for Sustainable Development.
- 16. More specifically, the proposed 2024-2025 PoW envisages:
  - a) Ensuring effective decision-making and review of implementation of the legal and policy instruments by the MAP relevant bodies; Deliver a successful COP 24, in Egypt, in 2025;
  - b) Supporting national efforts for further progressing on the ratification of the Protocols to the Barcelona Convention, to enable their entry into force for as many CPs as possible;
  - c) Reinforcing Contracting Parties' capacities on reporting on legally binding provisions of the MAP Barcelona Convention framework; developing legal indicators;
  - d) Implementing the MAP Data Policy at regional and as appropriate at national levels, and strengthening national capacities to implement it with closer support and dedicated workshops;
  - e) Strengthening SPI networks in the scope of MAP work;
  - f) Strengthening capacities for mobilizing external resources to implement PoW and MTS and executing efficiently externally funded projects in their context, including finalisation of funding proposals within the Post-2020 SAP BIO Resource Mobilisation Strategy;

- g) Strengthening partnerships with major regional and global actors and scientific and academic networks/institutions; Enhancing participation and engagement of the civil society, as well as of the private sector;
- h) Promoting gender mainstreaming into UNEP/MAP operations and activities.

## **Enabling Programme 6: Towards Monitoring, Assessment, Knowledge and Vision of the Mediterranean Sea and Coast for Informed Decision-Making**

- 17. The main objective of the proposed 2024-2025 PoW for this Programme is to recapitalize on the work undertaken for the implementation of IMAP, with a view to entering into a new phase and delivering an updated IMAP for GES assessment, based on the outcomes of the 2023 Mediterranean Quality Status Report (2023 Med QSR). This Programme also aims at strengthening the Environment and Development Observatory in support of CPs decision-making. Another key objective of proposed 2024-2025 PoW for this Programme is to strengthen the information system for IMAP including with the integration of assessment tools, as well as the delivery of a Knowledge Management Platform for the MAP system.
- 18. More specifically, the proposed 2024-2025 PoW envisages:
  - Implementing IMAP at national and as appropriate sub-regional level taking in consideration the MED QSR 2023 recommendations and preparing thematic analyses and assessments as requested by the Contracting Parties;
  - b) Maintaining and updating all InfoMAP components such as: Barcelona Convention Reporting System (BCRS), National Baseline Budget (NBB) reporting system, full IMAP Info System for all IMAP Common Indicators and InfoMAP Spatial Data Infrastructure for the geographical data and maps (InfoMAPNode); as well as enhancing and updating InfoMAP tools as INFO/RAC Cloud tools;
  - c) Strengthening national capacities to organize, upload, validate and release IMAP data, and to establish a strong science-policy interface for the implementation of the ecosystem approach;
  - d) Maintaining MAP Components' databases and products and ensuring full operability of the new MAP Knowledge Platform allowing the migration, integration, harmonization, management and update of InfoMAP System and MAP Components databases in a unique hub;
  - e) Disseminating widely the main elements of the Med2050 foresight study, making full use of them for further strategic approaches through spin-off (thematic or geographical) activities and linking them with future MSSD preparatory activities;
  - f) Strengthening work of global, regional, national and sub-national observatories on environment and development through data-sharing and capacity-building and updating the MSSD dashboard and the SCP indicators database, and their integration into the World Environment Situation Room.

## **Enabling Programme 7: For Informed and Consistent Advocacy, Awareness, Education and Communication**

19. The main objective of the proposed 2024-2025 PoW for this Programme is to inform stakeholders and policy makers about the state of the Mediterranean Sea and coast and to make them aware of the environmental priority issues, and to disseminate knowledge and raise awareness and outreach of general public in particular youth, including through citizen science and digital campaigns. It also aims at contributing to a digital transformation using new technologies to improve networking and MAP visibility. A key milestone in our advocacy campaign is the celebration with pride and inclusiveness of

the 50 years Anniversary of MAP (1975) and 20 years Anniversary of MAP II and of the current Barcelona Convention (1995), all adopted in Barcelona, Spain.

- 20. More specifically, the proposed 2024-2025 PoW envisages:
  - a) Implementing the MAP Operational Communication Strategy 2024-2025 in the framework of the 2024-2029 Communication Strategy, and updating it for the biennium 2026-2027;
  - b) Publishing and disseminating the results from the 2023 MED QSR, the Med2050 Foresight, and other environmental assessment products;
  - Delivering the MAP Knowledge Management Strategy and ensuring functioning and maintenance of MAP Knowledge Management Platform integrating information and knowledge from the entire MAP system;
  - d) Celebrating dedicated recognized Days of importance to the Mediterranean (i.e., Mediterranean Coast Day, SPAMI Day etc.) and UNEP/MAP system anniversaries, i.e., UNEP/MAP 50<sup>th</sup> anniversary, SPA/RAC 40<sup>th</sup> anniversary and INFO/RAC 20<sup>th</sup> anniversary;
  - e) Delivering environmental and sustainability awards and certificates (e.g., WeMed Sustainability Award, Istanbul Environment Friendly City Award, SPAMI Certificates) to enhance public awareness and outreach;
  - f) Preparing and implementing education and awareness programmes on key issues, including through e-learning tools with a special attention to youth;
  - g) Developing and implementing a concrete communication and visibility plan towards COP 24.

## Key Principles for the Budget preparation<sup>1</sup>

- 21. The proposed 2024-2025 PoW and Budget aims at maintaining the total budget at the same level as in 2022-2023 (15,915,413 EUR), with the addition of 350,000 EUR (395,500 EUR including PSC) allocated to activities' budget for ad hoc mandates, as explained in paragraphs 24-25 below, therefore amounting to a total budget of 16,310,913 EUR.
- 22. There is an overall increase of the operational costs as compared to the 2022-2023 biennium, due to two main reasons, i.e. (i) increase of staff salary costs and administrative support costs and (ii) addition of two positions in CU and REMPEC, as outlined in detail below. However, every effort has been made to economise on the use of resources from administrative purposes to the extent possible. In particular, a significant reduction has been made to the operational costs of the Coordinating Unit and MED POL to enable the Secretariat to top up the budget for activities. Specifically, the Other Office Costs of the Secretariat are reduced by 85,000 EUR (from 270,000 EUR in 2022-2023 to 185,000 EUR in 2024-2025, as shown in Table 4a of the proposed 2024-2025 PoW and Budget) to supplement the activities costs.
- 23. It has to be noted that all the additional administrative support and operational costs are going to be absorbed through the amount of total budget approved for the 2022-2023 biennium, per each respective Component.

#### Additional resource needs for ad hoc mandates

- 24. As indicated under paragraph 21 above, the proposed 2024-2025 PoW includes a number of important ad hoc mandates which are more specific than the usual set of PoW activities and require additional support in order to ensure a participatory and inclusive process for their delivery, through consultation with Contracting Parties and integrated work among MAP Components. These important "ad hoc" mandates comprise the upgrade of MAP info systems to integrate assessment tools and modalities (additional support proposed amounting to 50,000 EUR), the development of a revised roadmap for ecosystem approach implementation and IMAP (additional support proposed amounting to 60,000 EUR), the MSSD revision (additional support proposed amounting to 50,000 EUR), a continued countries support for the implementation of the Med SOx ECA (additional support proposed amounting to 40,000 EUR) and the preparation of studies for a possible designation of the Med NOx ECA pursuant to MARPOL Annex VI (additional support proposed amounting to 10,000 EUR), the Secretariat's contribution to the organisation of the 9th international "Our Ocean Conference" (OOC-9) (additional support proposed amounting to 10,000 EUR), the celebration of the 50 years Anniversary of MAP (1975) and 20 years Anniversary of MAP II and of the current Barcelona Convention (1995) (additional support proposed amounting to 30,000 EUR), the preparation of updated NAPs/PoM under the LBS Protocol (additional support proposed amounting to 50,000 EUR). More resources are also required to provide smoothly the necessary services to the organisations of the COP (additional support proposed amounting to 50,000 EUR).
- 25. Based on the above, it is estimated that an additional amount of 350,000 EUR (395,500 EUR including PSC) compared to the approved budget for 2022-2023 is required for the ad hoc mandates. The addition of dedicated resources for these purposes will not only indicate a particular priority for the respective activities but will be also serve as a way to seek and generate interest for mobilisation of additional external resources from Contracting Parties or other interested donors.

Elements for consideration regarding the Administrative and Staff Salary Costs

## i. Administrative costs increase

- 26. In terms of administrative costs, it is proposed to have a total 3 percent increase for the administrative support costs of the RACs, a 3 percent increase on the costs of both the international and locally recruited staff posts of REMPEC, a 3 percent increase on the costs of international staff posts and a 5 percent increase of the locally recruited staff posts of the Secretariat, all calculated for the biennium as compared to the 2022-2023 budget.
- 27. The MAP Secretariat proposes to maintain the increase of the UN International Professional Staff costs, both the MAP Secretariat and REMPEC, at 3% for the biennium (an annual increase of 1.5%), taking into account the current rate of consumption of staff costs, expected to be at the level of approx. 90% of the approved 2022-2023 budget, at the end of the biennium. The proposed 3% increase is the minimum required to cover the projected costs in 2024-2025. The Secretariat will closely monitor the budget balance of staff costs in 2024-2025 and propose an adjustment in 2026-2027 biennium if necessary.<sup>2</sup>
- 28. For the Local General Services staff costs of the MAP Secretariat in Athens, a higher biennial increase of 5% (an annual increase of 2.5%) is proposed. This reflects the increased projected actual costs for the current biennium, mainly due to the adverse effect of currency exchange rate fluctuations between US dollars and Euro during the 2022-2023 biennium.
- 29. With regards to REMPEC, the Secretariat would like to bring to the attention of the MAP Focal Points that the 3% increase has been applied only to the staff posts costs, while the Other Administrative Costs have been maintained at the level of the 2022-2023 budget.

## ii. New positions proposed

- 30. The Secretariat, in addition, considers including some new positions to be budgeted in the next biennium, as follows:
  - a) It is important to strengthen REMPEC with an additional P5 position, that would enhance competency and leadership of the Center considering the new mandates related to SOx ECA and possibly work on NOx ECA. For the next biennium, the proposed post will be funded for one year only (2025) considering the time required for its establishment and recruitment process, while maintaining the P4 position for both years.
  - b) It is proposed to re-establish the post of the Assistant to the MAP Coordinator at G6 level, that was frozen in the biennium 2012-2013 and no allocations were included in the PoW and budget for the consecutive biennia. The "freezing" of this post has resulted in assigning in the existing post of one Assistant at G5 level the duties of the Assistant to the Coordinator and to the Deputy Coordinator, the Assistant of the Front Office Unit, including the preparation of all folders submitted for clearance by the MAP Senior Management, and the support of tasks pertinent to the MSSD implementation, and as such, the re-establishment of the post of the Assistant to the MAP Coordinator will support the disaggregation of the above functions and as a result, facilitate the smoother and more effective running of the office operations. For the next biennium, it is proposed that this post be financed with savings under the Host Country Contribution account (CAL).
  - c) Under the MedProgramme, the Secretariat has used the approved budget under activity "Strengthen the MAP result-based programmatic framework including gender mainstreaming and sustainability of operations" to establish 2 G5 positions as a counterpart contribution to

GEF funds. We were informed by the HQ that these costs should appear as part of the staffing table of the Secretariat because their costs are financed with MTF and the related OTA funds if available, levied on the MTF. These posts appear on Table 4a. Details of Salaries and Operational and other Activities Costs (Secretariat) of the proposed 2024-2025 PoW and Budget. It should be noted that in line with the above arrangement, the amount of MTF funds that used to be allocated in past biennia, as co-financing to the MedProgramme (i.e. 180,000 EUR at biennial level) has been reduced by the amount allocated for the post of (MedProgramme) Programme Assistant, i.e. 124,752 EUR, and therefore only the amount of 55,000 EUR (rounded figure) from MTF is allocated to the relevant activity 5.2.5.

31. The Secretariat is confident that despite the lower amount allocated for activities in particular for CU, MED POL, and REMPEC, due to the increase of administrative costs, every effort will be made to compensate any potential impacts, through four main factors: a) strengthening the capacity of the Secretariat to deliver more effectively; b) reducing to the extent possible the costs of meetings and using up-to-date delivery modalities; c) reducing other office costs and making operations more effective; and d) mobilising larger amounts of external resources.

#### External resources

32. It is important to note that the Secretariat has secured or is in the process of mobilising additional external resources that will support the activities of the 2024-2025 PoW through ongoing and newly approved projects, i.e. EUR 4,000,000 expected to become secured under the EU-funded SEMPA Project (DG NEAR) for a four-year period i.e. August 2023-August 2027, USD 2,200,000 expected to become secured under the EU-funded ECAP Med Plus Project (DG ENV) for a three-year period, i.e. March 2024 – February 2028, and USD 1,200,000 expected to become secured under the EU-funded Marine Litter Med Plus Project (DG ENV) (*specific yearly allocations for the three projects to be defined at a later stage*); USD 1,132,986 are already secured under the FishEBM Med Project for the biennium 2024-2025; as well as approximately USD 16,000,000 together with implementing partners' budget, from the GEF-funded MedProgramme for 2024-2025.

## Composition of proposed budget for 2024-2025

- 33. Based on the above proposals, the total amount from MTF required for the implementation of the proposed 2024-2025 PoW is EUR 16,310,913 which is composed of EUR 15,915,413<sup>3</sup>, as approved in the PoW and Budget 2022-2023, with the addition of approx. EUR 350,000 (EUR 395,500 incl. PSC) for the ad hoc mandates as described above.
- 34. A budget solely based on the approved ordinary income of the Mediterranean Trust Fund in 2022-2023 biennium amounting to EUR 13,296,144, cannot provide the necessary budget allocations for the effective implementation of the proposed 2024-2025 PoW.
- 35. For this reason, the Secretariat would like to propose for consideration by the MAP Focal Points, to cover the additional budget, in addition to the ordinary income of the Mediterranean Trust Fund at 2022-2023 level, through a combination of (i) the use of approx. EUR 2.4 million from MTF surplus and (ii) a marginal increase of the assessed contributions for the 2024-2025 biennium at the level of 5 percent (amounting to EUR 570,680), as further elaborated below:
  - i. MTF surplus

- 36. The Total Net Assets of USD 7.9 million, as reflected in the certified and audited Statement of Financial Position for the year ended 31 December 2021, comprises of the Working Capital Reserve of USD 1. 2 million and the accumulated surplus of USD 6.7 million<sup>4</sup>. A table showing the status of the MTF balance and its evolution from 2012 until 2021 is also attached as Appendix 2 to the present document.
- 37. The Cash and Cash equivalents as at 31 December 2021 amount to USD 6,803,276.35. By deducting the Working Capital Reserve of USD 1,185,602.61 the net cash balance is calculated at the amount of USD 5,617,673.74.
- 38. The factors which contributed to the accumulation of the MTF surplus as at 31 December 2017 were presented at the COP21 in paragraphs 50 and 51<sup>5</sup> of the Working Document Draft Decision: Programme of Work and Budget 2020-2021 (UNEP/MED IG.24/17), submitted to COP 21 (Naples, Italy, 2-5 December 2019). The accumulated surplus increased from USD 6,985,902 as at 31 December 2017 to USD 7,702,442 as at 31 December 2019 for the reasons explained in paragraph 38<sup>6</sup> of the Working Document Draft Decision IG.25/19: Programme of Work and Budget for 2022-2023 (UNEP/MED IG.25/22/Rev.2) submitted to the COP 22 (Antalya, Türkiye, 7-10 December 2023), and was reduced to USD 6,685,385 as at 31 December 2021 due to utilization of the surplus for PoW activities in 2020-2021 biennium. The potential savings as at 31 December 2023 has been projected to be approx. USD 3 million, which will be updated at COP23 in Slovenia.
- 39. The use of MTF surplus over the past biennia has gradually led to its significant reduction. For the 2024-2025 biennium the proposal of the Secretariat is to use EUR 1.1. million from the MTF surplus.

Accounts receivable are reduced by the allowance for doubtful accounts (AFDA), which is a provision for bad and doubtful debts recorded as accruals at the end of the reporting period, while the remaining value of the assessed contributions receivable as reflected in the Statement of Financial Position might include arrears for which an allowance of less than 100% is calculated, all in accordance with the UN IPSAS policy framework; (b) advance transfers and prepaid expenses of USD 687,999 (not yet recorded as expenditures; as soon as the respective expenditure is recorded, the total net assets will be reduced accordingly) minus Accounts Payable and Other Liabilities of USD 241,996, and (c) other accounting items of USD 3,240 (i.e., property, plant and equipment). The result of the deduction of the sum of above items of USD 1,067,712 from the accumulated surplus of USD 6,685,386 is the net cash balance of USD 5,617,674 as at the end of the year 2021. A similar analysis for 2022 and 2023 accounts cannot be completed before the end of the biennium and financial statements are finalized for both years.

Following the MTF deficit of USD 4.5 million in 2009, the implementation of the functional review recommendations led to the generation of significant savings on the personnel costs of UNEP/MAP (Coordinating Unit and MED POL) through either abolishment of posts, downgrading or merging the functions of several posts in one. Savings on the personnel costs were also generated through vacant posts due to lengthy selection and recruitment processes. For the period 2014-2017 a total of 98,5 man-months relating to the P-staff category and 24 man-months relating to the G-staff category in the Coordinating Unit and MED POL were vacant. The approved budget for staff costs in the Coordinating Unit and MED POL for the period 2014-2017 amounts to USD 6,358,019 (equiv. EUR 5,411,268) while the incurred expenditure for the same period, as per the statement of accounts, amounts to USD 2,642,158 (equiv. EUR 2,242,416). The unspent balance, amounting to USD 3,715,861 (equiv. EUR 3,168,852), consists of approximately 1.22 mill USD for staff costs charged to other funds, 1.58 mill USD from vacant posts and 0.91 mill USD mainly attributed to the fact that salary scale figures used in the budget do not necessarily correspond with the actual figures of the duty station but they represent an applicable average. In addition, during past biennia the budget allocations were lower than the approved amounts mostly due to the delays in the payment of contributions, which prevented the timely programming of the entire approved budget, in conformity with decision of the Contracting Parties to incur commitments only the amounts corresponding to contributions already received. Lastly, the impact of exchange rate fluctuations? on both income and expenditures, which depends on the timing and magnitude of foreign currency movements as well as on the time lag between when pledges are received and when expenses are incurred, is roughly estimated to account for 5%-10%

<sup>51.</sup> Taking into account the above elements, the main reasons for the accumulation of the MTF surplus are the following: (a) savings from staff costs as explained in paragraph 50 above; (b) the efforts made by the Secretariat to reduce the meeting costs by organizing, to the extent possible, back to back meetings; (c) the fact that some Contracting Parties did not always attend meetings; and (d) delays in implementing national activities which in several cases led to non-absorption in full of allocated amounts. Other factors that have also contributed to the surplus is the non-timely execution of some activities due to payment of main contributions after June of each year, as well as the administrative delays caused by the introduction of the UMOJA financial system.

Not considering the accounting items, this increase in the surplus corresponds to savings of USD 0.8 million from budget implementation in 2018-2019. One factor which contributed to this increase relates to the savings arising from vacancies in established posts because of the long recruitment procedures. In particular, the post of the Programme Officer QSR Expert - P.3 and the post of the Programme Officer (MEDPOL) - P.4 were vacant for 8 months in 2019 and in 2018, respectively. Another factor which contributed to the increase in the accumulated surplus relates to the returns on investments which increased the total revenue of the MTF in the biennium 2018-2019. The impact of the exchange rate fluctuations on both income and expenditures and the budget implementation rate of less than 100% are also to be taken into consideration. As a conclusion, it appears that out of the USD 0.8 million savings increase in 2018-2019 compared to end of 2017, 54% arises from staff costs of CU and MED POL, 24% from other administrative costs of CU and MED POL, 18% from administrative support costs for RACs, and the remaining from lower costs for the implementation of the activities, as indicated in the Financial Implementation Report UNEP/MED IG.25/25.

- 40. With regards to the EC Discretionary Contribution account, a "Statement of Performance" report has been provided by UNEP HQs which describes the annual movement of income and expenditures and the changes in the available balances for this account. The available balance of USD 1.3 million, as reflected in the Interim Certified Financial Statement for the period ended 31 December 2021, reflects the excess of Income over Expenditure and the Exchange Rate (loss)/gain for the respective period. A table summarizing the evolution of this account from 2014 until 2021 is attached as Appendix 2 to the present document. The potential savings as at 31 December 2023 has been projected to be approx. USD 1.4 million, which will be updated at COP23 in Slovenia. The proposal of the Secretariat is to use the total amount of these savings for the 2024-2025 PoW and Budget.
  - ii. Need to increase the assessed ordinary contributions of the Contracting Parties to the MTF
- 41. Considering the above-mentioned anticipated reduction of MTF savings, and in order to ensure the long-term financial sustainability of the MAP system, it is important to bring to the attention of the MAP Focal Points the need for a regular increase in assessed ordinary contributions. This increase should align with international practices which take into consideration the annual increments in the salary scale of the UN staff and other relevant factors recommended for other UNEP administered MEAs.
- 42. In the proposed 2024-2025 PoW and Budget, it is recommended to increase the contributions by 5% for the biennium (amounting to EUR 570,680), to absorb the increasing administrative costs adequately. Ideally, a higher increase between 6% to 8% for the biennium is considered in line with the standard practice of other MEAs which would not only cover the administrative costs but also absorb the cost increase of the activities in line with the trend of the global market. This increase of 5% would enable the use of part of the MTF surplus for the following biennia beyond 2025.
- 43. In addition, the Contracting Parties are strongly encouraged to provide significant voluntary contributions to support the implementation of PoW activities, as per the already established practice, in particular the considerable amounts provided by Italy and France as voluntary contributions. Negotiations have been launched and are ongoing with the Ministry for Europe and Foreign Affairs of France for the allocation of a voluntary contribution at the amount of approx. EUR 1.2 million for the implementation of the PoW and Budget 2024-2025.

#### UN Scale of Assessments

- 44. The table of contributions annexed to this draft Decision is based on the UN scale of assessments for the period 2022 to 2024, adopted by the UN General Assembly (UNGA) at its 76<sup>th</sup> Session on 24 December 2021 in Resolution A/RES/76/238.
- 45. The UN Scale of assessments is updated triennially, while the MAP Programme of Work and Budget is adopted biennially. Therefore, the updated UN scale of assessments for 2025 may not be final at the time of budget approval. Following discussion with the relevant services of UNEP HQ and taking into consideration the practices of other MEAs, it is proposed that the scale of assessment applied on the contributions table included in the draft Decision at the time of COP 23, will be maintained for the entire biennium.

## Working Capital Reserve

46. Since 2015, a Working Capital Reserve (WCR) has been established in line with Procedure 3 of the Financial Rules and Procedures for the funds of the Barcelona Convention. The level of the WCR shall be determined by the Conference of the Parties by consensus, bearing in mind the desirability of bringing its level to the recommended UN rate of 15 percent of the average annual budget for the biennium, inclusive of programme support costs. In line with COP 18 Decision IG.21/17, the WCR

was established at the level of 15 percent of the annual expenditures. For the biennium 2024-2025, the total WCR should be decreased as compared to that in 2022-2023<sup>7</sup>.

### RAC Host Countries' Contributions

47. Part C (RAC's Hosting Countries' Contributions) of Table 2. "Overview of Income and Commitments" in the Annex to this Decision will be filled in upon receipt of the expected value of contributions from the host countries of the RACs and will be updated as soon as the value is confirmed by the respective host countries.

## Financial Implementation of the Programme of Work and Budget 2022-2023

48. For MTF (Fund:40MEL & Grant:M1-32QML-000008), the budget consumption rate for the biennium 2022-2023, as of 30 June 2023 reached the level of approximately 75%, out of which 42% represents the expenditure level and 33% represents the commitments level. In further detail, as regards the budget allocated to the RACs, the rate of commitment is at the level of 100%, since all the funds under the Legal Instruments for the PoW 2022-2023 have been disbursed to the RACs for the entire biennium, while the rate of expenditure is at the level of 36%, noting that this figure represents the expenses reported by the RACs for the period January-December 2022, as the reporting of expenses for the first semester 2023 is due by end of July, after which the expenditure rate is expected to be significantly increased and figures will be updated. Regarding the budget of CU and MED POL, the expenditure rate as of 30 June 2023 is at the level of 49% and the commitment rate is at the level of 7%, noting that budget for some major activities, in particular the COP 23 organization, has not yet been committed at the time of preparation of the present document.

#### Arrears

- 49. The collection rate of the Assessed Ordinary Contributions for the year 2023, reached the level of 50.01% and the pledges in arrears reached the amount of EUR 1,114,454 as of 30 June 2023 (Appendix 1).
- 50. As of 30 June 2023, four Contracting Parties were in arrears for more than two years, as detailed in the table below.

51. In line with Procedure 4.2.d of the Financial Regulations and Rules and Procedures for the Contracting Parties, its subsidiary bodies and the Secretariat of the Barcelona Convention, the Coordinator is writing to those Parties whose contributions have not been received by the 1<sup>st</sup> July of year 2023, to impress upon them the importance of paying their respective contributions for the year as well as arrears for prior periods. In line with Procedure 4.2.e of the Financial Regulations and Rules and Procedures, the Coordinator has proposed to the four Parties whose contributions are in arrears for two or more years, a payment schedule to enable them to clear all outstanding arrears

within a maximum of six years and to pay future contributions by their due dates. The Secretariat is continuing its efforts with the relevant national authorities. Regarding the outstanding payments of the Government of Algeria, the initial installment of EUR 39,630 intended for settling the arrears in the framework of the agreed repayment plan for the MTF as well as the payments of their 2022 annual contribution have been received by UNEP HQs<sup>8</sup>.


Appendix 3. Graphical representation of key budget elements














## [Decision IG.26/14

#### Programme of Work and Budget for 2024-2025

The Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean and its Protocols at their 23<sup>rd</sup> Meeting,

Recalling Articles 18 and 24(2) of the Barcelona Convention and Decision IG.21/15 of COP 18 (Istanbul, Türkiye, 3-6 December 2013) on the Financial Rules and Procedures for the funds of the Barcelona Convention;

Recalling Decision IG.25/1 of COP 22 (UNEP/MAP Medium-Term Strategy 2022-2027) adopting the Medium-Term Strategy 2022-2027 (MTS) as the framework for the development and implementation of the Programme of Work of UNEP/MAP;

*Welcoming* the Progress Report on the activities carried out during the 2022-2023 biennium and the related expenditure report;

*Emphasizing* the need for stable, adequate and predictable financial resources for MAP and the Mediterranean Trust Fund (MTF);

Welcoming the rate of collection of assessed contributions including parts of the arrears, and noting the need for their timely collection;

Appreciating the guidance provided to the Secretariat by the Bureau of the Contracting Parties to the Barcelona Convention during the 2022-2023 biennium;

Expressing deep appreciation to the Contracting Parties and partners that have provided additional financial and other resources for the implementation of the activities of the 2022-2023 biennium, including through the Bilateral Agreements with the Italian Ministry of Environment and Energy Security, and the Ministry for Europe and Foreign Affairs of France, the EU-funded IMAP MPA, EcAp MED III and Marine Litter MED II projects, the GEF-funded MedProgramme, and Fish EBM project, etc. and welcoming the financial resources mobilized by the Secretariat including Regional Activity Centers (RACs) for the same purpose;

Welcoming the simplified structure of the Programme of Work and Budget applied to 2024-2025 Programme of Work and Budget presentation to ensure that Contracting Parties have a clear understanding of the priorities and the relationship with the MTS, bearing in mind the Decision IG. 17/5 "Governance Paper" adopted by COP 15 (Almeria, Spain, 15-18 January 2008);

*Noting with appreciation* the progress made on the refurbishment of the premises of the Coordinating Unit with the strong support of Government of the Hellenic Republic and welcoming the actions to be undertaken to conclude this process in 2024;

- 1. Request the Executive Director of UNEP and the Coordinator of MAP to execute the Budget taking into consideration Decision IG.21/15 on the Financial Regulations and Rules and Procedures for the Contracting Parties, in particular the provisions under Annex II, Procedure 2, paragraph 4, which entrusts the responsibility to certify and authorize expenditures to UNEP in conformity with the Programme of Work and Budget Decisions adopted by the Conference of the Parties;
- 2. *Approve* the 2024-2025 Programme of Work and Budget set out in the Annex to this Decision;
- 3. Approve the budget appropriations, as set out in Table 1. "Overview of income and commitments" of the Annex to this Decision; the income in the amount of EUR 13,866,824, composed of the Mediterranean Trust Fund in the amount of EUR 11,984,256,

the European Union discretionary contribution in the amount of EUR 1,192,968 and the host country contribution of EUR 689,600 (USD 800,000); the use of the MTF positive cash balance up to the amount of EUR 2,444,089;

- 4. *Approve* the use of the budget appropriations as set out in Table 3 Summary of Activities and Administrative Costs by MAP Component;
- 5. *Approve* the 2024-2025 assessed ordinary contributions from Parties shown in Table 2 "Expected Ordinary Income" of the Annex to this Decision, which is based on the 2022-2024 scale of assessment adopted by the United Nations General Assembly (UNGA) at its 76<sup>th</sup> Session on 24 December 2021 in Resolution A/RES/76/238;
- 6. Request the Executive Director of UNEP, subject to the approval of the United Nations Environment Assembly, to extend the Mediterranean Trust Fund through 31 December 2025;
- 7. Approve the staffing of the Coordinating Unit including MED POL for 2024-2025 as indicated in Table 4a. "Details of Salaries and Operational and other Activities Costs of the Secretariat" in the Annex to this Decision;
- 8. *Take note* of the staffing of REMPEC for 2024–2025 as indicated in Table 4b, "Details of Salaries and Administrative Costs of REMPEC" in the Annex to this Decision;
- 9. *Take note* of the external funding secured by the Secretariat and MAP Components in the amount of EUR 11,298,300 and external non-secured funding in the amount of EUR 15,093,777 for the implementation of the Programme of Work 2024-2025;
- 10. Authorize the Coordinator in line with Decision IG.21/15 on the Financial Rules and Procedures for the Funds of the Barcelona Convention, Procedure 2, paragraph 6, to approve transfers within the same Programme and Component up to 20 per cent within the criteria: a. funds to be transferred are savings achieved upon committing funds for full delivery of activities planned in the approved Programme of Work, b. the transferred funds are strictly used for achieving the outcomes of the Programme of Work of concerned biennia in line with the outcomes of the 2022-2027 Mid-term Strategy; and c. such transfers are reported for information at the first meeting of the Bureau of the Contracting Parties following occurrence of such transfers;
- 11. *Urge* the Contracting Parties to strictly adhere to Procedure 4.2 of the Financial Rules and Procedures and pay their contributions to the MTF in the first quarter of each year to allow for the full and effective implementation of the Programme of Work;
- 12. Request the Secretariat to keep up to date information on the status of Contracting Parties' contributions to the Mediterranean Trust Fund and to continue to post it in a publicly available place on the UNEP/MAP website and report, for information, to the Bureau of the Contracting Parties in their periodical meetings on the status of unutilized resources;
- 13. *Urge* the Contracting Parties to adhere to nomination deadlines of their representatives in meetings of the MAP system and to avoid modifications and cancellation of their travel in order to minimize losses arising from the increase of airfare and cancellation fees and inefficiencies;
- 14. *Urge* the Contracting Parties to consider increasing their voluntary contributions in cash and/or in kind in support of the implementation of the 2024-2025 Programme of Work and to support the resource mobilisation activities of the Secretariat;
- 15. *Invite* other partners including industry to contribute adequate human and financial resources to meet the external funding requirements for priorities still unfunded

under the 2024-2025 Programme of Work and Budget;

16. Request the Secretariat, in consultation with the Bureau, to prepare for careful consideration by the MAP Focal Points and, after further refinement, approval by COP 24 a result-based Programme of Work and Budget for 2026-2027, explaining the key principles and assumptions on which it is based and taking into account the progress achieved during the implementation of the 2022-2023 and 2024-2025 Programmes of Work, providing information on the consultation process followed for its preparation, and in full alignment with the MTS.]
