

The delegation of each State participating in the Conference shall consist of accredited representatives and such alternate representatives and advisers as may be required.

Rule 2

An alternate representative or an adviser may act as a representative upon designation by the chairman of the delegation.

Subwission of credentials

Kule 3

The credentials of representatives and the names of alternate representatives and advisers shall be submitted to the executive Secretary of the Conference if possible not later than 24 hours after the opening of the Conference. Any later change in the corposition of delegations shall also be submitted to the Executive Secretary. The credentials shall be issued either by the head of State or Government, or by the Minister for Loreign Affairs.

A Credentials Committee shall be appointed at the beginning of the Conference. It shall consist of not more than five members, who shall be appointed by the Conference on the proposal of the President. The Committee shall elect a chairman. It shall examine the credentials of representatives and report to the Conference without delay.

In addition to exercising the powers conferred upon him elsewhere by these rules, the Fresident shall declare the opening and closing of each plenary meeting of the Conference, direct the discussions at such meetings; accord the right to speak; put questions to the vote and announce decisions. he shall rule on points of order and, subject to these rules of procedure, have complete control of the proceedings and over the maintenance or order thereat. The Fresident, may propose to the Conference the time to be allotted to speakers, the limitation of the number of times each representative may speak on any question, the closure of the list of speakers or the closure of the debate. Le may also propose the suspension or the adjournment of the meeting or the adjournment of the debate on the question under discussion.

Rule 20

No person may address the Conference without having previously obtained the permission of the President. Subject to rules 21 and 22, the President shall call upon speakers in the order in which they signify their desire to speak. The Secretariat shall be in charge of drawing up a list of such speakers. The President may call a speaker to order if his remarks are not relevant to the subject under discussion.

kule 21 The Chairman or Rapporteur of a committee, or the representative of a sub-domnittee or working group, may be accorded precedence for the purpose of explaining the conclusion arrived at by his committee, sub-committee or working group.

During the discussion of any matter, a representative may rise to a point of order, and the point of order shall be immediately decided by the President in accordance with the rules of procedure. A representative rising to a point of order may not speak on the substance of the matter under discussion.

The Conference shall normally vote by show of hands or by standing, but any representative may request a roll-call. The roll-call shall be taken in the English alphabetical order of the names of the States participating in the Conference, beginning with the delegation whose name or is drawn by lot by the President.

Conduct during voting

Rule 39

After the President has announced the beginning of voting, no representative shall interrupt the voting except on a point of order in connexion with the actual conduct of the voting. The President may permit representatives to explain their votes, either before or after the voting, except when the vote is taken by secret ballot. The President may limit the time to be allowed for such explanation. Division of proposals and amendments

Kule 40

A representative may move that parts of a proposal or an amendment shall be voted on separately. If orjection is made to the request for division, the motion for division small be voted upon. If the motion for division is carried, those parts of the proposal or amendment which are subsequently approved shall be put to the vote as a whole. Where, however, the adoption of one amendment necessarily implies the rejection of another amendment, the latter amendment shall not be put to the vote. If one or more amendments are adopted, the amended proposal shall then be voted upon. A motion is considered an amendment to a proposal if it merely adds to, deletes from or revises part of that proposal.

Plenary meetings and meetings of committees

Rule 55

The plenary meetings of the Conference and the meetings of the Main Committees shall be held in public unless the body concerned decides otherwise. As a general rule, meetings of the other committees and of any sub-committee or working group shall be held in private.

Chapter X

Observers of Number States of the United Nations, of the specialized agencies, of intergovernmental organizations and other observers

Rule 56

- 1. Observers of Member States of the United Nations, the specialized agencies and observers of intergovernmental bodies as well as other observers invited to the Conference may participate, without the right to vote, in the deliberations of the Conference, the Main Committees, sub-committees, working groups and other subsidiary organs of the Conference, upon the invitation of the President or Chairman, as the case may be.
- 2. Written statements of the representatives and observers referred to in paragraph 1 of this Rule shall be distributed by the Secretariat to the delegations at the Conference.
