Goals and objectives of Bern III

- ✓ Identify opportunities to strengthen cooperation and collaboration within and among Parties to the biodiversity-related conventions, Rio conventions and other relevant multilateral environment agreements (hereafter referred to as "MEAs") in implementing the Kunming-Montreal Global Biodiversity Framework (KMGBF) at all appropriate levels.
- ✓ Make recommendations on further steps that could be taken to strengthen cooperation and collaboration, while recognizing and respecting the roles and mandates of each MEA.
- ✓ Share practical experiences of cooperation and collaboration in implementation.

No-Goals of Bern III

- X Repeat the Bogey-Bossey brainstorming and re-open the list of ideas
- X Negotiation between parties or preempt CBD COP16 or other MEAs' governing bodies.
- X Dwell on or challenge the mandates that brought people to Bern III

Bern Conference – Principles

- We identify the next steps for everything we recommend: Bern III Conference deliverables are good practical ideas on who needs to do what, with what follow-up and by when.
- We share experience openly to enable scaling up good practice
- We spend as little time in plenary as possible this is not a negotiation!
- We start thinking about the future of the Bern Process from the beginning
- We can't deliver on our own, but need the input of the broader stakeholder community to implement the KMGBF
- We have no hierarchies among participants!

An important milestone towards achieving CBD COP 15 decision 15/13 on cooperation with other conventions and organizations and the associated package of decisions adopted supporting the implementation of Kunming-Montreal Global Biodiversity Framework (K-M GBF)

cop-15 invites governing bodies of other biodiversity-related conventions to take specific actions to align their processes in support of implementation and monitoring of the Kunming-Montreal Global Biodiversity Framework, and calls for continuation of the Bern Process to strengthen cooperation and collaboration among parties and secretariats of the various MEAs in delivery



Bern process aims to strengthen cooperation among parties and secretariats of the biodiversity-related conventions and other relevant conventions, in implementing the **KMGBF**

CBD COP invited UNEP within its role to facilitate strengthened cooperation and collaboration amongst MEAs in implementing the K-M GBF- building on experience of the Bern consultations and engaging with those in relevant thematic clusters

Working with the Swiss Government and SCBD, UNEP is planning for a Bern III Conference in January 23-25, 2024 to consider cooperation amongst MEAs in implementing the K-M GBF

- ➤ UNEP worked in close collaboration with the SCBD and Switzerland as host of the conference, and UNEP-WCMC partner
- ➤ June 27-30, 2023, **Bogis-Bossey Expert Meeting**, to gather advise on agenda and process of organization
- ➤ July- September 2023, **the Co-Chairs** of the Bern III Conference Ms. Clarisse Kehler Siebert from Sweden and Ms. Camila Isabel Zepeda Lizama from Mexico and organizing committee
- ➤ Worked with 15 MEA secretariats to coordinate invitations to party representatives as appropriate- Other relevant organizations and stakeholders' groups
- ➤ 18 October 2023, SBSTTA-25 Side Event on Cooperation in implementing the framework preparation for the Bern III Conference Nairobi, Kenya, to gather further inputs from CBD/SBSTTA Parties and MEAs attending


