UNEP Working Group on Nitrogen in collaboration with the Global Partnership on Nutrient Management (GPNM)

BACKGROUND

Acknowledging the outcome of the third meeting of the UNEP Working Group on Nitrogen, held in Bucharest, Romania on 27 April 2023, the UNEP-WGN had an informal expert dialogue with GPNM members on 28 April 2023, to explore areas of cooperation and synergies, and in particularly how the GPNM could contribute to the work process by providing technical support to the focal points.

It was decided that during the inter-sessional period the GPNM would organize information-sharing, technical webinars on specific topics.

It was also decided that the GPNM would convene an informal expert meeting backto-back to the meetings of the Working Group to provide inputs into focal point discussions in an informal setting and draw attention of the policy makers through the NWG on other related issues of sustainable nutrient management that GPNM addresses such as Phosphorus in pursuance to the decision of the Intergovernmental meeting of the GPA¹ (Manila Declaration 2012).

The proposed dialogue on phosphorus is organised with reference to the above to inform Member States on the work of the GPNM on phosphorus which is a critical nutrient for food security but at the same time due to its inappropriate use causing multiple environmental challenges.
