



Introduction (1/2)

Definition

The country has mechanisms in place to promote the alignment of private and public financing with policy coherence objectives and to track related expenditure





Introduction (2/2)

Why are financial resources and tools important?

- To track allocations and expenditure promoting policy coherence, such as contributions to all dimensions of sustainable development, consideration of cross-sectoral impacts and the alignment across government levels
- To ensure that funds from different sources are coherent with national policies and priorities



Country example

Republic of Korea



- Coordination mechanism to ensure coherence and alignment of official development assistance projects with the SDGs
 - ➤ Each ministry and agency are requested to specify which Goals and targets are relevant to their respective projects
 - Mandatory evaluation of international development cooperation projects twice every financial year
 - Mechanism to check the contribution of projects to the achievement of the SDGs

8.1 Check-lists to ensure that plans and budgets reflect policy coherence for sustainable development

Country example: Sierra Leone



- ➤ Also ensures reporting on their progress towards the Goals
- Multilevel governance has many tiers:
 - Within the <u>chiefdoms</u>, there are ward committees that elect councillors for community representation on the local councils
 - > The local councils coordinate implementation of the SDGs at the district level
 - > The regional planning offices coordinate the activities of the local councils

8.2 Integrated financial information systems

Country example: Brazil



- Two open-source public information systems regarding the country's budget, which allow easy
 access to government databases containing information on public plans and budgets
 - SIGA Brasil, run by the Federal Senate
 - Fiscalize, run by the Chamber of Deputies

8.3 Mechanisms to ensure that cooperation funds are aligned with national policies and priorities

Country example: Rwanda



- <u>List of national accounts that includes all aid that has reached the government sector</u> (administered by the Government, donors or third parties)
 - Exposes the underreporting of aid in the budget and discrepancies in relation to aid databases
 - ➤ Enables the Government to look more closely at the integration of aid into the budget cycle for all types of aids
