Chair's Summary

Agenda item 1: Opening of the meeting and adoption of the agenda.

- 1. H. E. Mr. Firas Khouri, Chair of the Committee of Permanent Representatives (CPR), Ambassador of the Hashemite Kingdom of Jordan to Kenya and Permanent Representative to UNEP, opened and chaired the meeting.
- 2. The <u>agenda</u> was adopted.

Agenda item 2: Preparations for / stock-taking of progress made at the sixth meeting of the Openended Committee of Permanent Representatives

- 3. The Secretariat provided an update on the progress made during the sixth meeting of the Openended Committee of Permanent Representatives (OECPR-6), which started on Monday, 19 February and is to conclude its work on Friday, 23 February 2024.
- 4. The Secretariat presented a <u>revised organization of work</u> for OECPR-6 for Friday, 23 February 2024. The Secretariat proposed to move the closing plenary originally scheduled for 15:00 to 19:00, with the aim to provide one more session of informal consultations per cluster to find agreement on as many draft resolutions and decisions as possible before the closing plenary.
- 5. The Secretariat presented an overview of the draft <u>Chair's Summary of the OECPR-6</u>, to be finalize and made available on the meeting portal for consideration and endorsement at the closing plenary session.
- 6. The Bureau endorsed the revised structure for OECPR-6 and the draft Chair's Summary of the OECPR-6.
- 7. The Co-Facilitators requested the Secretariat to provide rooms to enable informal discussions during the weekend.
- 8. The Secretariat informed the Bureau that they could provide rooms for informal consultations pending a decision on how the results of these informal consultations would be presented to the Committee of the Whole (if established).
- 9. Upon request, the Legal Advisor confirmed that informal consultations could continue during the weekend, with some conditions to be met: (1) there has to be agreement by Member States to continue, (2) informal consultations must be open to everyone, and (3) the need for appropriate notification to delegations on the details of the informal consultations.
- 10. The CPR Bureau expressed appreciation for the work carried out by the Secretariat, the Chair

and the Co-facilitators and supported the proposal to continue informal consultations over the weekend under the conditions explained by the Legal Advisor and fully understanding that OECPR-6 will officially close on Friday, 23 February.

11. The Chair informed the CPR Bureau that resolution *Living well in balance and harmony with Mother Earth and Mother Earth centric actions* submitted by Bolivia was withdrawn.
