Joint Bureaux of the United Nations Environment Assembly and the Committee of Permanent Representatives 25 February 2024 16:00 – 18:00 (GMT+3) Hybrid – Conference room 9 and Microsoft Teams

Summary

Agenda item 1: Opening of the meeting and adoption of the agenda.

- 1. H. E. Ms. Leila Benali, President of UNEA and Minister of Energy Transition and Sustainable Development of Morocco, and H. E. Mr. Firas Khouri, Chair of the Committee of Permanent Representatives (CPR), Ambassador of the Hashemite Kingdom of Jordan to Kenya and Permanent Representative to UNEP, opened and chaired the meeting.
- 2. Ms. Inger Andersen, Executive Director of UNEP, welcomed the Bureaux Members of UNEA and the CPR to Nairobi and thanked the members of the CPR Bureau for the work done during the week of the OECPR-6.
- 3. The <u>agenda</u> was adopted.

Agenda item 2: Update on the consultations on the draft ministerial declaration of the sixth session of the United Nations Environment Assembly

- 4. The President of UNEA provided an update on the outcome of the informal consultations on the draft ministerial declaration for the sixth session of the Assembly held on 22 February in the margin of the sixth meeting of the Open-ended Committee of Permanent Representatives. As a follow, the President informed that she would circulate a revised text on Monday, 22 February, for consideration by Member States. The President requested members of the Joint Bureaux to transmit the message of unity, strength, and optimism to their respective regional groups to achieve consensus. The Presidency will also engage bilaterally with delegations to ensure a text as consensual and ambitious as possible.
- 5. Several Bureaux Members recognized the excellent work and efforts of the UNEA President to reach a consensual agreement while adding that the final document should reflect agreed text from previous international agreements and informing that some Member States have requested further consultations.

Agenda item 3: Outcomes from the sixth session of the Open-ended Committee of Permanent Representatives.

- 6. The Chair of the Committee of Permanent Representatives provided an update on the outcomes of the open-ended meeting of the Committee of Permanent Representatives (OECPR-6), which started on Monday, 19 February and concluded on Friday, 23 February 2024, and informed on the status of negotiations on draft resolutions and decisions.
- 7. The Secretariat informed the Joint Bureaux of the outcome of the informal informal consultations held over the weekend and that the co-facilitators may request the Secretariat to upload non-

papers with streamlined/shortened alternative text(s) on the <u>UNEA -6 Resolutions Portal</u>.

8. Several Bureaux Members requested the Secretariat to support the co-facilitators and the Committee of the Whole (once established) on procedural matters to ensure a smooth start to the work of the Committee of the Whole.

Agenda item 4: Update on preparations for the sixth session of the United Nations Environment Assembly

- 9. The Executive Director announced that 7300 participants have registered, and 3600 badges have been collected to date; this is currently the UNEA with the highest participation. 181 countries and 150 Ministers and Vice Ministers have registered to attend.
- 10. The Secretariat provided a detailed update on the status of final preparations for the sixth session of UNEA; informed on the status of credentials submitted to UNEA-6 adding that the final report will be provided to the Bureau on 28 February for approval by UNEA on 29 February; and provided an update on the status of nominations of candidates for the Bureau of the seventh session of UNEA.
- 11. The UNEA Bureau endorsed the nomination of Mr. Norbert Kurilla, Advisor to the President of the Slovak Republic on Environment, Energy and Climate and Vice President of UNEA, as the Chair of the Committee of the Whole, and H. E. Silvio Jose Albuquerque e Silva, Ambassador and Permanent Representative of Brazil to UNEP and Vice President of UNEA as the Rapporteur of the Committee of the Whole.
- 12. The Secretariat presented the organization of the work of the Committee of the Whole to be established on Monday, 26 February, including the provisional agenda and the annotated agenda, which was subsequently endorsed by the UNEA Bureau.
- 13. The Secretariat informed the Joint Bureaux that, given the number of draft resolutions and decisions to be finalized and the limited time available, it may not be possible to make available the drafts in the six UN official languages.
- 14. Several Bureaux Members expressed concern regarding adopting resolutions in English only. Upon request the Legal Advisor explained the provisions of rule 44 of the rules of procedure of UNEA.
- 15. The President informed the Joint Bureaux that, following consultations with the regional and political groups, the oral decision on the Chair of the Group of Asia-Pacific States will be proposed for adoption at the opening plenary of UNEA-6.

Agenda item 5: Organization of work.

16. Following a presentation by the Secretariat, the UNEA Bureau agreed on the proposed division of work among themselves for chairing the meetings devoted to the national statements scheduled for Thursday, 29 February, and Friday, 1 March.
