## **Report of the Committee of Permanent Representatives**

## Note by the Secretariat

Since the closure of the resumed fifth session of the United Nations Environment Assembly, the Committee of Permanent Representatives has convened ten regular meetings, including resumed 160<sup>th</sup> and 162<sup>nd</sup> meetings. At all the meetings except the meeting directly preceding the sixth session of the United Nations Environment Assembly, the Committee has considered a written report of the Executive Director and engaged in an exchange of views with the Executive Director at the meeting.

At its 158<sup>th</sup> meeting on 26 May 2022, the Committee consulted on the assessment and lessons learned from UNEA-5.2 and UNEP@50 and heard a briefing on the preparations for the Stockholm+50 International Meeting and the World Environment Day 2022.<sup>1</sup>

At its 159<sup>th</sup> meeting on 29 September 2022, the Committee considered the implementation of the following UNEA resolutions:

- 5/2 entitled "Sustainable Nitrogen Management"
- 5/3 entitled "Future of the Global Environment Outlook"
- 5/5 entitled "Nature-based Solutions for supporting sustainable development".<sup>2</sup>

At its 160<sup>th</sup> meeting on 8 December 2022, the Committee adopted the Chair's summary of the 9<sup>th</sup> meeting of the annual subcommittee of the Committee of Permanent Representatives.<sup>3</sup>

At its resumed  $160^{th}$  meeting on 12 January 2023, the Committee considered the implementation of paragraph 41(j) of the Chair's Summary of the 9th annual subcommittee meeting of the Committee.<sup>4</sup>

At its 161<sup>st</sup> meeting on 9 March 2023, the Committee considered the preparations for the sixth session of the United Nations Environment Assembly and continued its consideration of the implementation of paragraph 41(j) of the Chair's Summary of the 9th annual subcommittee meeting of the Committee of Permanent Representatives and consulted on the contribution of the United Nations Environment Assembly to the High-level Political Forum on Sustainable Development.<sup>5</sup>

At its 162<sup>nd</sup> meeting on 16 June 2023, the Committee elected the Chair, three Vice-Chairs and the Rapporteur of the Committee of Permanent Representatives for a two-year term beginning on 1 July 2023 and ending on 30 June 2025.<sup>6</sup>

At its resumed  $162^{nd}$  meeting on 31 October 2023, the Committee considered the financial outlook and funding challenges for UNEP – follow up from the 9<sup>th</sup> annual subcommittee meeting of the Committee and continued its consideration of the implementation of paragraph 41(j) of the Chair's Summary of the 9th annual subcommittee meeting of the Committee.<sup>7</sup>

At its 163<sup>rd</sup> meeting on 31 October 2023, the Committee was briefed on the update on the preparations for UNEA-6.<sup>8</sup>

At its 164<sup>th</sup> meeting on 25 January 2024, the Committee adopted the Chair's summary of the 10<sup>th</sup> annual subcommittee meeting.<sup>9</sup>

At its 165<sup>th</sup> meeting on 25 January 2024, the Committee considered the preparations for the upcoming session of the Environment Assembly.<sup>10</sup>

The Committee has also convened the 9<sup>th</sup> and 10<sup>th</sup> meetings of the annual subcommittee held from 24 to 28 October 2022 and from 20 to 24 November 2023, whereby the Committee, *inter alia*, considered the state of implementation of the Programme of Work and Budget 2022-2023 of UNEP and preparations for the UNEA-6.

At the sixth meeting of the Open-ended Committee of Permanent Representatives, which took place from 19 to 23 February 2024, the Committee agreed on its organization of work; took note of document UNEP/EA.6/13 on the implementation of decision 5/4 of the Environment Assembly on the extension of the programme of work for the period 2022-2023 by two years to the end of 2025, with the budget and targets being pro-rated accordingly; consulted on the administrative and budgetary matters, the contributions of the Environment Assembly to the meetings of the high-level political forum on sustainable development, and the preparation of decisions and outcomes of the UNEA-6.

On 19 February, under the item budget and programme performance, including implementation of previously adopted Assembly resolutions and decisions, the Committee took note of the following working documents:

On 19 February, the Committee decided to recommend that the sixth session of the UN Environment Assembly defer its contributions to the forthcoming meetings of the high-level political forum on sustainable development, held under the auspices of the Economic and Social Council, taking place in New York in 2024 and 2025, to future meetings of the Committee of Permanent Representatives.

On 23 February, the Committee decided to transmit to UNEA for adoption a revised final draft ministerial declaration, as circulated by the President of the sixth session of UNEA to all delegations on 15 February 2024, without prejudice to the rights of Member States to make additional proposals for further consideration.

On 23 February, the Committee also considered 22 draft resolutions and 2 draft decisions, and recommended that UNEA should consider the following draft resolutions and decisions with a view to their possible adoption:
