2. Briefing on the 2023 Annual Report on UNEP's Private Sector Engagement.

The Secretariat will present an overview of UNEP's efforts to partner with the private sector to take action and achieve impact across key industrial sectors, as reflected in the **2023 Annual Report on UNEP's Private Sector Engagement**, covering the reporting period September 2022-August 2023 and highlighting UNEP's monitoring of private sector partnerships. The Committee is invited to take note of the briefing and engage in an exchange of views with Committee Members and the Secretariat.

3. Review of UNEP Thematic Programmes.

Following the Committee's request to ensure early and strategic planning in the performance of its oversight function vis-à-vis the Programme of Work, presentations will be delivered to the subcommittee on all 13 thematic programmes between 18 April and 3 December 2024. Under this item, the Secretariat will present an overview of the two following thematic programmes: **1) "Adaptation and Resilience"**, which aims to integrate emission reduction and climate change adaptation solutions through more effective interactions between science, policy, finance, technology, and the economy; and **2) "Decarbonization"**, which aims to enhance the effectiveness and impact of UNEP's support in reducing greenhouse gas emissions in line with the goals of the Paris Agreement on Climate Change. The Committee is invited to take note of the briefing and engage in an exchange of views with Committee Members and the Secretariat.

The meeting will consider any other matters related to its work.
