		and advocate for a greater level of inclusion, it is crucial that research papers and studies (e.g. on consumer behaviour) include analysis of human rights, gender dimensions and considerations of whom the most vulnerable people are and how they may be reached. - A dedicated outreach and communication strategy is required to ensure reaching of vulnerable groups and people living with a disability etc. In order to ensure enrolment of such target groups in consumer groups, training courses etc., a more direct communication may be needed (e.g. through organizations working with people living with a disability) to ensure that the messages are being communicated to the right people/community.
