- Possible MGS Focus: Provide inputs and ideas to promote the implementation of UNEP's Programme of Work and UNEA resolutions/decisions, sharing successful examples, and suggest possible recommendations.

#### b) Management and Administration of UNEP

- o Overview of budget, human resources, audits, and other administrative matters.
- o Exchange of views with Member States and Stakeholders.

 Possible MGS Focus: Provide input and ideas linked to administrative matters relating to UNEP.

#### • c) Consideration of relevant UNEP evaluation reports

- Consideration of evaluations completed, including the Biennial Evaluation Synthesis Report 2022-2023, and the management response from the UNEP Secretariat.
- Possible MGS Focus: Provide inputs and ideas relating to UNEP's evaluation reports.

# d) Coordination within the UN System on the environment through the Environment Management Group

- Consideration of UN system-wide Common Approaches to integrate environmental considerations in the programmes and operations of the UN entities.
- Possible MGS Focus: Provide inputs and ideas to promote the integration of environmental considerations across UN entities.

## e) Contribution of Regional Forums to the UNEP Medium-term Strategy and Programme of Work

- Consideration of the role of regional forums of ministers of environment and environment authorities and UNEP regional offices in achieving multilateral cooperation.
