Agenda item 3 (a): Review of UNEP Programme of Work implementation.

- My delegation applauds UNEP secretariat for the informative overview of the status of implementation of Program of Work and budget (PoW) 2022-2023. PoW highlights strategic objective and their linkage with UNEA resolutions and decisions in addressing triple planetary crisis (Climate Change, Biodiversity loss and Pollution) including the support provided to countries in tackling these challenges.
- We also appreciate the support provided by UNEP in addressing marine pollution through implementation of small-scale funding agreement on protecting the marine environment from land based pollution in the United Republic of Tanzania. The program among others aimed to

strengthen global action on tackling marine pollution through development of Marine Litter Action Plan in the United Republic of Tanzania.

- Mr. chair let me take this opportunity to inform that, Tanzania has achieved the milestone in addressing triple planetary crisis. This has been revealed through implementation of Nationally Determined Contribution; review of National Biodiversity Strategy and Action Plan (NBSAP); formulating National Blue Economy Policy, formulating carbon trade regulations and guidelines that facilitated enrichment of Carbon market in the country; formulating a National Clean cooking Energy Strategy which aims to reduce overdependence of forest biomass, reduce human health risks and prevent land and forest degradation.
- My delegation calls upon more effort to be taken by UNEP in terms of capacity building and technical support in implementation of priority projects and programs to address marine pollution, Blue Economy, Clean cooking, Marine spatial planning; and Carbon trade; as key areas of priority. This support will facilitate country's efforts for effectively addressing triple planetary crisis.
