### Mr. Chair,

Regarding the review of UNEP Programme of Work implementation, we appreciate progress that has been on the implementation of the said work programmes. Our delegation also looks forward to actualization of the proposals made from the meeting on the Drafting of the Roadmap for the Development of the UNEP Medium-Term Strategy 2026-2029 and Programme of Work for 2026-2027.

#### Mr. Chair,

Zambia will continue to play its role in ensuring strengthened implementation of the activities as agreed by all parties through various decisions and resolutions including those espoused in the UNEP's work programme. We at country level will also continue to aligns ourselves with the agenda 2030 for sustainable development, its sustainable development goals and with the United Nations General Assembly Resolutions to ensure environmental sustainability.

In this regard, **Mr. Chair,** we have since formulated national plans that prioritises implementation of medium to long term adaptation measures in order to address the adaverse impact of climate change and ensure attainment of country's climate resilience.

We are also implementing the land degradation neutrality plan (2015-2030), the national action plan on combating desertification, the investment framework for sustainable land management and the great green wall action plan all aimed at addressing land degradation across the country.

#### Mr. Chair,

Considering the significance of financial resources as a means of implementing UNEPs program of work and medium-term strategy, Zambia wishes to join other delegations in expressing its gratitude to all the contributors and funding partners.

We support the call for the next MTS to retain the three thematic areas of actions that include climate change, biodiversity and pollution control and underscore the need to build on the gains made this far rather than open new areas of work.

Further, we reiterate the call for the consultations with the regional ministerial groups to be at the center of the development of the next MTS as we believe the platforms are the strategic platform to inform the future strategy.

# Mr. Chair,

Zambia is of the view that the theme for the UNEA should be anchored on the gains of the past UNEA decisions. UNEA 7 should be themed around emphasizing the need for urgent actions to build resilience considering the impacts of the triple planetary crisis. In addition, the theme should support the final collaborative thrust in the implementation of actions towards achieving the SDGs.

Zambia stand ready to continue supporting your leadership and wish to assure you of our full cooperation as we engage in the future processes.
