> Complementary Statistical Information

For reasons of economy, this document is printed in a limited number. Delegates are kindly requested to bring their copies to meetings and not to request additional copies.

A biennial questionnaire sent to about 160+ UN member states (all UN member states except OECD and Eurostat members/candidates and potential members/candidates): The UNSD/UNEP Questionnaire on Environment Statistics (water and waste sections. It collects data at the national level on volumes of waste measured in 1000s of tonnes. Variables collected include: "municipal solid waste (MSW) generated"; "MSW collected"; "MSW treated"; "MSW composted"; "MSW recycled"; "MSW landfilled"; "MSW in controlled landfilling"; "MSW incinerated"; "MSW incinerated with energy recovery", etc. Furthermore, data is collected on the % composition of MSW by several variables ("Paper, paperboard"; "Textiles"; "Plastics"; "Glass"; "Metals"; "Other Inorganic Material"; "Organic material"). Data on other types of wase (e.g. hazardous waste, e-waste, food waste) are also collected. I can speak about this at the EG as relevant. The waste section of the Questionnaire is
