Dear Minister,

I wish to thank you for your continuous support towards the implementation of <u>UNEA resolution 5/8</u> entitled "Science-policy panel to contribute further to the sound management of chemicals and waste and to prevent pollution".

Using this opportunity, I would like to bring to your attention that as per the resolution an ad hoc open-ended working group was established to prepare proposals for the science-policy panel. In this regard, paragraph 10 of the resolution additionally requested the Executive Director "...upon completion of proposals prepared by the ad hoc open-ended working group, to convene an Intergovernmental meeting for the purpose of considering the establishment of a science-policy panel."

On 21 June 2024, the working group agreed to hold a resumed 3<sup>rd</sup> session of the ad hoc open-ended working group (OEWG 3.2) back-to-back with the Intergovernmental meeting, with the intention to finalize the proposals and establish the science-policy panel. The exact dates and venue for these upcoming meetings are to be confirmed.

Therefore, the United Nations Environment Programme (UNEP) is seeking financial resources to support the ongoing intergovernmental processes. The required funds are intended for the planning and preparation of the above-mentioned meetings. UNEP is seeking the support of governments to provide extra-budgetary resources to advance the implementation of UNEA resolution 5/8. In line with the request, a budget breakdown for the continued operations of the secretariat, from the first part of the third session of the ad hoc open-ended working group (OEWG 3.1) to the back-to-back convening of OEWG 3.2, and the Intergovernmental meeting, is annexed to this letter.
