# Why civil society engagement?

- Rule 70 of UNEA Rules of Procedure
- UN practice as also outlined in "The Future We Want" and Governing Council Decision 27/2
- Civil Society and stakeholder expertise enriches the inter-governmental decisionmaking processes without questioning the intergovernmental nature of UNEP
- Adds transparency and legitimacy to the work of UNEP
- Gives an opportunity for those who might be affected by decisions to raise their concerns but also make constructive suggestions.




## How does civil society engage?

- Nine Major Groups and Stakeholders
- Formal accreditation as a condition for participation
- In UNEA and CPR as observer with opportunity to provide oral and written statements
- Access to CPR portal including to un-edited working documents and submission of written inputs
- Global Major Groups and Stakeholders Forum (GMGSF) prior to the UN Environment Assembly as well as Youth Environment Assembly (YEA)
- Regional Consultative Meetings (RCMs) often back-to-back with Regional Ministerial
  Fora
- Major Groups Facilitating Committee, including Regional Facilitators (MGFC)




## Three levels of engagement



### **Agenda-setting**


- Policy shaping

## Decisionmaking/shaping

- Policy deliberations leading to decision-making
- Transparency and accessto-information

**Expert input and advice**

- Strategic partnerships for implementation of UNEP's policies
- Strategic partnerships for achieving sustainable development



# Civil Society at meetings of the Committee of Permanent Representatives

- Accredited organizations may participate and make statements at all CPR meetings, including sub-committees
- Reserved seats for the nine Major Groups
- Online participation possible
- Opportunity to provide written and oral comments
- Accredited organizations have access to all relevant documentation and access to portals



# Role of the Civil Society Unit in the Governance Affairs Office

- Administers accreditation of non-governmental observers to UNEA/CPR
- Runs the UNEP <u>Civil Society Engagement Website</u>
- Facilitates and organizes meetings, consultations, training, outreach
- Maintains the **Stakeholder Engagement Handbook** as a guiding tool
- Assists the <u>Major Groups Facilitating Committee</u>
- Facilitates <u>Global Major Groups and Stakeholders</u> Forum and <u>Regional</u> <u>Consultative Meetings</u> and the UNEA <u>Multi-Stakeholder Dialogue</u>
- Supports MGS engagement across UNEP, such as in the process to establish a Science-policy panel on Chemicals, Waste and Pollution Prevention
- Administers the dissemination of the <u>"Perspectives"</u> publication, with inputs from civil society



# Recent and upcoming meetings/events

- 10th special session of AMCEN, **3-6 September** in Abidjan, Cote d'Ivoire focusing on Desertification and Land Degradation (RCM on 1-2 September)
- UNEP supporting 7 MGS representatives to the Summit of the Future, 21-22
  September
- Major groups and stakeholders participated in INC 4. Similar interest is expected for <u>INC 5</u> scheduled to take place 25 Nov – 1 Dec in Busan, South Korea
- Global Environment Outlook 7 MGS are participating in dialogues and chapter-writing



OECPR: Open ended meeting of the Committee of Permanent Representatives

GMGSF: Global Major Groups and Stakeholders Forum

MSD: Multi Stakeholders Dialogue

AWF: African Animal Welfare Conference

INC: Ad hoc open-ended working group to prepare for the Intergovernmental Negotiating Committee to develop an international legally binding instrument on plastic pollution



## Accreditation

#### **Accreditation criteria:**

- Registered with a Government for at least
  2 years
- Non-governmental, non-profit
- Focus on environment
- With environmental work locally and internationally

### Number of accredited organizations:

1182 as of 15 August 2024. List can be found <a href="here">here</a>

### Regional distribution as of 15 August 2024:

- Africa: 22%


- Asia and the Pacific: 16%

- West Asia: 3%






# Accreditation (cont')

## Distribution by Major Groups as of 15 August 2024:

- Non-Governmental Organizations (NGO): 74%
- Business and Industry: 9%
- Scientific and Technological Communities:7%
- Women: 2%
- Children and Youth: 4%
- Workers and Trade Unions: 1%
- Local Authorities: 1%
- Farmers: 1%
- Indigenous Peoples and their Communities: 1%
