**1. Opening of the meeting and adoption of the agenda.**

**2. Briefing on the development of the seventh Global Environment Outlook Summary for Policy Makers.**

The Secretariat will provide an update on the status of the production of the seventh edition of the [Global Environment Outlook \(GEO-7\)](#), including on the Second Order Draft of the main report, the First Order Draft of its Summary for Policy Makers, and the on-going intergovernmental and expert peer review process taking place from 1 November 2024 until 15 January 2025. The Secretariat will also provide an overview of the 2025 timeline for the production of GEO-7. The Committee is invited to take note of the briefing and engage in an exchange of views with the Committee Members and the Secretariat.

**3. Development of a medium-term strategy for the period 2026-2029 and a draft programme of work and budget for the period 2026-2027.**

In preparation for the discussions expecting to take place under item 5 of the agenda of the 168<sup>th</sup> quarterly meeting of the Committee to be held on 17 December 2024, the Secretariat will provide an update on the ongoing work for the development of a medium-term strategy for the period 2026-2029 and a draft Programme of Work and budget for the period 2026-2027. This will include an update on the roadmap, a synthesis of themes that emerged from the informal dialogues held in October 2024 with Member States as well as a presentation of the budget options paper for the draft programme of work and budget for the period 2026-2027. The Committee is invited to take note of the briefing and engage in an exchange of views with the Committee Members and the Secretariat.
