Opening of the meeting by the President of the UN Environment Assembly (UNEA) and by the Chair of the Committee of Permanent Representatives (CPR), and adoption of the agenda.

**2. Consideration of a theme of the seventh session of the UN Environment Assembly**

The President of UNEA will brief the two Bureaux on the status of the consultations on the theme for the seventh session of UNEA and present a final streamlined proposal and final background document, followed by an exchange of views with the members of the UNEA and CPR Bureaux.

Members of the UNEA Bureau will consider the President's final proposal for the UNEA-7 theme with a view to defining a theme.

**3. Discussion on the roadmap for the consultations on the draft Ministerial Declaration of the seventh session of the UN Environment Assembly**

The President of UNEA will present a roadmap for the consultations on the draft Ministerial Declaration of the seventh session of UNEA, followed by an exchange of views with the members of the two Bureaux.

**4. Contributions of the UN Environment Assembly to the high-level political forum on sustainable development**

In accordance with paragraph 3 of UNEA [resolution 3/3](#) and [decision 6/5](#), in which the Assembly requested the CPR to consider a written contribution to the meeting of the high-level political forum on sustainable development to be held in 2024 and 2025, the Secretariat will present a background document for the preparation of UNEA's contributions to the HLPF to be held in 2025, 2026 and 2027, followed by an exchange of views with the members of the UNEA and CPR Bureaux.

**5. Organization of work**

Members of the two Bureaux will be invited to consider the organization of work of the two Bureaux based on the 2025 draft roadmap for the UN Environment Programme Governing Bodies.
