Compte tenu de l'importance de ce projet, nous avons déjà signé des partenariats avec le CIAPOL (Centre Anti-pollution) du Ministère de l'Environnement et du Développement Durable ainsi qu'avec la Direction du Suivi Minier. Conscients des dangers de cette pratique, nous avons développé une initiative visant à sensibiliser les communautés minières et rurales, à promouvoir des techniques d'extraction sans mercure et à renforcer les capacités de développement de cultures.

Au vu des impacts négatifs de cette activité sur les eaux, les sols et la santé, nous croyons fermement que ce partenariat avec le PNUE pourrait grandement renforcer l'efficacité de notre initiative, grâce à une expertise combinée. Nous serions honorés de pouvoir discuter de cette collaboration à votre convenance.

We are a youth organization dedicated to environmental protection, sustainable development, and gender promotion in rural areas. In this context, we seek a partnership with UNEP for our project aimed at reducing, or even eliminating, the use of mercury in illegal artisanal mining (illegal gold mining) and protecting the lands and waters in Côte d'Ivoire.

Mercury is commonly used in artisanal gold extraction in Côte d'Ivoire, and it is unfortunate to see that this practice is widespread throughout the country—from the West to the East, and from the South to the North, including the central region. We have conducted initial field studies to understand and highlight the socio-economic, developmental, and environmental impacts of this issue.

Given the importance of this project, we have already formed partnerships with the CIAPOL (Anti-Pollution Center) of the Ministry of Environment and Sustainable Development, as well as with the Directorate of Mining Monitoring.
