My name is Fernanda Venzon. I am an attorney and the Executive Director of the Environmental Defender Law Center (EDLC). I am writing to express our organization's interest in joining UNEP's Global Mercury Partnership.

EDLC is a non-profit organization that works globally with local communities supporting their efforts to protect the environment and defend their rights, especially the right to live in a clean and healthy environment, free from contaminants.

For several years EDLC had been supporting the Grassy Narrows case in Canada.

In another case, EDLC is collaborating with the inhabitants of Huancavelica and Sacsamarca, in the Peruvian Andes, in their efforts to live in an environment that is free from mercury and other pollutants. It is estimated that 19,000 people in these towns live in homes made of mud bricks that emanate mercury. The city was built around a mercury and precious metals mine in which the soil has been contaminated since colonial times. Less than a year ago, though, the community obtained a favorable ruling that orders the Peruvian government to remediate the sites and include them as a priority action under its plans for the implementation of the Minamata Convention. EDLC is interested in collaborating with the Peruvian government in creating and implementing a plan to remediate these contaminated sites.

Additionally, EDLC is planning a webinar and creating educational materials on mercury contamination and human rights with the view of organizing workshops for local communities affected by mercury contamination in the Global South.

We would very much welcome the opportunity to join the Partnership.
