Introduction

The Fourth Ordinary meeting of the Contracting Parties to the Convention for the protection of the Mediterrenaen Sea against pollution convened in Genoa, 9-13 September 1985, decided to convene the present meeting in Athens from 7 to 11 September 1987.

The following annotations to the proposed agenda for the meeting were prepared by the secretariat to assist the meeting in its deliberations. The opening session will be preceded by informal consultation of Heads of delegations on Monday, 7 September 1987 at 09.00 hours at Zappeion Conference Centre, Athens.

Agenda Item 1. Opening of the meeting

The meeting will be opened at 10.00 hours on Monday, 7 September 1987, at Zappeion Conference Centre by the President elected by the Fourth Ordinary Meeting of the Contracting Parties. The Minister of Environment of Greece will welcome the participants. The Executive Director of UNEP will deliver an opening statement.

Agenda item 2. Rules of procedure

The rules of procedure adopted for meetings and conferences of the Contracting Parties to the Convention for the protection of the Mediterranean Sea against pollution and its related protocols will apply for the meeting (UNEP/IG.43/6, Annex XI).

Agenda item 3. Election of officers

In accordance with Rule 20, the meeting shall elect from among the representatives of the Contracting Parties a President, two Vice-Presidents and a Rapporteur, who shall remain in office until their successors are elected at the next ordinary meeting and shall serve in that capacity at any intervening extraordinary meetings.

Agenda item 4. Adoption of the agenda

The provisional agenda prepared by the Executive Director in agreement with the Bureau (Rule 10) has been distributed as UNEP/IG.74/1.

Agenda item 5. Organization of work

It is proposed to establish under Rule 24 a Committee of the whole open to all delegations to consider agenda items 9 and 10 as indicated in the suggested time-table appearing as an annex to this document.

In line with past practice the meeting is expected to designate one of its Vice-Presidents to chair the Committee of the whole. The Committee should elect at its first sitting a Vice-Chairman and a Rapporteur. The remaining agenda items will be considered in plenary. In accordance with Rule 9 plenary sittings shall be held in public and Committee sittings shall be held in private, unless the meeting decides otherwise.

Agenda item 6. Credentials of representatives

Each Contracting Party shall be represented by an accredited representative, who may be accompanied by such alternates and advisers as may be required (Rule 18). The credentials of the representatives and the names of the alternate representatives should be submitted to the Executive Director before the opening sitting. In accordance with Rule 19, the Bureau shall examine the credentials of representatives and submit its report to the meeting.

Agenda item 7. Report of the Executive Director on the implementation of the Action Plan and of the Genoa Declaration in 1986-1987 and recommendations for activities to be undertaken in 1988-1989 biennium with related budget proposals

The meeting will have before it document UNEP/IG.74/3. The report will be presented by the secretariat. The meeting will be invited to provide general comments on the report. The report will be considered in detail under the corresponding agenda items, and recommendations adopted in plenary or by the Committee of the whole for the items assigned to it.

The secretariat will introduce the information on the implementation of the Genoa Declaration (UNEP/IG.74/3, section I). The meeting will be invited to consider the secretariat's suggestions for reporting on the implementation. The meeting will have before it the document on Proposed 100 Coastal Historic Sites of Common Interest (UNEP/IG.74/4), with a view of its adoption. The meeting will also have before it the Programme Calendar 1986-1995, as reviewed by the Bureau and incorporating changes suggested by the Contracting Parties (UNEP/IG.74/Inf.7). The meeting will be asked to adopt the Programme Calendar.

Agenda item 8. Framework convention and related protocols with their technical annexes for the protection of the Mediterranean environment

Agenda item 8(a) Implementation of the Convention for the Protection of the Mediterranean Sea against Pollution

The meeting will be expected to consider those articles of the Convention that have been insufficiently acted upon (UNEP/IG.74/3, section II(a)).

The meeting will have as information documents UNEP/IG.74/Inf.5, UNEP/WG.155/1 and UNEP/WG.175/1.

The meeting will be invited to consider the recommendations contained in UNEP/IG.74/3, section II(a), with a view to their approval.

Agenda item 8(b) Implementation of the Protocol for the Prevention of Pollution of the Mediterranean Sea by Dumping from Ships and Aircraft

The report on the implementation of the above protocol was reviewed by the meetings of the Working Group for Scientific and Technical Cooperation for MED POL and it will be considered under agenda item 10(c).

Agenda item 8(c) Implementation of the Protocol concerning Cooperation in Combating Pollution of the Mediterranean Sea by Oil and Other Harmful Substances in Cases of Emergency

The report on the implementation of the emergency protocol was reviewed by the meetings of the Working Group on Scientific and Technical Cooperation for MED POL, which decided to recommend to the present meeting that in the future technical matters related to oil pollution abatement within the framework of the emergency protocol would not be referred to WGSTC. Such matters should be considered and discussed by the ROCC National Focal Points meeting (UNEP/IG. 74/3, section II(c)).

As an information the meeting will have before it the Report on Alerts and Accidents (UNEP/IG.74/Inf.3).

The meeting will be invited to consider the recommendations contained in UNEP/IG.74/3, section II(c), with a view to their approval.

Agenda item 8(d) Implementation of the Protocol for the Protection of the Mediterranean Sea against Pollution from Land-based Sources

Progress report on the general implementation of the protocol is presented in section II(d) of UNEP/IG.74/3 and it will be discussed under this agenda item.

Progress report on the technical/scientific implementation of the protocol is presented in section IV(c) of UNEP/IG.74/3 and it will be discussed under agenda item 10(c).

The meeting will have as information document reports of the Fourth and Fifth Working Group meetings (UNEP/WG.144/13 and UNEP/WG.160/13).

The meeting will be invited to consider under this agenda item the recommendations contained in section II(d) of UNEP/IG.74/3, with a view to their approval.

Agenda item 8(e) Implementation of the Protocol concerning Mediterranean Specially Protected Areas

Progress report on the implementation of the protocol is presented in section II(e) of UNEP/IG.74/3. Progress report on scientific/technical implementation of the protocol is presented in section III(c) of UNEP/IG.74/3.

The meeting will have as information document the report of the meeting of National Focal Points (UNEP/WG.163/9).

The meeting will be invited to consider under this agenda item the recommendations contained in section II(e) of UNEP/IG.74/3, with a view to their approval.

Agenda item 8(f) Other legal matters

Information on other legal matters, which includes proposal for further development of the legal and policy components, is contained in section II(f) of UNEP/IG.74/3.

The meeting will have before it the Information Document on Interstate Guarantee Fund (UNEP/IG.74/Inf.6).

The meeting will be invited to consider recommendations contained in section II(f) of UNEP/IG.74/3, with a view to their approval.

Agenda item 9. Integrated planning of the development and management of the resources of the Mediterranean Basin

Agenda item 9(a) Blue Plan (BP)

The meeting will have as information documents reports of the Fourth and Fifth meetings of the Working Group for Scientific and Technical cooperation for MED POL (UNEP/WG.144/13 and UNEP/WG.160/13) as well as documents on assessments of the state of pollution in the Mediterranean Sea by mercury and mercury compounds (UNEP/WG.160/8), microbial pollution of shellfish waters (UNEP/WG.160/10) and petroleum hydrocarbons (UNEP/WG.160/11).

The meeting will be invited to consider recommendations contained in section IV(d) of UNEP/IG.74/3, including measures to prevent pollution by mercury and environmental quality criteria for shellfish waters, and proposed budget for 1988-1989 contained in Annex IV of UNEP/IG. 74/3.

Agenda item 11(c) Regional Oil Combating Centre (ROCC)

The meeting will be invited to consider the proposed programme for 1988-1989 with their related budget contained in UNEP/IG.74/3, section V(d) and Annex IV, with a view to their approval.

Financial aspects

The meeting will be invited to take note of the status of the MTF contained in UNEP/IG.74/3, section V(e) and Annexes II and III.

Concerning the alternative methods of calculating contributions to the Mediterranean Trust Fund, the meeting will have before it the reports of the Bureau of the Contracting Parties (UNEP/BUR/26,27,28 and 29), as well as the report of the Meeting of Experts on the Contribution to the MTF, held in Madrid, Spain, 19-22 June 1987, contained in UNEP/IG. 74/Inf.11.

The meeting will be invited to consider and review the question with a View to take decision on the recommendations contained in UNEP/IG.74/3, section V(e).

Agenda item 11(f) Adoption of budget and pledges for the 1988-1989 biennium

The meeting will be invited to consider the proposed budget for 1988-1989 contained in document UNEP/IG.74/3, Annex IV, the cash flow (Annex V) and the apportionment of contributions (Annex VI), with a view to their approval.

Agenda item 12. Date and place of the 6th Ordinary Meeting of the Contracting Parties

The meeting will be invited to consider the secretariat's proposal to convene the 6th Ordinary Meeting of the Contracting Parties in Athens, Greece, from 2 to 5 October 1989.
