Introduction

- 1. Following the recommendations of the Launch Meeting on the External Evaluation of MAP, held in Athens on 910 December 2004, a first draft of the evaluation report is being prepared by the team of evaluators. A consultative meeting with all Contracting parties has also been proposed to address the priority topics highlighted under the process of the evaluation and a set of preliminary recommendations.
- 2. The following annotations to the provisional agenda for the Consultative meeting were prepared by the Secretariat to assist the meeting in its deliberations.

Agenda item 1: Opening of the meeting

3. The meeting will be opened at 09:30 hrs on Thursday, 31 March 2005, by the MAP Coordinator. Due to the consultative nature of the meeting, it is proposed that the meeting will be chaired by the MAP Coordinator.

- 8. Due to the consultative nature of the meeting, the Secretariat will not submit either a report or a set of recommendations for adoption by the meeting. The leader of the team of evaluators will wrap up the main findings and recommendations of the meeting.
