The Eighteenth Ordinary Meeting of the Contracting Parties (Istanbul, December 2013), by its Decision IG. 21/1, amended Section V of Decision IG. 17/2 on the Procedures and mechanisms on compliance with a new Article 23 bis, which recognizes an initiative power to the Compliance Committee. Under this new competence, the Committee may consider, on the basis of biennial Reports of activity and/or in the light of other relevant sources of information, the difficulties encountered by a Contracting Party in the application of the Convention and its related Protocols and may request the Party concerned to provide further information, on the basis of which it may consider to take measures with a view to promoting compliance and addressing cases of non-compliance.
- 17. The Chairperson of the Compliance Committee also referring to the results of Agenda Items 5 and 6, as well as of the Informal Session may wish to invite its members to assess the best conditions to implement its prerogative of initiative in coordination with that of the Secretariat pursuant of article 23 of Decision IG. 17/2.
