Introduction

1. At their 13th meeting, held in Catania on 11-14 November 2003, the CPs requested the Secretariat to undertake an external evaluation of MAP, emphasizing also some criteria and the main principles for such an evaluation. With a view to conducting a transparent and a fully participative approach, the Secretariat is organizing a meeting to launch the evaluation process where all CPs can take an active part in the discussion. In particular, participants will be invited to discuss and make recommendations on the methodology, approach and activities to be carried out as part of the evaluation, based on the proposal contained in document UNEP(DEC)/MED WG.261/3 prepared by the consultants and the Secretariat.

In order to facilitate the discussion and ensure that the meeting will address the various aspects of the evaluation process, participants may wish to establish two or three Working Groups, each chaired by a member of the evaluation team or one of the participants elected for this purpose.

- 2. The conclusion of the Working Groups will be discussed in plenary in the second day of the meeting when a set of recommendations will be formulated in order to guide the evaluation process and the task of the evaluation team.
- 3. The following annotations to the provisional agenda for the meeting were prepared by the Secretariat to assist the meeting in its deliberations.

Agenda item 1: Opening of the meeting

4. The meeting will be opened at 10.00 hrs on Thursday 9 December 2004, at the Holiday Inn Hotel, 50 Michalakopoulou Avenue, 11528 Athens, Greece (Tel: 30-210-7278000, Fax: 30-210-7278600), by the Coordinator of the Mediterranean Action Plan (MAP). Simultaneous interpretation in English and French will be available for all sessions.

Agenda item 4: External evaluation of the Mediterranean Action Plan (MAP)

- 9. The Secretariat will introduce the main document of the meeting distributed as document UNEP(DEC)/MED WG.261/3. The discussions will be facilitated by the members of the evaluation team of MAP.
- 10. The meeting is expected to undertake a thorough discussion, in plenary and/or in working groups, by addressing all points contained in the working document and any other issue that participants would consider pertinent, and provide the Secretariat and the evaluation team with recommendations and further guidance.

11. The meeting will consider any other issue that might be raised.

- 12. The Secretariat will submit for adoption at the meeting a set of recommendations arising from the discussions.
- 13. The draft report of the meeting will be circulated by the Secretariat and is expected to be adopted at a later stage by correspondence.
