# REGIONAL CONSULTATIVE MEETING OF THE MAJOR GROUPS AND STAKEHOLDERS IN LATIN AMERICA AND THE CARIBBEAN 2015

#### 7 May 2015. Country Inn & Suites Panama Canal, Panama City, Panama

#### **Objectives**

- To prepare the contributions of representatives of major groups and stakeholders in the region to global processes such as discussion of the post-2015 agenda and climate change.
- To identify opportunities to enhance the participation of major groups and stakeholders in policy-making processes at different levels.
- To foster dialogue and knowledge sharing between major groups and stakeholders in the region.

#### Meeting methodology

- 1. The opening session will be chaired by the chair of the last meeting. During this session, a vote will be taken to elect the chair of the meeting. The functions of the chair are to call the meeting to order, to assign the floor, and to monitor adherence to the agenda.
- 2. A rapporteur will also be elected, and will be responsible for the minutes. For the preparation of the minutes, each working group will elect a rapporteur who will prepare the elements to be included in the final report of the meeting.
- 3. The meeting will encompass four sessions.
  - a. The first is the opening session.
  - b. The next two include a plenary session at which an introduction to the topics will be made, followed by working group discussions to prepare specific recommendations. Each group will have a moderator to facilitate discussions and a rapporteur who will take notes for the meeting report. The rapporteur will also present to the plenary the contributions to be included in the final statement.
  - c. The fourth session is a plenary session at which the recommendations of the meeting will be discussed. In addition, a summary of the meeting will be presented, regional representatives will be elected, and closing remarks will be made.

To facilitate discussion, a series of informational documents will be made available to the participants through the website of the UNEP Regional Office for Latin America and the Caribbean.
