#### Introduction

- 1. In accordance with the UNEP/MAP Programme of Work 2016-2017 adopted by COP 19, Athens, Greece, 9-12 February 2016, the Secretariat is organizing the Regional Meeting of Experts to review the Draft Desalination and Dumping Protocol Guidelines from 4 to 6 April 2017 in Greece.

    - a) to review the proposed draft updated Desalination Guidelines
    - b) to review the proposed draft updated Guidelines under the Dumping Protocol of the Barcelona Convention related to Dredged Materials and Artificial Reefs.
    - c) to undertake a discussion on the status of implementation of the Dumping Protocol by the Contracting Parties and issues at stake

The meeting is expected to provide feedback and inputs on the follow up of these discussions with the view to have both assessment reports completed by the MED POL and MAP Focal Points meetings as well as on the need to undertake a policy discussion at the MED POL Focal Points meeting on new possible approaches to address dumping of dredged materials in the Mediterranean.
