Introduction

- 1. The objectives of the meeting of the MAP Focal Points are to review the progress achieved during the 2016-2017 biennium in the implementation of the programme of work and of the activities approved by the 19th Meeting of the Contracting Parties (COP 19, Athens, Greece, 9-12 February 2016); and to approve a number of draft decisions, including the proposed biannual Programme of Work (PoW) and Budget 2018-2019, prepared by the Secretariat for submission to the 20th Meeting of the Contracting Parties (COP 20) (Tirana, Albania, 17-20 December 2017), aiming at strengthening the implementation of the Barcelona Convention and its Protocols.
- 2. The following annotations to the proposed provisional agenda have been prepared by the Secretariat to assist the meeting in its deliberations.

As per practice, pre-session documentation will not be distributed on paper. Participants are encouraged to download the documentation on their computers in advance of the session.

- 9. Sessions are scheduled every day from 09:30-12:30 and 14:30-17:30. The morning of the last day of the meeting will be allocated for the preparation of the Report of the Meeting and the afternoon session will take place between 14:30 and 17:30.
- 10. It is expected that the MAP Focal Points will address all items of the Agenda during their four-day meeting. It is envisaged to close the meeting at 17:30 on 15 September 2017 after adopting its draft Report.
