Introduction

1. At the invitation of the UN Environment/Mediterranean Action Plan (MAP), on the 6th September 2016, representatives of 19 organizations¹ from across the Mediterranean Sea, being actively involved on several aspects of marine litter management and assessment, were gathered together in Athens, Greece to participate on a round table discussion entitled "Enhancing Regional Coordination on Marine Litter in the Mediterranean". The round table aimed at initiating a discussion on the establishment of a partnership for the implementation of the Regional Plan on Marine Litter Management in the Mediterranean.

2. The main outcome of the round table discussion was the establishment of the Regional Cooperation Platform on Marine Litter in the Mediterranean, which is instrumental in providing coordinated support and guidance to the implementation of the Regional Plan on Marine Litter Management in the Mediterranean, and a forum for consultation, exchange of good practices, and solutions seeking.

3. The Regional Cooperation Platform on Marine Litter in the Mediterranean is implemented through the establishment, on a voluntary basis, of an open ended group of regional and international partners with mandates and activities contributing to the environmentally sound management of marine litter in the Mediterranean. The cooperation platform offers to its members the opportunity to provide, on an equal footing and as appropriate, concrete contributions and inputs for the implementation of the Regional Plan based on their individual mandates, expertise, work plans, and the decisions and recommendations of their respective governing bodies.

4. The members of the Regional Cooperation Platform on Marine Litter agreed on a joint work plan focusing on the following priorities:

- a. Review/update of the list of the existing guidelines related to marine litter management;
- b. Marine litter monitoring and data collection including related information system;
- c. Capacity Building, Awareness, Educational and Clean up Campaigns; and
- d. Identification of priority research needs with a focus on implementation of measures.
- 5. To this extent, the following activities were agreed: :
 - a. Review and complete the list of existing guidelines on marine litter management provided under the UNEP(DEPI)/MED WG.425/Inf.4 information document and identify the needs for updated and or developing new ones. It has been also agreed to finalize this document by end of September in order to be in a good position to assess together where we stand and what are the needs of the region for new or updated technical marine litter guidelines.
 - b. Support the implementation of marine litter monitoring programmes with a particular focus on regional, sub-regional related activities and corresponding information systems/databases/research needs.
 - c. Promote among respective networks the UNEP/GPA on-line course on marine litter to be available in January-May 2017.
 - d. Work together to ensure large regional/international participation of our networks in a common clean-up campaign in 2017 (exact date and event to be jointly selected among the partners).

6. In 2017, additional organizations expressed their interest to participate and to become member to the platform, such as: Secretariat for the Union for the Mediterranean, Institut Français de Recherche pour l'Exploitation de la Mer (IFREMER), Consiglio Nazionale delle Ricerche (CNR), Foundation Euro-Mediterranean Centre on Climate Change (CMCC).

Progress Achieved in Extroverting the Platform

7. The UN Environment/MAP during the first year of operation of the Regional Cooperation Platform on Marine Litter, focused its work on communicating, disseminating and spreading the word on the Regional Cooperation Platform in order to increase visibility to the platform and maximize its effect. Moreover, the Secretariat has worked in developing and improving the assessment of marine litter and its impacts at regional level.

8. Within the framework of the 2017 Italian Presidency of the G7, the Italian Ministry for the Environment, Land and Sea organized a workshop (Rome, Italy, 20-21 April 2017) in collaboration with UN Environment/Mediterranean Action Plan (MAP) with the aim of identifying possible way of "Mainstreaming the work of the Regional Seas Programmes towards the better implementation of the G7 Action Plan and the achievement of global commitments on marine litter".

9. The UN Environment/MAP prepared a background document to provide a global overview of the marine litter issue; and review and analyze the basic elements of the G7 Action Plan in parallel with the current related activities of the Regional Seas Programmes. It aimed at offering a discussion platform on how the current work undertaken by the Regional Seas Programmes could be considered as a practice/model to further implement the G7 Action Plan to Combat Marine Litter.

10. The Mediterranean case was presented in the aforementioned background document as an exemplar model and the Regional Cooperation Platform on Marine Litter in the Mediterranean was showcased as a good example of regional cooperation to maximize results and enhance the impact on marine litter management.

11. The G20 organized a high level conference on Marine Litter in Bremen, Germany (30 May – 01 June 2017), where the G20 Action Plan on Marine Litter was agreed. The UN Environment/MAP Barcelona Convention Secretariat Coordinator, addressed to the delegates of the conference a key-note intervention where the Regional Cooperation Platform on Marine Litter in the Mediterranean was brought to the attention of the participants.

12. In the middle of the year 2017 (5-9 June 2017), UN organized the high-level "The Ocean Conference", Our Oceans Our Future: Partnership for the Implementation of the Sustainable Development Goal 14, in UN headquarters in New York. The Ocean Conference aimed at supporting the implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development. In this sense, UN Environment/MAP was asked to prepare a number of concept papers; one of them addressing marine pollution.

13. The Cooperation Platform on Marine Litter in the Mediterranean, has been included in the concept paper (Partnership Dialogue 1: Addressing Marine Pollution), as a good example to build on existing partnerships at regional level. 14. UN Environment/MAP Barcelona Convention Secretariat also participated in the 2017 "Our Ocean" Conference (Malta, 5-6 October 2017), where important commitments were made, many of

which addressing marine pollution and particularly marine litter (<u>https://ourocean2017.org/our-ocean-commitments</u>).

15. The platform has been also brought to the attention of the Contracting Parties to the Barcelona Convention, during several UN Environment/MAP meetings:

- a. Meeting of the Ecosystem Approach Correspondence Group on Marine Litter Monitoring (Madrid, Spain, 28 Feb. 2 Mar. 2017);
- b. Meeting of the MED POL Focal Points (Rome, Italy, 29 31 May 2017);
- c. 6th Meeting of the Ecosystem Approach (EcAp) Coordination Group (Athens, Greece, 11 September 2017);
- d. Meeting of the Mediterranean Action Plan (MAP) Focal Points (Athens, Greece, 12-15 September 2017);

16. The platform has been also brought to the attention of the EU MSFD Technical Group on Marine Litter (TGML) and to other marine litter oriented fora e.g. μMED Conference (Capri, Italy, Sept. 2017), the UN Environment/GPA Global Partnership on Marine Litter (GPML) Steering Committee meetings etc..

Progress Achieved on Marine Litter at Regional Level

17. Furthermore, the following outputs/goals related to marine litter have been achieved by the UN Environment/MAP:

- a. Approved marine litter metadata templates for beach and seafloor marine litter;
- b. Approved marine litter chapters for IMAP common indicators 22 and 23 for the 2017 Mediterranean Quality Status Report (QSR);
- c. Approved marine litter guidance factsheets for IMAP common indicators 22 and 23, and the candidate indicator 24.

18. The MAP Secretariat updated the list of guidelines on marine litter management, as a response to the need for implementation of prevention measures provided for in the Regional Plan on Marine Litter Management in the Mediterranean (Article 9). The updated list of guidelines on marine litter management can be found in the UNEP(DEPI)/MED WG/446/3.

19. The Programme of Work (PoW) of the UN Environment/MAP for the biennium 2018 - 2019 includes an important number of activities on marine litter aiming at ensuring continuation of the work carried out during the 2016 - 2017 biennium.

20. The EU-funded Marine Litter MED project, implemented and coordinated by UN Environment/MAP covering a period of three years (June 2016 – June 2019) is aiming at:

- a. Assisting the implementation of the Regional Plan on Marine Litter Management in the Mediterranean at sub-regional levels with a particular focus on the up to five most common Marine Litter measures provided for in the updated National Action Plans (NAPs).
- b. Strengthening the implementation of harmonized approaches at regional and sub-regional level to reduce and prevent marine litter generation from land-based and sea-based sources including pilot preventions;
- c. Assisting the establishment of regional and bilateral cooperation mechanisms with relevant regional actors as well as other European Regional Seas Conventions to enhance synergies for

the implementation of the Marine Litter Action Plans being adopted or in process of preparation, with a particular focus on the collaboration with the Black Sea Commission.

21. The Secretariat has also undertaken important steps for the development of the Mediterranean Node on Marine Litter. The Mediterranean Node aims to support the implementation of the Regional Plan on Marine Litter Management in the Mediterranean, having the following objectives:

- a. Enhance awareness on marine litter prevention and reduction measures and actions at the regional, national, and local levels;
- b. Strengthen the exchange of information and knowledge, mainly regarding the best practices and measures for prevention and reduction of marine litter in the Mediterranean;
- c. Establish linkages and synergies with the Global Partnership on Marine Litter (GPML); and
- d. Enhance knowledge of GPML among local governments, NGOs/NPOs and local people in the Mediterranean.

Progress Achieved at Global Level

22. UN Environment launched #CleanSeas in February 2017, with the aim of engaging governments, the general public, civil society and the private sector in the fight against marine plastic litter. Over the next five years, the campaign will address the root-cause of marine litter by targeting the production and consumption of non-recoverable and single-use plastic. To do this effectively, citizens need to be aware, engaged and active in addressing the problem in their own lives and beyond. Moreover, hundreds of local organizations who are already doing important work on marine litter, have joint forces with the #CleanSeas campaign to highlight their efforts.

23. The campaign contributes to the goals of the Global Partnership on Marine Litter (GPML), a voluntary open-ended partnership for international agencies, governments, businesses, academia, local authorities and non-governmental organizations hosted by UN Environment.

24. The second Massive Open Online Course (MOOC) on Marine Litter was held from May to August 2017. The course is part of the UN Environment/GPA #CleanSeas campaign and presented different options and tools to combat marine pollution such as the use of effective and legitimate tools like the Honolulu Strategy. The course also provided examples and case studies that can inspire leadership at all levels, thereby increasing awareness of and stimulating creative solutions to marine litter problems.

25. The MOOC was made available in two tracks: a leadership track and an expert track. The Leadership track lasted for approximately two weeks and those who wish remained in the course also for the Expert track.

26. The MAP Secretariat informed all Contracting Parties to the Barcelona Convention in early May 2017 with a letter signed by the Coordinator of the UN Environment/Barcelona Convention Secretariat. In particular the Mediterranean Action Plan (MAP) and MED POL Focal Points received this letter along with a request to disseminate the information about MOOC on Marine Litter to their networks and communication channels, inviting them to enroll in the course as appropriate.

27. In addition to the above mentioned progress, the Secretariat is providing an updated status of implementation of the Regional Plan on Marine Litter Management in the Mediterranean, including a work plan and a timetable (Annex I to the present report,). The work plan was reviewed by the members of the Regional Cooperation Platform on Marine Litter during its first meeting (Athens,

Greece, 6 Sept. 2016) and are also invited during the second meeting to fill in their possible contribution, on an individual basis.
