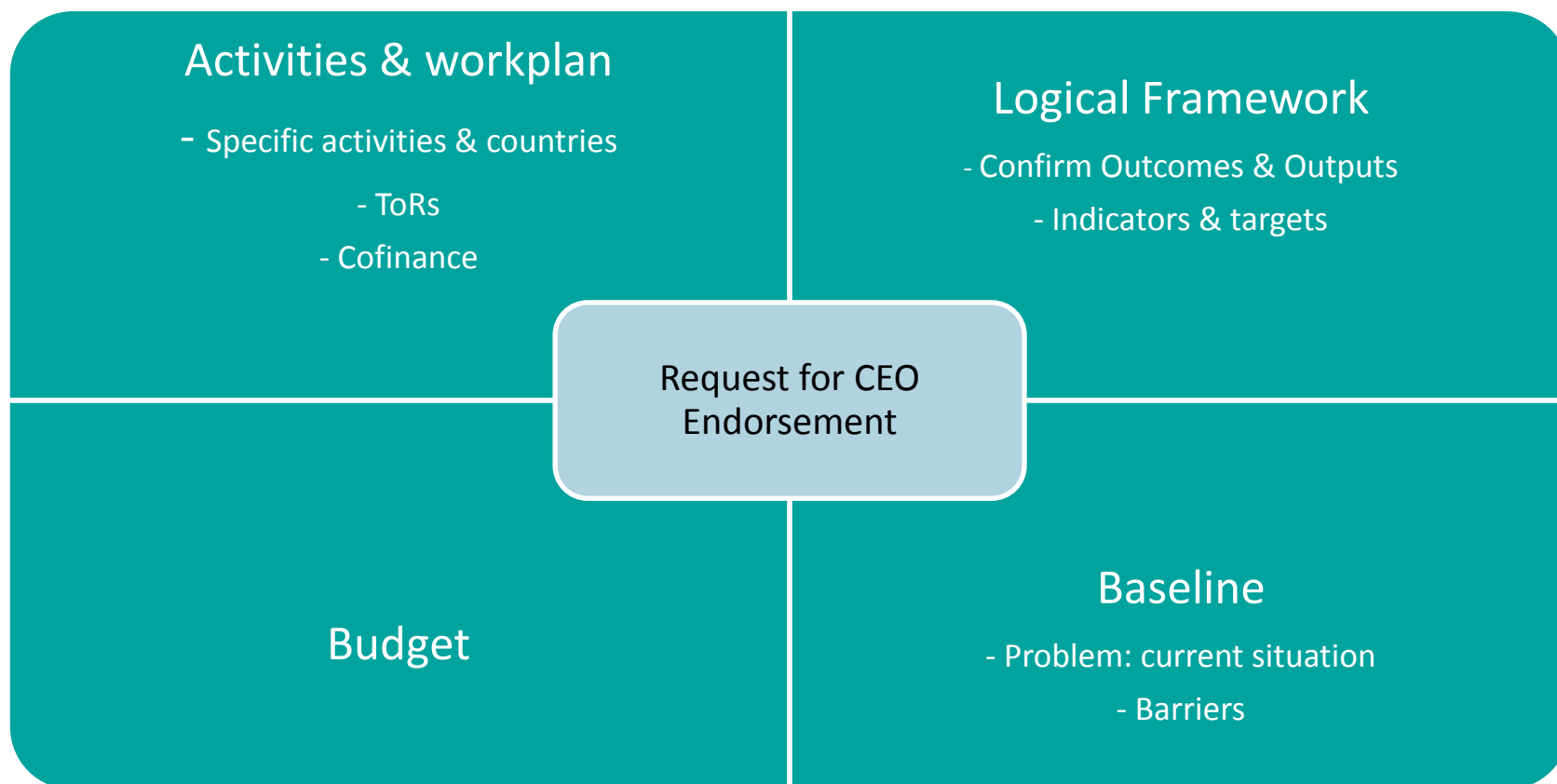

Theory of Change – Lead in Paint

What is the overall change?

Countries restrict the use of lead in paint
[n=40]

Preconditions

Paint manufacturers phase lead out of processes and pigments

Governments introduce legal limits

BAT/BEP technologies and processes

Lack of knowledge of problem.

Old formula.

Access to advice and vendors of alternatives

Economic factors

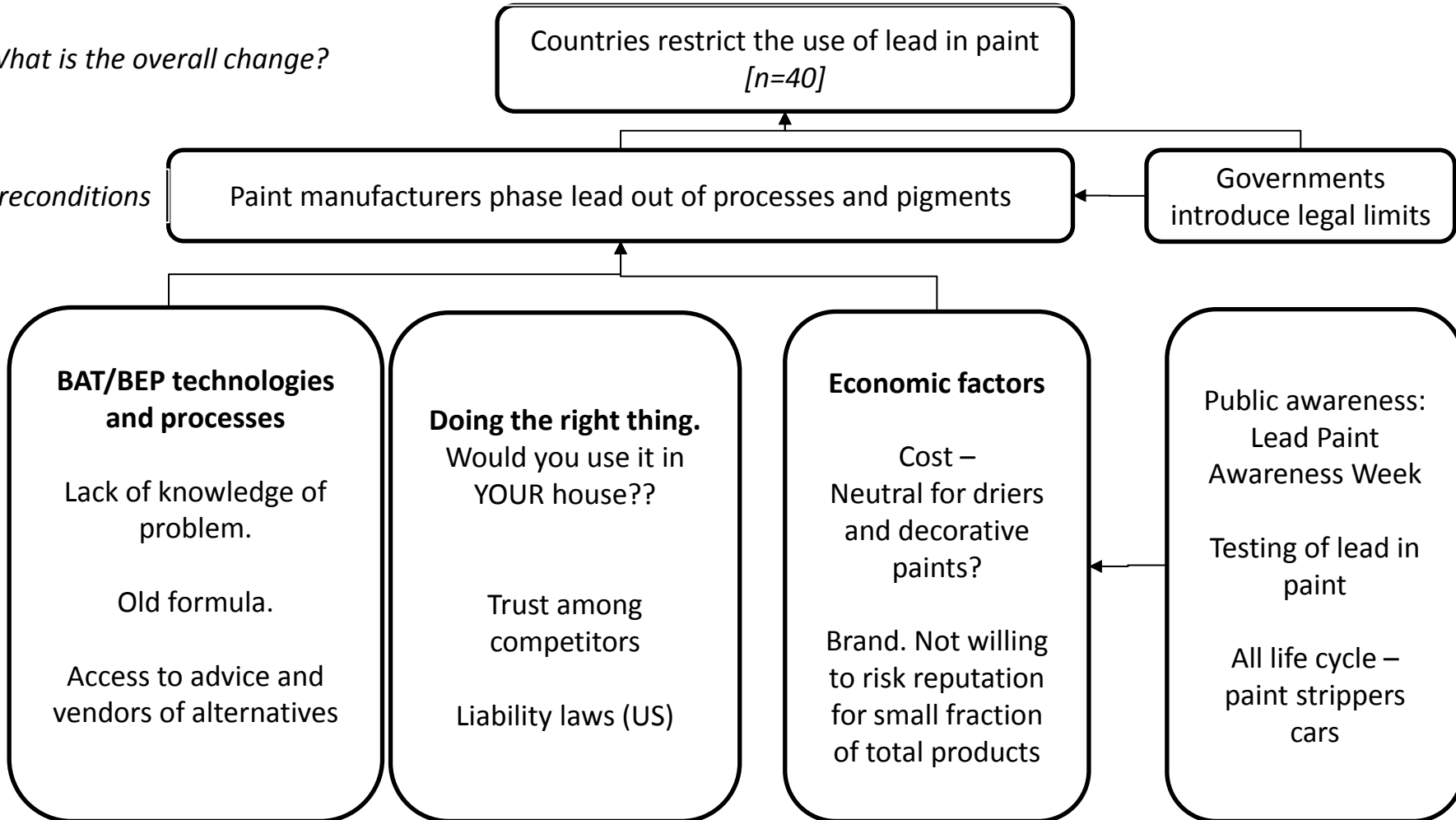
Cost – Neutral for driers and decorative paints?

Building

- A. Upstream product manufacturing (sector specific)**
- B. Construction enabling factors (procurement, green investment).**



Electronics

A. Voluntary standards (MRSL)

B. Sustainable public procurement (inc. labels)

LCA / multistakeholder



Toys

- A. Multi-stakeholder platform to look at non-compliance etc. (national level platforms)**
- B. Retailers – peer to peer network (for common standards in toy safety)**
- C. Enforcement**
