- 1. In accordance with the Procedures and Mechanisms on Compliance under the Barcelona Convention and its Protocols and the Rules of Procedure of the Compliance Committee, the 15<sup>th</sup> Meeting of the Compliance Committee of the Barcelona Convention and its Protocols will be held in Athens, Greece, on 25-26 June 2019.

- 6. The Compliance Committee is expected to **review** and **adopt** the Provisional Agenda (UNEP/MED CC.15/1) and the Provisional Annotated Agenda (UNEP/MED CC.15/2) for this session and **agree** upon the proposed timetable to conduct its work (UNEP/MED CC.15/3).
- 7. The Compliance Committee is expected to **formally adopt** the Report of the 14<sup>th</sup> Meeting of the Compliance Committee of the Barcelona Convention and its Protocols (Athens, Greece, 27-29 June 2018 and Resumed Session on 30 October 2018) (UNEP/MED CC.15/4). The Report is the result of intersessional consultation and agreement among Members and Alternate Members of the Compliance Committee following the 14<sup>th</sup> Meeting of the Compliance Committee.

- 8. Following the Guidelines agreed at the 14<sup>th</sup> Meeting of the Compliance Committee, the Committee went through the Updated Synthesis Analysis (UNEP/MED CC.15/Inf.3) and the Updated General Status of Progress (UNEP/MED CC.15/Inf.4) intersessionally.
- 9. The result of this collective exercise is presented in the form of status of reporting, key findings and draft recommendations corresponding to the national implementation reports for the biennium 2014-2015 and possible tools to improve the assessment methodology for national implementation reports for the biennium 2016-2017 (UNEP/MED CC.15/5).
- 10. The Secretariat will introduce document UNEP/MED CC.15/5, thus setting the general framework for the Compliance Committee to present its work. The Compliance Committee is expected to **examine** the key findings and draft recommendations together with the possible methodological tools and, if appropriate, to agree to forward them to the 21<sup>st</sup> Meeting of the Contracting Parties (COP 21) for their consideration.

**Agenda item 4:** National Implementation Reports for the Biennium 2016-2017: Status of Reporting and Implementation

- 11. The Secretariat will introduce document UNEP/MED CC.15/6, showing for the national implementation reports corresponding to the biennium 2016-2017 the status of reporting and, in the form of a synthesis table per country and legal instrument, a summary of the status of implementation, including the difficulties reported by Contracting Parties.
- 12. The Compliance Committee is expected to **consider** the status of reporting and implementation for the national implementation reports for the biennium 2016-2017 and **formulate** recommendations to COP 21, where relevant and appropriate.
- 13. The Secretariat will introduce a draft Explanatory Note to the new BCRS (UNEP/MED CC. 15/7) giving general guidance to Contracting Parties when reporting, so as to avoid ambiguity and any impression of non-reporting. The Compliance Committee is expected to **consider** the draft Explanatory Note and **advise** on next steps.

<u>Agenda item 5</u>: Draft Criteria for Identification of Actual or Potential Cases of Non-Compliance on the Basis of the National Implementation Reports Submitted under Article 26 of the Barcelona Convention

- 14. The 14<sup>th</sup> Meeting of the Compliance Committee considered the testing results of the Draft Guidelines for the Preliminary Assessment of Reports to Identify Actual or Potential Cases of Non-Compliance and built on lessons learned requested the Secretariat, in consultation with the General Fisheries Commission for the Mediterranean (GFCM), to put forward a set of draft criteria with its accompanying matrix, if applicable, for the identification of actual or potential cases of non-compliance.
- 15. The draft criteria are presented in document UNEP/MED CC.15/8, and the Secretariat will introduce them. The Compliance Committee is expected to **consider** the draft criteria and, if appropriate, **recommend** their adoption to COP 21.

- 16. The 14<sup>th</sup> Meeting of the Compliance Committee examined the communication from Ecologistas en Acción de la Región Murciana (EARM) (Spain) regarding the implementation by Spain of the Barcelona Protocol concerning Specially Protected Areas and Biological Diversity in the Mediterranean. The meeting concluded that the Compliance Committee designated Rapporteur for this matter should ask EARM for additional information, to enable her, building on the information received so far, to present her findings and put forward a draft preliminary decision on admissibility for discussion at the 15<sup>th</sup> Meeting of the Compliance Committee.
- 17. The communication from EARM is presented in document UNEP/MED CC.15/9, together with the additional information provided by EARM in document UNEP/MED CC.15/Inf.5. The findings and draft preliminary decision on admissibility are presented in document UNEP/MED CC. 15/10, which will be introduced by the Rapporteur.
- 18. The Compliance Committee is expected to **consider** the findings and draft preliminary decision on admissibility and **determine** on the admissibility of the communication.

Following the 14<sup>th</sup> Meeting of the Compliance Committee and the conclusions of the 86<sup>th</sup> Meeting of the Bureau (Teleconference, 11 July 2018) a number of issues for legal interpretation were raised as regards the Procedures and Mechanisms on Compliance and the Rules of Procedure of the Compliance Committee for the consideration of the 15<sup>th</sup> Meeting of the Compliance Committee. The issues so raised and possible legal interpretation are presented in document UNEP/MED CC.15/11.
- 20. The Secretariat will present document UNEP/MED CC.15/11 and the Compliance Committee is expected to **examine** the list of issues and legal interpretation so provided and **advise** on further steps to take.
