Introduction

1. At their Twentieth Ordinary Meeting (Tirana, Albania, 17-20 December 2017), the Contracting Parties to the Barcelona Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean, and its Protocols, requested the Specially Protected Area Regional Activity Centre (SPA/RAC) to prepare on a trial basis, a meeting of the thematic focal points for Specially Protected Areas/Biological Diversity for the biennium 2018-2019, under the guidance of the Coordinating Unit, to achieve the greatest possible integration with the other themes of the Mid-Term Strategy (Decision IG.23/3).
2. The Fourteenth Meeting of Thematic Focal Points for Specially Protected Areas and Biological Diversity will be convened at the kind invitation of the Government of the Republic of Slovenia, at the Slovenija Hotel (Obala 33, 6320 Portorož), in Portorož, Slovenia, from 18 to 21 June 2019.
3. The following annotations to the provisional agenda have been prepared by the Secretariat to assist the meeting with its deliberations.

4. The meeting will be opened on Tuesday, 18 June 2019, at 9 a.m., by the representatives of the host country, the Coordinating Unit of the UN Environment/Mediterranean Action Plan (UNEP/MAP) and SPA/RAC.
5. All the MAP Focal Points and SPA/BD Focal Points have been invited to attend the meeting or to designate their representatives.
6. The relevant intergovernmental or non-governmental organizations have also been invited to designate their representatives to the meeting as observers.
7. As this meeting is held on a trial basis, SPA/RAC will act as Secretariat of the Meeting, supported by other MAP Component representatives who will present the documents they have elaborated and give assistance in their discussion, as appropriate.
