A representative from the President of the fifth session of the UN Environment Assembly will brief the meeting on the outcomes of the 1st meeting of the Bureau of the UN Environment Assembly, which took place on 3 July 2019 in Trondheim, Norway, and on the subsequent letter from the President addressed to all members of the Assembly dated 8 July 2019, whereby all countries through their regional groups are encouraged to widely consult on the selection of a theme for the next Assembly on the basis of three tentative thematic areas that received general support by the Bureau as a basis for further consultations.

The Secretariat will brief the meeting on the preparation for the 6th Annual Subcommittee meeting, scheduled for 7-11 October 2019, followed by an exchange of views with member States.
