# UNEA-4 Ministerial Declaration - 2

Para #3: Highlights Several Concerns:

- Increasing pollution
- Adverse effects of climate change
- Loss of biodiversity
- Widespread environmental degradation

Para #4: Policy development & Implementation to achieve:

- Poverty eradication
- Sustainable environment & natural resources management

# UNEA-4 Ministerial Declaration - 3

Para #5: Scales up efforts to engage all stakeholders as appropriate:

- Civil society & citizens
- Indigenous people & local communities
- Private sector & academia

Para #6: Coherent policy framework & law enforcement

Para #7: Develop realistic post-2020 global biodiversity framework

Para # 10: requests Executive Director to report back on progress
