#### INTRODUCTION

This preliminary draft of MED POL proposed budget for 1997 was prepared on the basis of zero growth comparing with funds allocated for 1996.

Based on the instructions to be given to the Secretariat by the next Meeting of the Bureau of the Contracting Parties (Cairo, 1-2 April 1996), the Secretariat will revise this preliminary budget and submit it to the meeting of MAP Focal Points to be held in Athens from 6 to 10 May 1996.

Prohibition of all exports of hazardous waste from the OECD countries of the Mediterranean to countries which are not members of the European Union.
