8 Subparagraphs

- (a) Establish universal membership;
- (b) Have secure, stable, adequate and increased financial resources;
- (c) Enhance the voice and coordination function;
- (d) Promote a strong science-policy interface;
- (e) Disseminate and share evidence-based environmental information, and raise public awareness;
- (f) Provide capacity-building to countries, as well as support, and facilitate access to technology;
- (g) Progressively consolidate headquarters functions in Nairobi, as well as strengthen its regional presence;
- (h) Ensure the active participation of all relevant stakeholders.

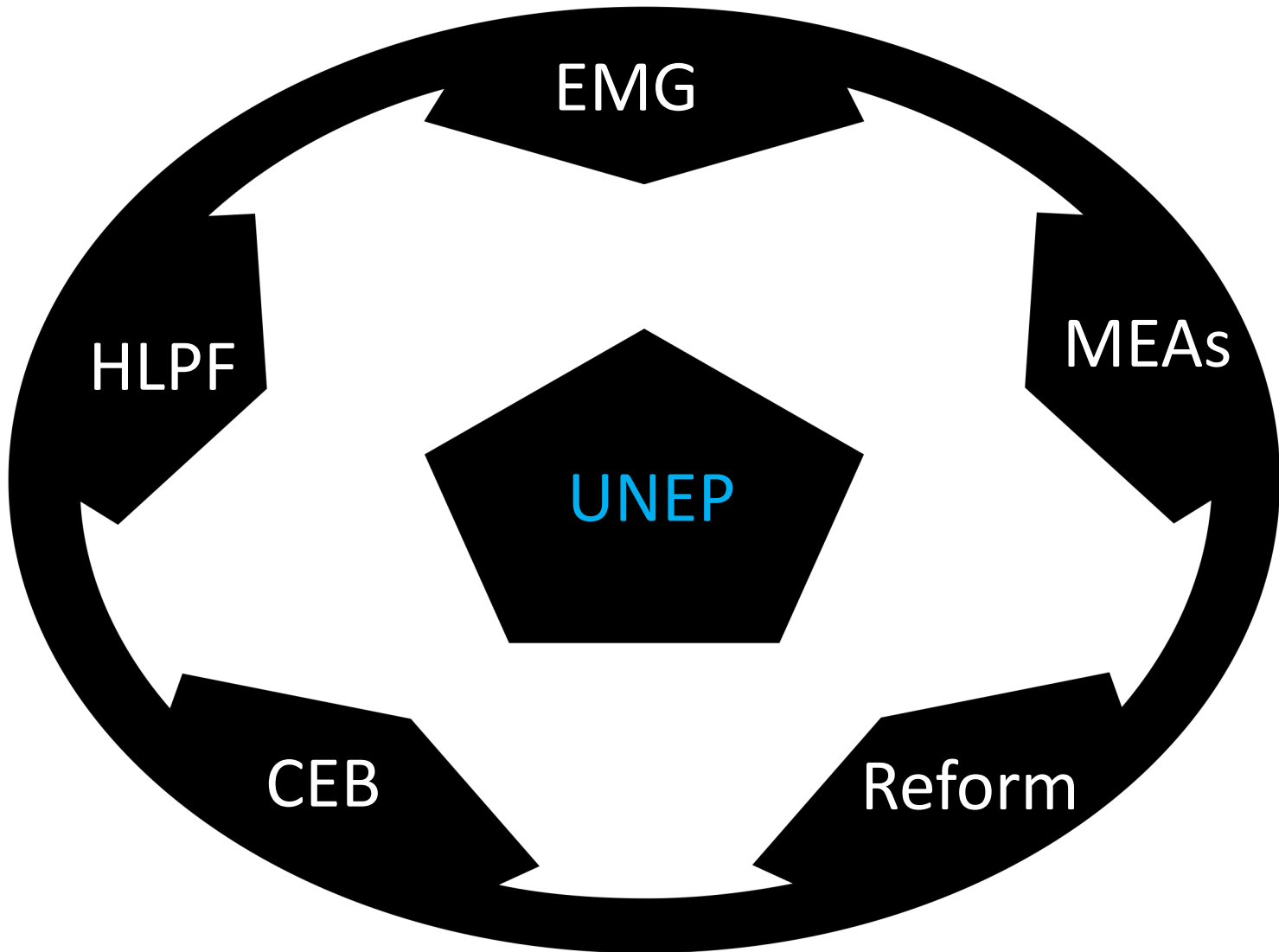
(b) Financial resources

- UNEP: 95% voluntary funding (earmarked contributions and Environment Fund), 5% UN regular budget

	2014-2015	2018-2019
UN regular budget	34.3 million	39.6 million
Environment Fund	168.4 million	138 million
Earmarked contributions	721 million	(2016-2017) 740

- Resource mobilization strategy aims to increase donor base; currently 50% of all UN member States contribute to the Environment Fund

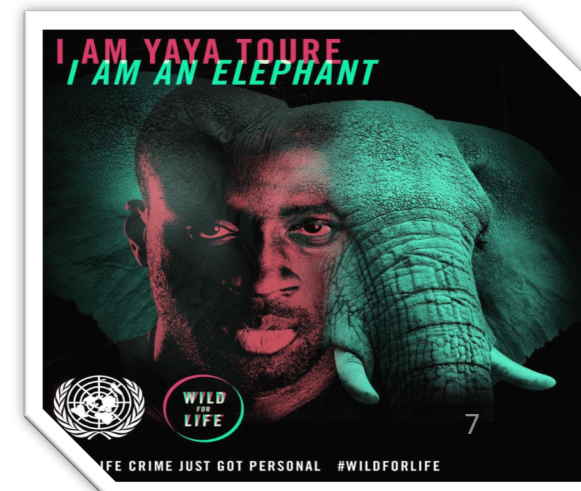


(d) Science-policy interface

- 6 Regional Offices with various subregional, country and liaison offices
