H.E. Mr. Fernando Coimbra, Chair of the Committee of Permanent Representatives, Ambassador and Permanent Representative of Brazil, will open and chair the meeting. UNEP's Executive Director, Ms. Inger Andersen, will provide an update on the key activities undertaken by the Secretariat.

UNEP's Executive Director, Ms. Inger Andersen, will provide an update on the work of the Secretariat to implement paragraph 8 in UNEA decision 4/2 in the Secretariat and present a draft questionnaire as a basis for informal consultations with regional groups. The Permanent Representatives of Sweden and Kenya will then be invited to provide an update on the offer from the Swedish Government to host a UN meeting in Stockholm in 2020 to commemorate the Stockholm Conference on the Human environment in 1972. The Bureau is invited provide guidance on the next steps.

Following the joint meeting of the Bureaux of the UN Environment Assembly and the Committee of Permanent Representatives on 3 December 2019, the CPR Bureau is expected to provide further guidance on the process for consultations towards the preparation of the political declaration referred to in General Assembly resolution 73/333, on the basis of an update from the Secretariat and a draft roadmap, taking into account inputs in writing from member States and stakeholders on the questionnaire circulated in December 2019.

Following the discussion on the development of an action plan for the implementation of paragraph 88 of the outcome document of the UN Conference on Sustainable Development entitled "The future we want" at the meeting of the CPR subcommittee on 23 January, on the basis of a Synthesis report prepared by the Secretariat, the Bureau will be invited to consider provide further guidance on the consultation process on the basis of the roadmap adopted and the 6th Annual Subcommittee Meeting and reviewed at the 148th CPR Meeting.
