Introduction

1. The XV meeting of MED Unit and Regional Activity Centres on MAP programme was held in Athens at MAP premises, on 3-4 February 1998. All RAC Directors were present. All professional staff of MEDU were also present. The list of participants is contained in Annex I to this report.

Agenda item 1. Opening of the meeting

- 2. The meeting was opened by Mr. L. Chabason, MAP Coordinator, who welcomed the participants. Mr. Chabason especially welcomed Mr. G. Benoit, the new Director of Blue Plan/RAC who replaced Mr. Glass as of January 1998. He also congratulated Mr. I. Trumbic who was appointed as of November 1997 Director of the Priority Actions Programme/RAC, replacing Mr. P. Reic.
- 3. Mr. Chabason announced to the meeting that he was just officially informed from the Headquarters in Nairobi of the appointment of Mr. Arab Hoballah, as Deputy Coordinator of MAP and of Mr. Francesco Saverio Civili, as MED POL Coordinator. Mr. Chabason, on behalf of all participants congratulated the two officials for their appointments.

Agenda item 2. Adoption of the Agenda

4. Mr. I. Dharat introduced the revised Agenda appeared in document UNEP(OCA)/MED WG.137/1/Rev.1. Following a proposal of the Director of the SPA/RAC, the meeting decided to add a sub item under item 3 entitled "1997 budget rephasing". Following a discussion the meeting approved the revised agenda which appears in Annex II to this report. The meeting also decided to conclude its work on 4 February 1998 at noon, in order to give time for individual contacts.

Agenda item 3. Review of the recommendations and programme budget for 1998-1999 as approved by the 10th Ordinary Meeting of the Contracting Parties

- a. Implementation of the recommendations and the programme budget
- 5. The discussion of this agenda item started with a tour de table during which all participants gave a briefing on the work of their Centre or programme:

REMPEC

6. Mr. J.C. Sainlos, the Director of REMPEC referred to the issue of the amendments to the Emergency Protocol. He stated that a discussion on this issue with IMO will take place at the end of March 1998. He suggested to prepare to this end a legal experts' meeting followed by the meeting of REMPEC focal points. The results will be presented to the next meeting of MAP focal points and then to the 10th Ordinary Meeting of the Contracting Parties in Malta in October 1999.

- 7. Mr. Chabason informed the Director of REMPEC that the MAP Legal Advisor Mr. Raftopoulos would be at the disposal of the Centre for legal advise, and should be present from the beginning of this exercise.
- 8. The Director of REMPEC added that a project on port reception facilities will be launched this year, and he referred to the necessity of bilateral cooperation between the centres and the countries to enhance cooperation. In this regard, he mentioned the sub-regional cooperation of REMPEC with Italy and Slovenia and expressed the wish that the same be done with the Magreb countries. He added that the signing of a Memorandum of Understanding for cooperation between Malta and REMPEC is imminent. This will set an example of cooperation on the policies to be followed for medium and long-term programme on bilateral cooperation.
- 9. On this subject Mr. Chabason stressed the importance of undertaking studies on oil activity risks (offshore, drilling, increased transport, pipelines,..) which is a very important issue for the region. As small countries have no resources to undertake these studies and to have an assessment of risks, therefore, the promotion of regional cooperation in this field becomes more acute. He also added that it is important that bilateral operational agreements are signed, and he particularly mentioned sensitive areas in Mediterranean in case of accidents, like the Aegean Sea. Operational studies, analyzing the problems should be undertaken by REMPEC and BP in order to validate the interventions of MAP in future and in order to assist countries to prevent and control potential risks.
- 10. The REMPEC director pointed out that risks associated with transport are covered by other multilateral and bilateral agreements and not within the mandate of the Centre. The Centre's main role is to help countries to develop their capabilities.
- 11. Mr. Sainlos also informed the meeting that the transfer of REMPEC offices to new premises is in progress and hopes that the inauguration could take place during the 11th Ordinary Meeting of the Contracting Parties.

Blue Plan

- 12. The new full-time Director of Blue Plan Mr. Guillaume Benoit, an Agronomist and Forestry Expert, introduced himself, and expressed the wish that efficient cooperation among the centres will be strengthened especially with PAP/RAC. He informed the participants that a Scientific Director Ms. Aline Comeau, also seconded by the French Government, has taken up her duties as from January 1998. He particularly referred to the organisation of workshops, during 1998 especially on tourism. Other fields that he wishes to be enhanced is the dissemination of information. At this point he referred to the problem of the translation of the various Blue Plan brochures, studies and fascicules addressed to the public.
- 13. A discussion followed and various ideas were expressed on the best way to have good quality of translations with the most economically way. Different proposals were made by the participants, such as to have a translation pool or to have translations done in countries with lower cost. All agreed to investigate more on this subject. The Coordinator

stressed the need for rapid production of BP material in different languages in order to encourage discussion on the level of the Mediterranean region.

- 14. The Blue Plan Deputy Director Mr. A. Hoballah, pointed out that fascicules were generally prepared by former experts at a very low cost. A new fascicule on Agriculture will be launched soon whereas the former ones on Forest and on Water will be reviewed and re-edited.
- 15. On the activity relevant to observatory and indicators, the Deputy Director of Blue Plan mentioned that additional funds from LIFE programme were provided. Funds from METAP for environmental performance indicators and the organisation of a workshop were also provided. A workshop on tourism within the framework of the MCSD is planned for next September, as well as two sub-region workshops on indicators during 1998.

PAP/RAC

- 16. The Director of PAP/RAC Mr. I. Trumbic informed the meeting that a Guidelines on rain fall induced erosions processes in the Mediterranean coastal areas has been produced. A document on "Integrated approach to develop, manage and use of water resources" has been also produced. He added that preparation of guidelines is a very important but costly activity (water resources guidelines, legal guidelines for coastal areas, guidelines for rehabilitation of historic sites). He referred to the activities concerning the assessment of carrying capacity for tourism, to water resources management, and to the collaboration of METAP/MAP on coastal management in the Mediterranean.
- 17. He also informed the meeting on the Centre's contribution to the MCSD as far as tourism is concerned, in collaboration with Spain, and referred to the review meeting held last month in Israel concerning the CAMP project.

SPA/RAC

- 18. The Director of the SPA/RAC Mr. Mohamed Saied referring to the activities of his Centre, pointed out that within the preparation of the two main experts meetings one on the implementation of the action plan for the threatened species adopted within MAP, and the second on classification of marine habitat types in Mediterranean to be convened by RAC/SPA in 1998, several documents are under preparation.
- 19. He informed the meeting that a fourth action plan on marine vegetation will be prepared for submission to the next focal point meeting as well as the other outputs of the two experts meetings. He added that in order to enhance public awareness, a mobile exhibition presenting technical material will be developed. A home page for a web site is being prepared.
- 20. Moreover he noted that field activities will be developed in 1998 (missions, cruises and specific training sessions) and assistance to Contracting Parties will be provided, taking into account the marine biology in the establishment of the national strategies in the field of biodiversity.

ERS/RAC

- The Director of the ERS/RAC Mr Michele Raimondi referred to the 21. activities of his Centre and in particular to the good progress of its intervention in the Israeli CAMP, as well as to the capacity building initiative and the related meeting to be held in Egypt on 8 March 1998, which has been planned with the aim of laying the foundations for future cooperation with Egypt, applying possibly to MEDA for financing. Moreover he mentioned that the Centre is committed to the setting up of with the European Commission, Joint Research Centre synergies Directorate, for submitting projects for funding on crop monitoring, coastal areas observation, desertification assessment, dissemination of information, and with the RAMOGE Agreement's countries and with the European Space Agency for oil spill monitoring. He stressed that the euro-mediterranean strategy and MEDA seem to be the most promising programme for funding new initiatives and that they should be primarily taken into consideration.
- 22. Finally he expressed the wish that in order to avoid duplication of work, in particular in the CAMPs, a better coordination and a more frequent exchange of information and reports should be pursued with the other RACs and MEDU.

CP/RAC

- 23. The Director of the CP/RAC Mr. Victor Macià referred to the activities of his Centre, underlining the two experts meetings held in Barcelona and the launching of a newsletter called CPNews as a tool to keep all the CP/RAC National Focal Points informed about the activities carried out by the others.
- 24. He also referred to the recommendations issued from those two experts meetings that denote the interest of most countries in promoting cleaner production among industrial sectors and the expectations they have on the CP/RAC role that go far away from the scheduled activities of the centre. Same comments were also expressed about some of the recommendations addressed to the CP/RAC in the recent Ordinary Meeting of the Contracting Parties, mainly the ones referred to the collaboration of the centre with the MCSD, the implementation of LBS Protocol, the SAP, as well as the activities that would be convenient to be developed out of Spain.
- 25. In accordance with these comments, he asked the Coordinator to fix and agree with the Spanish Government on the activities to be financed by the host country, the limits of the CP/RAC role and the ways to reach the objectives agreed upon.

MED POL

26. Mr. F.S. Civili introduced this item and in particular gave detailed information on the activities related to trend monitoring, compliance monitoring, biological effects monitoring and in the GEF project which will represent a big boost for MAP activities, and in particular for the implementation of the SAP. In the new phase of MED POL, close cooperation with CP/RAC will be pursued. Concerning cooperation with other donors, he informed the meeting that MAP will try to get funds

from the EU to organize a meeting of national experts for the adoption of guidelines, for the management of dredged material in line with the new Dumping Protocol.

- Concerning MAP's cooperation with GEF, Mr Chabason pointed out that the 27. SAP document was adopted by the Tunis meeting and the 6 million dollar project will start being implemented after its final approval by the GEF The project was faced with some difficulties concerning the eligibility of participation to the project of certain countries, The problems were solved and finally Libya is eligible namely Libya. to be part of the project. He continued by stating that GEF requested to include biodiversity and fisheries among the items funded through SAP. After a long discussion during the MAP/GEF Coordinators meeting (Athens, 22-23 January 1998), it was recommended that a complimentary SAP project of \$ 350,000, which finally will be increased to \$ 500/600,000, on biodiversity will be prepared, which will be managed by MEDU(SPA/RAC). The Director of SPA/RAC suggested that a decision on this subject is to be taken during the meeting of SPA focal points, and presented to the next meeting of the Contracting Parties through the Bureau.
- 28. The Coordinator pointed out that, in restructuring MED POL, the functions of the vacant post of Marine Scientist (P.4) will be redefined, and that the autonomy of MED POL within the framework of MEDU should be discussed. In response, the meeting was informed that by the end of spring of 1998, the restructuring of MED POL will be finalized and a new organigram would be provided.
- 29. After the general briefings, the meeting had in front of it table (No.4) with the recommendations derived from the 10th Ordinary meeting (Tunis 18-21 November 1997). The table was prepared by the Med Unit and contained tasks assigned to each of the professional staff as well as to RACs. Mr. L. Chabason, MAP Coordinator, referring to this table mentioned that this is a guide for the 1998-1999 biennium. The meeting briefly reviewed the main recommendations as contained in Table (No. 4). See Annex III to this report:
- 30. On recommendation I, on the issue of the strengthening of MEDU's cooperation with the UNCSD, the Deputy Director of BP/RAC referred to the cooperation between the MCSD and UNCSD. He pointed out that in certain working groups of UNCSD, sustainable development indicators for example, MCSD can fully participate, and he has already been invited to this group. Mr. Chabason informed the meeting that the MCSD would be represented in the UNCSD only through the UNEP delegation. He added that he will officially requests that MCSD participates in the works of the forthcoming sixth meeting of the UNCSD (New York, 20 April 01 May 1998).
- 31. On the recommendation 7 requesting MAP to contact UNEP and IMO (for REMPEC) for better utilization of the programme support cost for financing and administration of these structures, the Coordinator pointed out that as MEDU is not managing REMPEC, the possibility for IMO to share the cost of the salary of an administrative officer for REMPEC from their share of the 13% of the programme support costs should be envisaged. The Director of the Centre Mr. Sainlos was of the opinion that IMO was not in a position to share an administrative cost with UNEP

for this purpose. He also referred to the fact that IMO and REMPEC have been trying to persuade countries to second personnel to REMPEC. At the end of the discussion on this part, it was agreed that the matter will be raised by Mr. Sainlos with IMO, and the Coordinating Unit will be informed consequently on the results. The Coordinator pointed out that it is within his duty to follow-up the recommendations of the Contracting Parties and to report back on the results.

32. On the legal component, the subject of recommendation 10, the Coordinator pointed out that the legal structure of MAP will stay as it is now, by using the services of a consultant.

MEDU, MEDPOL and RAC's Structure

- 33. The Secretariat distributed Table No. 6 on the Tunis Meeting recommendations related to the issue of MEDU, MED POL, and RAC structure (see <u>Annex IV</u> to this report). The Coordinator briefly went through all recommendations explaining what is needed to be done, requesting comments from the participants on these recommendations.
- 34. On the issue of <u>delegation of responsibility to RAC</u> for representing MAP in other fora, it was stressed that when representing MAP, a clear sign referring to MAP such as "Barcelona Convention" should be requested.
- 35. On the issue of <u>assessment of the activities of the RACs</u> and other MAP programme, the Coordinator stated that MEDU will start an assessment of the Blue Plan (BP/RAC). The consultant who will do the job should be carefully selected with clear terms of reference and fixed timetable.
- 36. On the <u>financial auditing of the RACs</u>, MEDU will start the exergise with the Historic Sites programme and PAP/RAC during 1998 and with SPA/RAC during 1999. Mr. F. Tissot will be responsible for this exercise.
- 37. The issue of signing of country agreements between UNEP and the countries hosting the Regional Activity Centres was discussed. It was pointed out that agreements or formal exchange of letters are to be prepared for all RACs. Some speakers pointed out that the formal exchange of letters does not have the legal status as that of the agreement, and this should be taken into consideration. Therefore, some suggested that it is preferable to have a host country agreement rather than a simple letter. Mr. Chabason said that first we will contact Nairobi to have the view of the Headquarters and if no objection, the solution could be either a host country agreement or just exchanging of letters for particular RACs. Finally, it was agreed to start the preparation of agreements or exchange of letters with the Centres lacking such document (BP/RAC, ERS/RAC and CP/RAC).
- 38. On the issue of MAP national focal points, it was proposed by ERS/RAC that the secretariat requests the governments to renew the mandate of their national focal points, as sometimes governments are not appropriately represented. The situation is better with other focal points, such BP, PAP, MED POL, SPA and REMPEC. The concept of a "MAP national committee" could be re-explored and proposed to the Contracting Parties. ERS/RAC pointed that while other centres can sustain cost of the meeting of their NFPs, ERS/RAC is not in a position to cover these costs, therefore, a solution must be found.

- 39. On recommendation concerning the recruitment of a Deputy Director of PAP/RAC, the Coordinator pointed out that for the posts of Deputy Directors of PAP and BP the vacancy announcements should be circulated to all Med countries through the MEDU.
- b. Follow-up of CAMP projects
- 40. A discussion on the follow-up of the closed and the on-going CAMP projects took place as follows:

General Status of CAMP projects

- 41. Mr. I. Dharat distributed a chart on the status of the various CAMP projects and the responsible liaison officer for each project (Annex V) to this report. He gave a very quick briefing on each of the projects and referred, in particular, to the issue of follow-up to the closed as well as to the on-going projects. He stated that authorities responsible for the CAMP projects of Syria, Greece (Rhodes), Albania and Egypt (Fuka-Matrouh) have repeatedly expressed their interest for a follow-up action to these projects. As the experience of Donors' Conference to deal with this issue, has not been a positive one, therefore, he suggested to take a different approach in the future. The chances are good in collaborating with the newly adopted by the Helsinki Euro-Mediterranean Ministerial Conference (28 November 1997), of the "Short and Medium-Term Priority Environmental Action Programme" (SMAP) within the framework of the Euro-Mediterranean partnership.
- 42. Concrete project documents could be prepared by MAP and the relevant countries implementing CAMP projects and submitted to the European Commission (MEDA), for financing selected follow-up activities taking into due consideration the five priority fields of action selected by SMAP: integrated water management, waste management, hot spots, integrated coastal zone management and desertification. Biodiversity, having an intersectoral character, is dealt within the framework of these five fields.
- 43. Finally, he pointed out that the forthcoming Cairo Workshop to assess ICAM activities in the Mediterranean (tentatively, 15-16 April 1998), would be a good opportunity to address the follow-up issue as well as to solicit potential partners to this exercise.
- 44. A general exchange of views took place on the follow-up of CAMP projects, during which various ideas and proposals were suggested:
 - It was pointed out that there exist organizations and programmes which could finance large projects related to CAMP activities in the fields of coastal management, protected areas, training, capacity building and pollution control (SMAP, EIB, GEF, METAP).
 - Setting up of multidisciplinary teams including potential partners, to review closed and on-going CAMP projects for any follow-up activities, particularly CAMP projects in Albania, Syria, Egypt.

- The meeting in Cairo next April on the assessment of ICAM activities in the Mediterranean region could be the starting point for a consolidated future collaboration between MAP and potential partners. This exercise is considered to be a major political challenge for MAP to create a real joint collaboration involving all relevant organizations and programmes, and this what MAP representatives to the Cairo meeting should propose and achieve.
- It was also suggested that the follow-up issue should be integrated at the outset of any CAMP project, and potential partners should be involved from the beginning of the project.
- concerning the duration of a CAMP project, it was stressed that a time duration, not exceeding three years is to be followed. Another view was expressed to the effect that CAMP projects could continue for a longer period, because the activities involved could last longer, such as undertaking environmental studies.
- Need to make careful selection of activities to be covered by any CAMP project and avoid the old check-list procedure.
- Need to involve all RAC directors in a regular manner.
- 45. At the end of the discussion on this agenda item, the meeting decided that a one-day meeting of MEDU and RAC Directors should be organized immediately before the Cairo meeting on the assessment of ICAM (April 1998), for the main purpose of reviewing MAP position on the issue of the follow-up of CAMP projects, and define a MAP strategy towards potential donors. A position paper reflecting the MAP experience in this field with suggestions, keeping all options open, would be prepared by PAP/RAC for this one-day meeting. The paper should be ready at least 15 days before the Cairo meeting.
- 46. The Coordinator of MAP expressed the view that MEDU will not be able to manage all CAMP projects, due to the heavy workload already being shouldered by the office. He proposed and the meeting accepted that PAP/RAC, due to the various relevant subjects it is handling, and to its previous experience in this field, would be the suitable centre to undertake the responsibility of the overall coordination of CAMP projects, under the overall supervision of the Athens Office.
- 47. The following is a brief status of each individual CAMP project:

Fuka-Matrouh (Egypt)

48. Mr. Dharat briefed the meeting on his contacts with the Egyptian authorities concerning this project, during his mission to Egypt (December 1997). This project is very important for Egypt and they need concrete recommendations in order to assist them in the enforcement of the 1994 Environmental Law, in that area which is witnessing an uncontrollable and unsustainable development situation. He stated that the Egyptian authorities have insisted that the final Presentation Conference of the Fuka-Matrouh project should take place in May/June 1998 at the latest.

Sfax (Tunisia)

49. The Director of SPA/RAC briefed the meeting on this CAMP. He pointed out that a technical presentation meeting will take place during the second half of April 1998. A final Presentation Conference is to be convened during 1998, with the participation of national and regional authorities.

Algeria

50. Mr. Hoballah informed the meeting that the changes of the government structure was the reason for the delaying in any tangible progress. Nevertheless, a feasibility study has already been prepared by a BP consultant, and it is now in the hands of the Algerian authorities for their comments.

Morocco

51. Mr. Civili pointed out that a report prepared by Moroccan experts on the identification of the potential role of the CAMP in the management of the zone of Al-Hoceima, had been circulated to all RACs for comments. He urged the RACs who had not done so to provide their comments as urgently as possible so that a draft workplan and agreement could be proposed.

Slovenia

52. This project is at its very early stage. PAP/RAC is in contact with the Slovenian authorities on this issue.

Lebanon

53. Mr. I. Dharat informed the meeting that Lebanon is to start with a feasibility study, though it is undefined who will be responsible for this project, a matter which will be solved when the new Deputy Coordinator assumes his duties.

Israel

54. The Director of PAP/RAC informed the meeting on a review mission undertaken last month in Israel. The national strategy on sustainable development is progressing slowly. It is expected that the project will be completed during 1998.

Malta

55. The Director of PAP/RAC stated that the first report on the feasibility study was delayed due to administrative problems (change of government). Now the report is almost ready. It is hoped that by the end of next month an agreement will be ready for signature by MAP and the government of Malta. Now the project is progressing well after the administrative changes.

c. Reporting System

- 56. A draft of an integrated system on reporting based on legal documents (Convention, MED POL, protocols) has been prepared by Prof. E. Scicluna (Malta). The reporting system deriving from legal obligations of the Contracting Parties was not presented in Tunis as the final forms were not ready on time. It is, therefore, suggested to recruit a consultant to finalize it by proposing certain forms and to send it to the MAP Focal Points for their comments before presenting it to the next meeting of the Contracting Parties in 1999. All RACs would be involved in this exercise in order to have a unified reporting system for all MAP activities.
- d. MAP relations with the Secretariats for the Biodiversity and the Desertification Conventions and other Secretariats

Biodiversity Convention

- 57. The Coordinator pointed out that the Fourth Meeting of the parties to the Biodiversity Convention (CBD) to be held in Bratislava on 4-15 May 1998 will be an opportunity to present MAP and exchange views on future collaboration between MAP and the Biodiversity Secretariat. He added that it should also be examined whether global conventions are willing to associate themselves at regional level.
- 58. After a brief exchange of views, it was agreed that SPA/RAC would represent MAP and to follow-up the work of Biodiversity Secretariat, under the overall supervision of the Coordinating Unit in Athens.

Desertification Convention

59. The Director of PAP/RAC gave a briefing on the Desertification Convention and the expected role to be played by his Centre. The meeting agreed that PAP/RAC would be the responsible Centre to follow-up the work of the Desertification Secretariat, under the overall supervision of the Coordinating Unit in Athens.

MAP cooperation with other Secretariats

60. It was pointed out by various participants that Regional Activity Centres should strengthen their relations with other Secretariats in full coordination with the Coordinating Unit. At this point the Coordinator pointed out that he will attend a meeting organized by the Secretariat of the Basel Convention in Malaysia, (Kuching, 23-27 February 1998) on hazardous wastes, which also relates to the Izmir Protocol on Hazardous Wastes. He pointed out that certain countries are not at ease with the hazardous wastes protocol as they expressed the opinion that the Mediterranean hazardous wastes protocol is not compatible with some provisions of the Law of the Sea Convention. He added that the Izmir meeting on the Mediterranean protocol has given rise to positive and negative reactions. There are certain problems of regional protocols linked to Conventions. However, he pointed out that we have to defend the Izmir protocol and see it ratified.

- 61. As far as the Lugano Convention on liability and compensation is concerned, which is the basis for the Brijuni meeting (September 1997) on Liability and Compensation, Mr. Chabason informed the meeting that the Lugano Convention has not been ratified yet. On this context, MEDU will hold a second meeting of the legal and technical experts, in 1999, on liability and compensation when new elements, such as like the ratification of the Lugano Convention appear.
- 62. Concerning cooperation with the Bern Convention, MEDU maintains good relations with the Bern Secretariat which is associated with the activities of SPA/RAC and PAP/RAC. MEDU will also extend its activities and collaboration with the RAMOGE Convention.
- 63. The Director of CP/RAC stated that the Oslo and Paris Convention (OSPARCOM) has just came into force and wished to follow the works of this Convention. As the issue of participation requires financial resources, Mr. Macia informed the meeting that the Spanish government will assist financially the CP/RAC to undertake this collaboration.
- 64. The Senior Programme Officer Mr. G.P. Gabrielides briefed the meeting on MEDU's cooperation with the European Environment Agency noting especially the preparation of the Mediterranean Report and MAP's participation in the Inter-Regional Forum. He pointed out that cooperation will be enhanced in the future in the field of biomonitoring, assessment tools, joint organization of workshops and that an MOU will be signed to formalize the cooperation.
- 65. Mr. Chabason informed the meeting that the field of information will be an issue that the new Deputy Coordinator will be dealing with. The Coordinating Unit will try to solicit funds from the EC (around \$ 60,000) for a brochure in order to promote environmental issues. The brochure on the style of the World Bank publications, with "success stories" will be launched in cooperation with countries and the RACs to present success activities having positive results on the Mediterranean region.
- 66. The First Officer, Marine Scientist, Mr. Civili also informed the meeting that a special issue of MEDWAVES on "The Year of Oceans" will be published, with the support of RACs. He also referred to the home page of MEDU in the Internet is gradually improved.
- e. MAP policy towards recruitment of Consultants
- 67. The Coordinator reminded the meeting that during their 10th Ordinary Meeting, the Contracting Parties adopted a decision requesting that consultants and experts recruited by RACs shall be selected in full consultation with MEDU and the principle of diversification of nationalities of the recruited consultant should be duly observed.
- 68. There was a long discussion on the subject of the selection of consultants by MEDU and the centres. One point that was stressed was that of the geographical representation. The Coordinator emphasized that we should adhere to the recommendations of the meetings of the Contracting Parties concerning the geographical distribution in selecting consultants and also to be careful during the selection process. The experience of the recruitment of consultants for the GEF

latest project should be kept in mind. A list of parameters should be drafted which will take into consideration the geographical representation, qualifications, quality, capability to keep deadlines, previous experience of a centre with the consultant. Various views were expressed on this point stressing that a consultant should meet the standard of the international organizations. It was suggested that a roster with names of consultants could be advisable. A two speed groups of consultant was also proposed. Others felt it is difficult to apply a unified rules for all centres to follow. However, certain general rules can be accepted for all centres.

- 69. The Deputy Director of the Blue Plan Mr. Hoballah, mentioned at this point that in preparing the terms of reference we have to provide the consultant with all necessary means to carry out his work and to be specific with our requirements. It is good to refer to "key elements" when preparing a roster. As far as the remuneration is concerned, it is advisable to pay only 1/4 of the fee in advance and the rest upon satisfactory completion of the contract. Also the responsible officer has to spend some time with the consultant before, during and after the assignment.
- 70. The Director of Blue Plan Mr. Benoit said consultants should be professionals and not people who currently hold high positions in their countries. The Director of PAP/RAC mentioned that specific rules on the evaluation of the work of the consultant should be established.
- 71. The Director of SPA/RAC noted while it would be interesting to have a roster of potential consultants, possibly organized in two levels, it would however be important to maintain some flexibility, particularly for cases where qualified experts are needed at short notice.
- 72. Mr. F. Tissot, Fund/Administrative Officer, stated that the United Nations regulations on consultants could be provided and be at the disposal of the responsible officers.
- 73. Finally, it was also pointed out that the main objective of recruiting a consultant is to produce an output which would be for the benefit of the countries of the region. The issue of opening the opportunity for young people to be recruited as consultants should also be explored.
- f. Unclosed projects and rephasing of 1997 unspent funds
- 74. Mr. F. Tissot briefed the meeting on the status of the 1998-1999 budget and the new format for the new project. He pointed out that only SPA/RAC and PAP/RAC have prepared the requested new project document with a duration of 24 months. He informed the meeting that authorization to spend has been granted, with 50% of funds to be allocated to administration including salaries and 30% to activities. The title and the number of the new project has been also changed.
- 75. With regard to the six unclosed projects, he pointed out that some projects are still not closed. He urged the relevant centres to speed up the closing process.

- 76. On the rephasing of the unspent funds, he pointed out that it is not possible to rephase funds from previous years to 1998 on 31 December 1997, the old project has been formally closed. However requests received before the end of 1997 for rephasing of funds allocated to activities that could not be implemented due to unforseen reasons, have been granted.
- 77. A discussion on this issue took place, during which it was stated that some centres are facing difficulties with this situation and they have to do some rephasing from 1997 unspent funds. They recommended that a flexible approach should be envisaged to deal with this issue. An authorization, therefore, is needed. All speakers stressed that these funds should not be lost for the centres.
- 78. At the end of the debate on this issue, it was agreed that the unspent funds can be used for activities in 1998. A supplementary project, in addition to the new 1998-1999 project, will be prepared to cover the unspent funds.
- 79. Mr. Tissot informed the meeting that a fax has been received from Headquarters expressing its concern about the long delay in submitting the six-monthly progress reports. This issue need to be taken into due consideration by all RAC centres and MEDU professionals as the auditors have in the recent audits pointed out the lack of submission or delays of receipt by UNEP of progress reports. The meeting took note of this request.

Agenda item 4: Relations between MAP and the EC. Euro-Mediterranean partnership, METAP, GEF

- 80. Mr. F. S. Civili informed the meeting that there was an interest of DG XII to cooperate with MAP concerning research. DG XII had in fact asked for a list of MAP subjects on which research is needed, to identify how it could assist MAP in this respect.
- 81. Mr. Hoballah informed the meeting that during a METAP meeting in Slovenia, which was attended by few countries, many delegations commented about the future role of METAP, due to its reduced budget, since it was initially started.
- 82. With regard to MAP relations with the Euro-Mediterranean partnership, the report of the Helsinki conference, which includes the SMAP, was distributed to participants. The Coordinator pointed out that he represented MAP in the Conference. A good chance for collaboration with EC on this matter is available. SMAP could be considered a good financing programme for MAP. He suggested to launch, during the Cairo meeting on ICAM assessment, a dialogue with all Mediterranean partners with a view to improve communications and strengthen coordination with them. MAP is now, in good position to enter in such a dialogue with all relevant partners.
- 83. With regard to cooperation with the European Union, Mr. F.S. Civili, pointed out that EU is ready to finance (around \$ 60,000) the preparation and production of a booklet on MAP, on the style of the World Bank publications.

Agenda item 5: Preparation for the Consultation Meeting of the Task Managers of the MCSD (Athens, 5 February 1998)

- 84. At the outset of the discussion of this agenda item, a general exchange of views on the conceptional framework and the method of work of the Task Managers and the Thematic Working Group took place. In this regard, various points were raised. It was stated that the objective of the whole exercise is not very clear in the mind of some task managers and their supporting organizations and the main objective of the Task Managers meeting should be the clarification of this point. An added-value with realistic recommendations and with defined target dates would be the main target of the work of these groups.
- 85. As we can see in some cases, there are more than a single Task Manager, a matter which created confusion and lacked coordination. Therefore, it was suggested that in future, there should be no more than one or two Task Managers for any selected theme. Moreover, Task Managers should be competent in their field of competence.
- 86. A well defined programme document with targets and deadlines on each theme should be prepared at the very beginning of the exercise.
- 87. It was noticed that some Task Managers have not arranged for any meeting of their Thematic Working Group, a matter which could be raised and questioned during the forthcoming meeting of the Commission. Therefore, it was emphasized that at least one general meeting should be organized for each Thematic Working Group, before the meeting of the MCSD, with the participation of all its members and relevant organizations.
- 88. During the general exchange of views, Mr. I. Dharat identified 13 general conceptual points related to the work of the Task Managers and the Thematic Working Groups. The meeting agreed to include them as an annex to its report for their consideration during a RAC meeting (Annex VI to this report).
- 89. After the general exchange of views, the meeting heard brief presentations by the supporting RACs concerning each theme.
- 90. At the end of the discussion, the Coordinator stressed that only technical issues should be discussed during the Consultation Meeting of MAP and Task Managers (Athens, 5 February 1998)
- 91. A table on the composition of the Task Managers and the Thematic Working Group as approved by the 10th Ordinary Meeting of the Contracting Parties was distributed (Annex VII to this report).

Agenda item 6: Calendar of meetings during 1998 and 1999

- 92. The Secretariat distributed a draft Calendar of meetings to be organized within the framework of MAP during 1998 and requested comments and inputs. The calendar as amended is contained in <u>Annex VIII</u> to this report.
- 93. The Secretariat also distributed for information a calendar of other relevant regional and international meetings (Annex IX to this report).

Agenda item 7: Any other matters

- 94. The Coordinator informed the participants that a draft report of the meeting will be sent to all participants for comments before its finalization and distribution.
- 95. No other issues were raised during the discussion.

Agenda item 8: Closure of the meeting

96. The Coordinator thanked all RAC Directors and MEDU staff for their contributions and declared the meeting closed at 13.30 hrs on 4 February 1998.

ANNEX VI

GENERAL CONCEPTUAL COMMENTS ON MCSD

- 1. The final objectives of the exercise is not very clear in the minds of many Task Managers and Thematic Working Groups representatives.
- 2. The issue of whether the recommendations adopted or to be adopted will take the form of practical costed programmes or strategic and policy orientations has to be carefully addressed.
- 3. Need to clarify more the relation between MCSD and its steering Committee (BUR) and other MAP structures (MEDU, RAC's, ...) to avoid duplication and strengthen complementarity between them.
- 4. The method of work of the Task Managers and the Thematic Working Groups needs to be more elaborated and defined.
- 5. The MCSD could play a major role in establishing a regional common vision for all MAP activities.
- 6. RAC's needed more and adequate funds through MTF and other outside sources in order to be able to support the MCSD and its Task Managers and Thematic Working Group.
- 7. Risk of changing the MCSD status from a task force to a merely research institute.
- 8. Need to involve specialists from all fields, in the work of the Thematic Working Groups.
- 9. Need to involve professional organizations (Chambers of Commerce and Industry, Trade associations)
- 10. During the last two decades of MAP' life, most of the expertise required for its work were in the field of marine environment. Now, with the MCSD, there is a need to establish a roster for experts in other field relative to environment and sustainable development (political, economic, social, cultural, etc).
- 11. In few MCSD themes, especially Free-Trade, Mediterranean Specific Studies on the issue are rare. There is a need to start this exercise in collaboration with the appropriate partners (WTO, UNCTAD,...)
 While other issues (water, industry) require huge investments.
- 12. Need to closely follow-up the various recommendations of the MCSD (we have already two sets on water and Coastal Zone Management).
 Coordinating Unit should take lead in assisting Mediterranean countries to implement these recommendations.
- 13. Need to look to the duration period for the work of the MCSD on each selected priority theme. The time allocated to each T.M. and W.G. is very short comparing to the importance of the various priority themes selected by the MCSD.
