In the lead-up to the 7th Annual Sub Committee meeting of the UNEP CPR, the UNEP Major Group Facilitation Committee (MGFC) is organising a Major Group and Stakeholders (MGS) consultation session for effective preparation and exchange of ideas between the MGS delegates on items under consideration at the CPR.

The session will bring up to 80 participants across the Major Groups and regional civil society constituencies engaging with the UNEP system; with intention to provide dedicated space for



dialogue, consultation and discussion on key environmental governance topics being tackled at the Annual CPR, *inter alia*, UNEP's Medium Term Strategy and arrangements (format, date, etc.) for the UNEA-5. Each segment will be facilitated by one or two MGS representatives who are experts on topics under consideration, with scene-setting provided by relevant UNEP Secretariat Representatives followed by moderated discussion. Key respondents will also be invited to share their views on the different topics.
