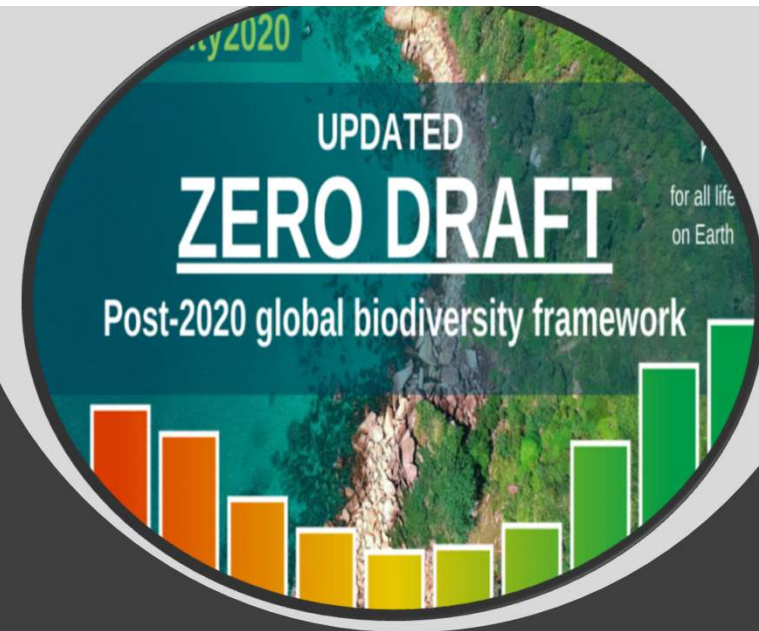

Progress on Development of the Post-2020 Global Biodiversity Framework

In 2020 the Convention on Biological Diversity will adopt a post-2020 global biodiversity framework as a stepping stone towards the 2050 Vision of "Living in harmony with nature".

In its decision 14/34 the Conference of the Parties to the Convention on Biological Diversity adopted a comprehensive and participatory process for the preparation of the post-2020 global biodiversity framework.

Process

- Regional consultations
- Phase 2: Thematic consultations
- Phase 3: Negotiation (OEWG, 1,2,3)

Roles of CBD Subsidiary Bodies & OEWG

Committees: SBSTTA , SBI and OEWG:

- Each has Unique & Valuable roles
- E.g. SBSTTA is the only forum/opportunity to discuss science among experts

Complementary roles

- E.g. for indicators: SBSTTA will discuss scientific validity then SBI will discuss how they will be implemented

Exclusive roles

- OEWG: Negotiation of Goals and Targets

Post 2020 global biodiversity framework process-Key Recommendations from WG2020-2

- Co-Chairs to Prepare updated draft of the GBF based on OEWG 2 Rome discussions
- SBSTTA to provide scientific and technical advice as per the mandates from COP, WG2020-1 and WG2020-2 (including, scientific advice – numerical values, indicators, baselines)
- SBI to provide advice on implementation – resource mobilization, capacity development, enabling conditions, knowledge management, outreach and awareness, responsibility and transparency
- Co-Chairs to prepare draft 1.0 in advance of WG2020-3 (likely Q2 2021)

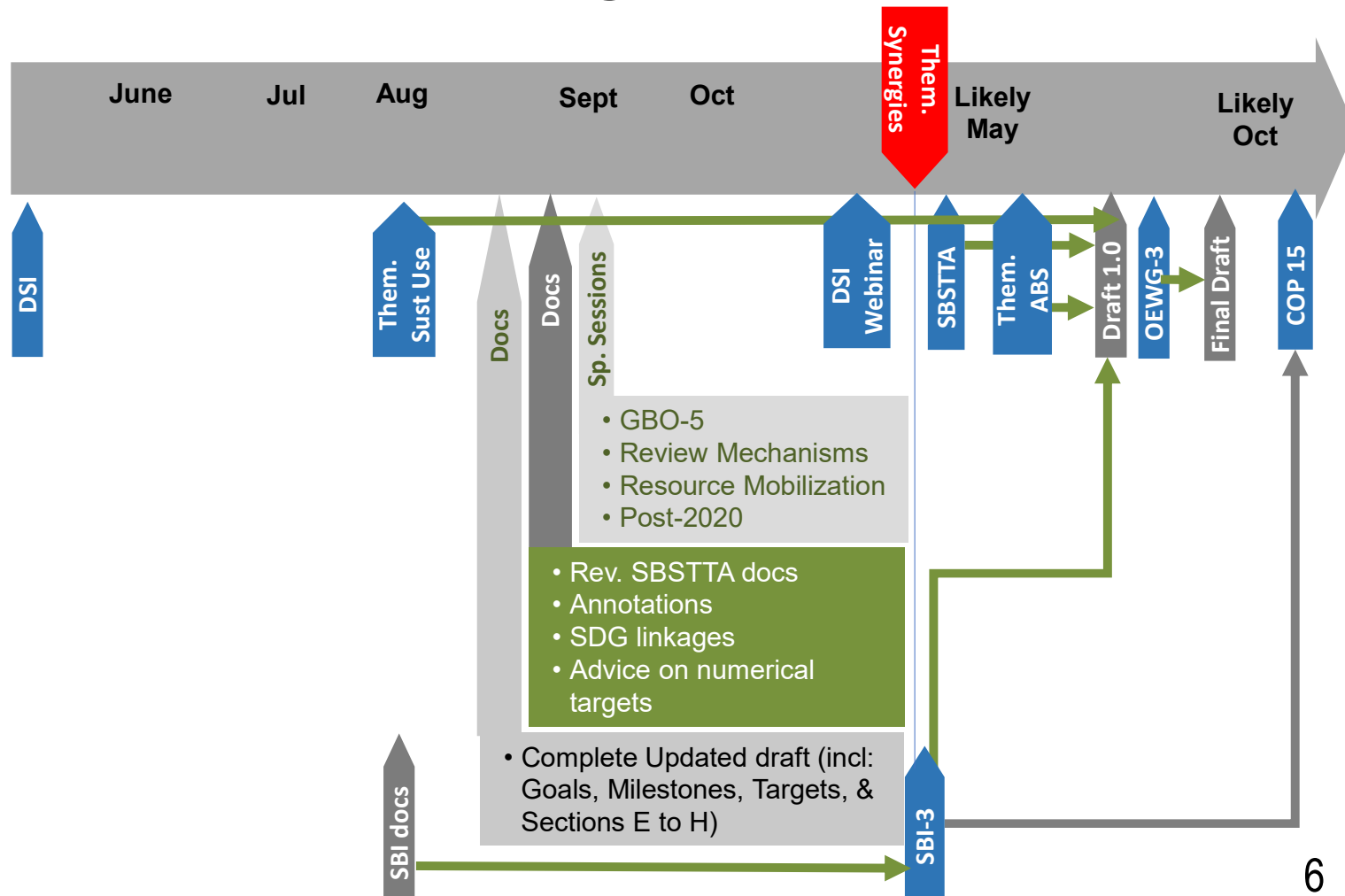
Process: Draft 1.0

- Will reflect
- WG2020-1 and WG2020-2
- WG8j, SBSTTA-23, SBSTTA-24 and SBI-3
- Written Submissions up to Feb 24, 2020
- Thematic consultations and other Post-2020 meetings

Will be the basis for negotiations at WG2020-3

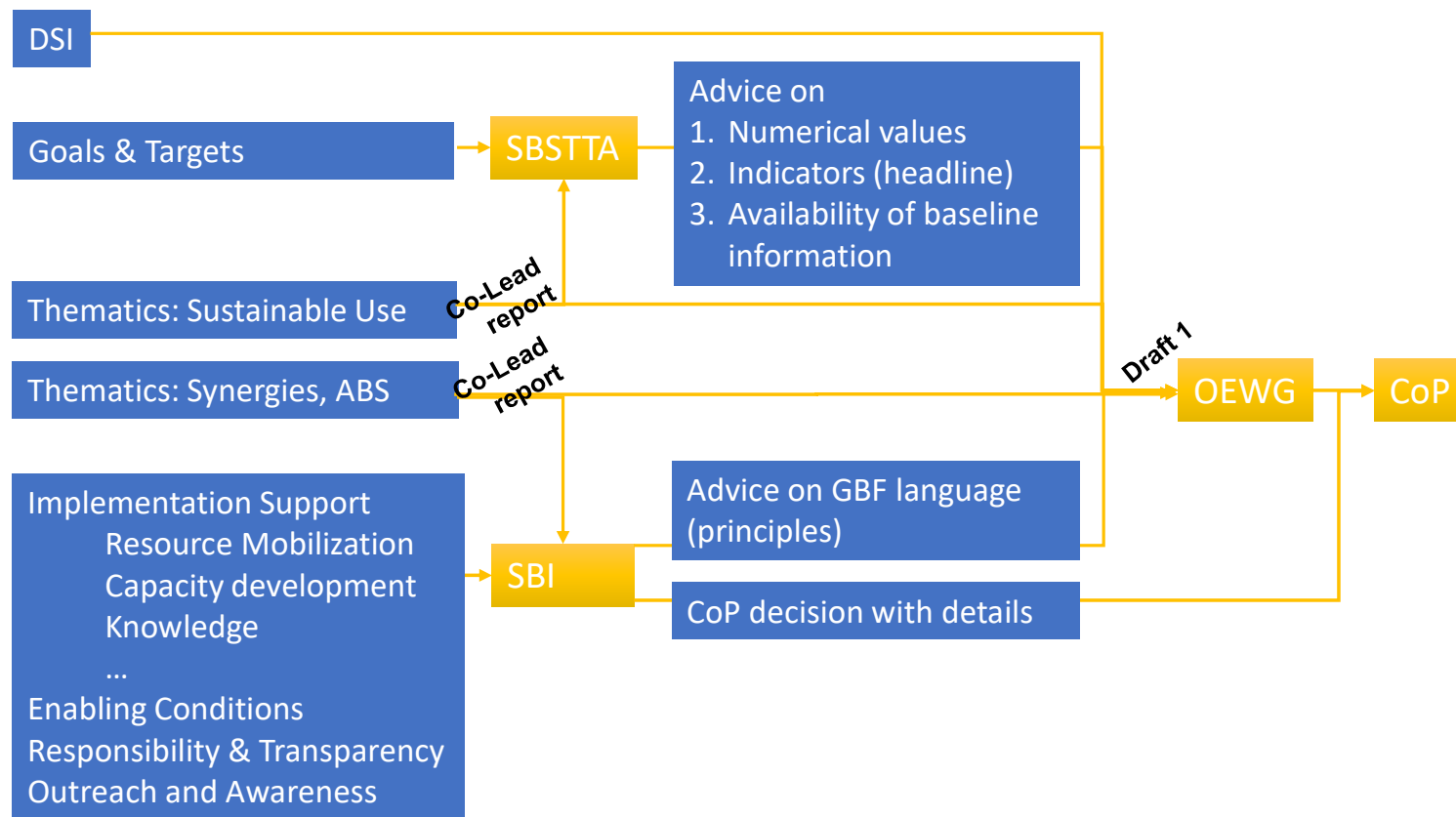

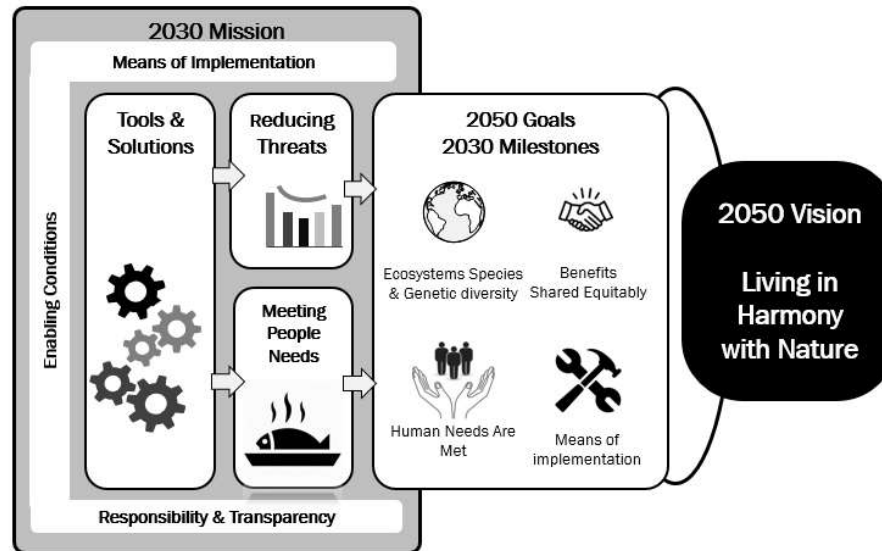

 - Update to the whole section

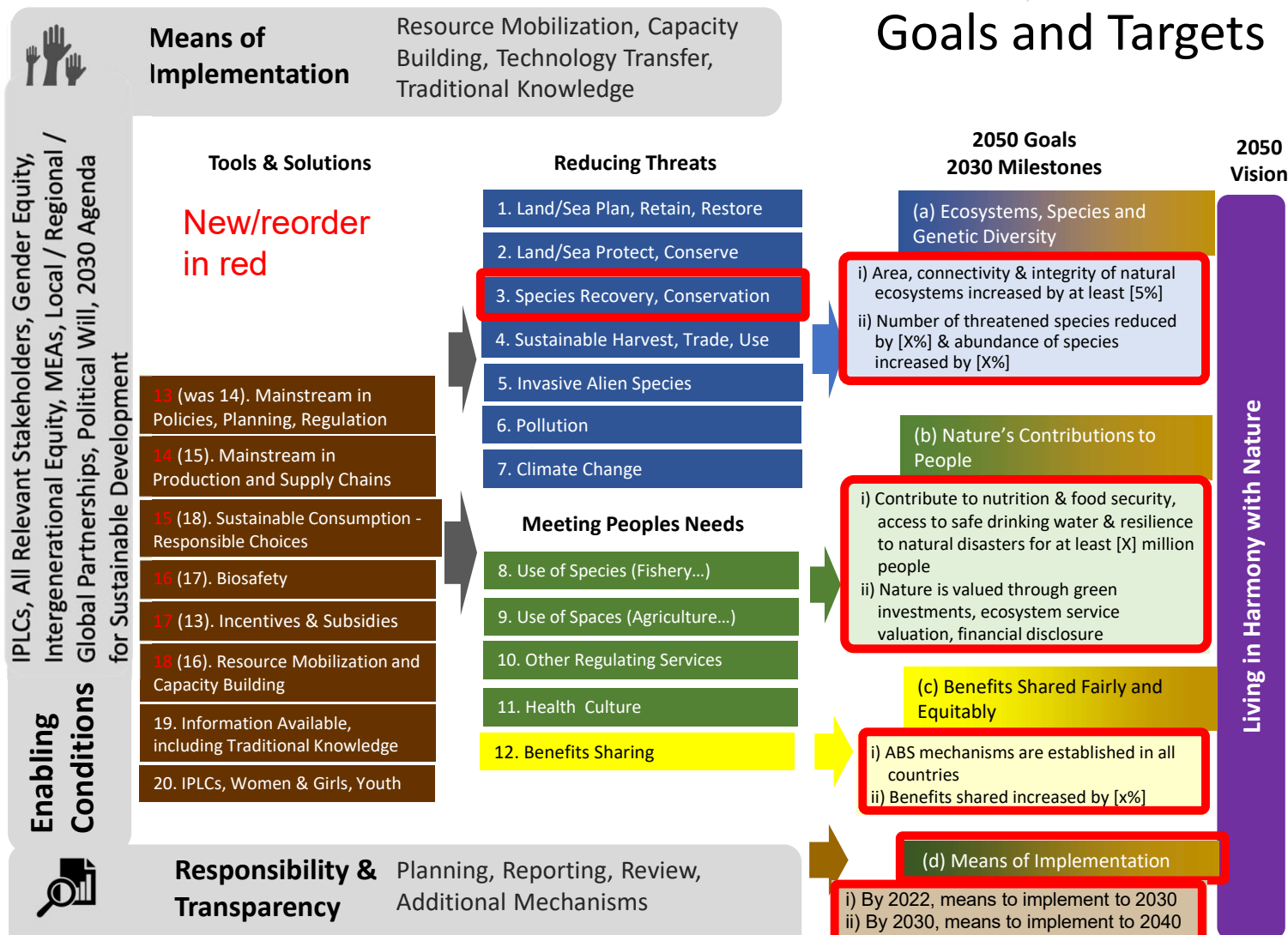

 - Ensuring we can evaluate if the Action Targets are the right tools to meet the 2050 Vision

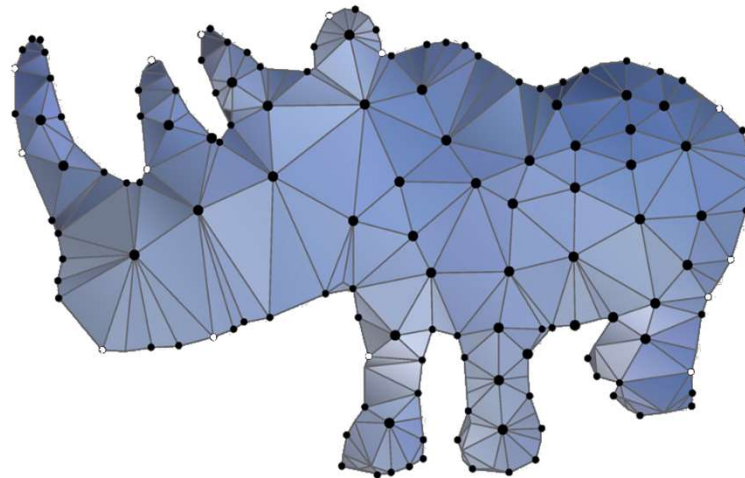

Goals and Targets



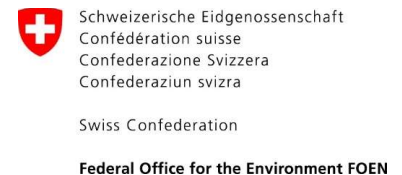
The Data reporting tool for MEAs - DaRT

A powerful tool that supports the implementation of post 2020 GBF



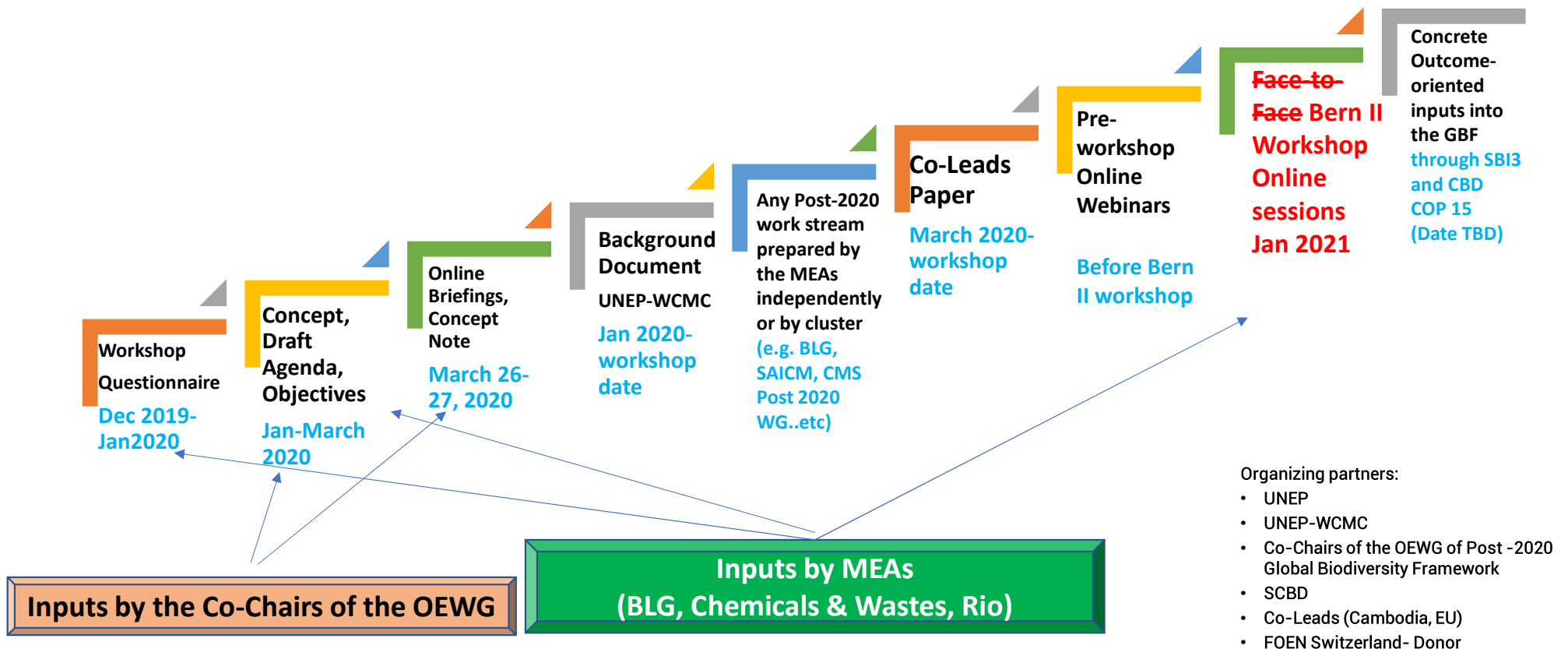

January 2020

- UNEP and the Government of Switzerland exchanged a pledged letter and concept
- Save-the-Date Letter and a pre-meeting questionnaire sent to Secretariats of MEAs (biodiversity, chemicals/waste, Rio Conventions).

February 2020

- A draft agenda prepared and consulted with MEAs clusters for inputs.
- Invitation letters were sent to MEAs Secretariats and Parties, Chairs of bureaus/standing committees, consolidated the nominations and started the logistical arrangements.
- The website launched (<https://www.unenvironment.org/events/workshop/bern-2-consultation-workshop-biodiversity-related-conventions-post-2020-global>).

March 2020

- Due to the COVID-19 pandemic, the originally planned workshop (25 – 27 March) was postponed.

The first online briefing was held on 26 and 27 March to inform the participants of the objectives and organization of the workshop. For this online briefing, a briefing note was circulated to participants.

May 2020

- The background document was prepared in consultation with MEAs for the Bern II workshop and was circulated to participants.

September 2020

- The Co-Lead's Paper was shared with participants
- The second online briefing took place on 9 September.

January 2021

- The Bern II workshop online sessions may be organized in late January 2021, subject to COVID-19.

CBD Special Virtual Sessions, in Preparation for SBSTTA-24 and SBI-3 15-18 September 2020

To help maintain momentum ahead of the UN Biodiversity Summit and towards COP 15. No decisions or formal recommendations were made.

- Launch of the fifth edition of the Global Biodiversity Outlook
- Testing of A Party-Led Review Process, Through an Open-Ended Forum (Special Session of SBI)
- Strategy for Resource Mobilization (Special session of SBI)
- Preparation of the Post-2020 Global Biodiversity Framework (Special Joint Session of SBSTTA and SBI)
