### **UNEA-5**

- Online, 22-23 February 2021
- In person, February 2022

- In October 2020, the UNEA Bureau agreed to a "two-step" approach due to the COVID 19 pandemic; 1) a 2-day online meeting of UNEA-5 on 22-23 February 2021, and 2) a resumed in-person meeting in February 2022.
- The online session will focus on a limited number of urgent administrative and procedural decisions (UNEP Medium Term Strategy and Programme of Work).
- Formal negotiations on substantive matters will be deferred to the resumed in-person session.
- An interactive leadership dialogue on the under the theme "Contribution of the environmental dimension of sustainable development to building a resilient and inclusive post-pandemic world"

## Expected outcomes from online UNEA-5



#### Procedural decisions which require urgent consideration

- Decisions on programme of work 2022–2023 and medium term strategy 2022-2025 and on management of trust funds
- Decision on the date and format of the resumed session in 2022

#### Possible consensual message from the President of UNEA

- Draft consensual message shared in mid-November focusing on green recovery
- Open online consultation held in December 2021, followed by further consultations with the UNEA Bureau in January 2022
- Significant support from many Member States, but some remain concerned about potential online negotiations and status of the text

#### Other ongoing processes – for consideration at the resumed meeting

- Future of the Global Environment Outlook process
- Outcome of the ad hoc expert group on marine litter and microplastics
- Implementation of UNGA resolution 73/333


## **Regional inputs to UNEA-5**



- Many regions have environment ministerial forums to facilitate the preparation of joint positions and political inputs to UNEA – often supported by UNEP Regional Offices
- Examples:
  - Forum of Ministers and Environment Authorities of Asia Pacific
  - African Ministerial Conference on the Environment
  - Forum of Ministers of the Environment of Latin America and the Caribbean
  - Currently there is no established environment ministerial forum in the West Asia region, but a first Environment Ministerial Meeting held in August 2020 provides a good starting point to establish such as Forum
- Regional ministerial meetings are often preceded by regional stakeholder forums;

# Looking ahead towards the resumed session of UNEA-5

- Takes place in Nairobi in February 2022, as an in-person meeting – exact date to be decided
- Overall theme remains "Strengthening Actions for Nature to Achieve the Sustainable Development Goals"
- UNEA President to continue consultations on a Ministerial Declaration
- Member States may table early draft resolutions with a focus on the "nature" theme
- Possible follow-up decisions to support the implementation of strengthened global agreements on biodiversity, climate change and chemicals
- UNEP@50 celebrated back-to-back
- Possible adoption of a declaration under General Assembly resolution 73/333
