Introduction

The Ecosystem Approach Roadmap (**EcAp Roadmap**), as agreed at the 18th Conference of the Parties, in Istanbul, 3-6 December, 2013 (COP18)¹ is following up on the hard work of experts in the three sub-clusters and as such, envisions the current biennium to focus on the development of an Integrated Monitoring and Assessment Programme.

As a first step towards this, the Integrated Correspondence Group (**Integrated CorGest**, 17-19 February, 2014) set the key direction by agreeing on a common set of indicators and specific recommendations to the Monitoring Correspondence Groups (UNEP(DEPI)/MED WG.394/Inf.5).

During the first meetings of the Monitoring Correspondence Groups (CORMON Groups, May-July 2014) monitoring experts focus their work on these common indicators, building on the Secretariat prepared General Monitoring Guidance (UNEP(DEPI)/MED WG.394/3); and on the specific Monitoring Guidances prepared on Ecological Objectives basis, following and addressing the common indicators list agreed at the Integrated CorGest.

The aim of the CORMON Pollution and Litter meeting thus is to

- (a) Discuss the options laid out in the Secretariat Monitoring Guidances, in order to find the best cost-effective and scientifically mature way of monitoring the common indicators of the pollution and litter cluster;
- (b) follow-up on the recommendations of the Integrated CorGest Group on monitoring, targeting specifically pollution and litter;
- (c) to give specific, more detailed monitoring related recommendations on the common indicators of the pollution and litter cluster;
- (d) Give recommendations, regarding EOs/indicators, which are not mature enough yet, but on which scientific developments and work in other International Bodies would suggest to include them already in early discussions.
