# Introduction

The Sixth Ordinary Meeting of the Contracting Parties to the Convention for the protection of the Mediterranean Sea against pollution (Athens, 3-6 October 1989), decided to convene every year, on the same dates, the Scientific and Technical Committee and the Socio-Economic Committee to review both separately and together the progress of the Action Plan and to prepare the decisions of the Contracting Parties. In view of the fact that this year's meeting will have to discuss the programme and budget for the next biennium 1992-1993, the two Committees will meet jointly in a plenary session to consider matters of common interest, and separately to review their respective programme components. The agenda will permit a clear distinction between the subjects falling within the responsibility of each Committee so that individual experts may attend sessions as appropriate.

The following annotations to the proposed agenda for the present meeting were prepared by the Secretariat to assist the meeting in its deliberations.

# Agenda Item 1 - Opening of the Meeting

The meeting will be opened at 09.30 hours on Monday, 6 May 1991, in the Conference Room of the Co-ordinating Unit, by the Co-ordinator of the Mediterranean Action Plan (MAP). All MAP focal points have been invited to send representatives taking into account the specific subjects of the meeting. Representatives of relevant international organizations, non-governmental organizations and the Regional Activity Centres have also been invited to attend the meeting as observers.

# Agenda Item 2 - Rules of procedure

The rules of procedure adopted for meetings and conferences of the Contracting Parties to the Convention for the protection of the Mediterranean Sea against pollution and its related protocols will apply to the meeting (UNEP/IG.43/6, Annex XI).

# Agenda Item 3 - Election of officers

In accordance with Rule 20 of the rules of procedure, the meeting shall elect from among the representatives of the Contracting Parties, a chairman, two vice-chairmen and a rapporteur.

The two vice-chairmen will chair the meetings of the two Committees. Each Committee will elect a vice-chairman and a rapporteur.

# Agenda Item 4 - Adoption of the Agenda and Organization of work

The provisional agenda prepared by the Secretariat and appearing in document UNEP(OCA)/MED WG.25/1 and annotated in the present document, will be proposed for adoption by the meeting. It is proposed that the two Committees will meet jointly on the first day (6 May) and in the morning of the second day (7 May), then separately on the afternoon of 7 May, on full of 8, 9 and in the morning of 10 May to consider their respective items and to adopt their respective final reports, and jointly again on 10 May afternoon to adopt the final report of the Joint Meeting.

The provisional agenda was prepared by the Secretariat in consultation with the Directors of the Regional Activity Centres and the relevant U.N. Organizations. Ad hoc discussion groups or drafting sub-committees may be formed by the Joint Meeting, in consultation with the Secretariat. The meeting will review and adopt the proposed timetable appearing in the Annex to the present document.

Simultaneous English-French interpretation will be available for all sessions.

# Agenda Item 5 - Progress report on the implementation of the Mediterranean Action Plan during 1990/1991 and recommendations and programme budget for 1992/1993

The Co-ordinator will introduce document UNEP(OCA)/MED WG.25/Inf.3, "Progress report on the implementation of the Mediterranean Action Plan during 1990/1991". It contains progress report on all MAP activities since the last Joint meeting (Athens, 28 May - 1 June 1990). The meeting is expected to comment and take note of the activities carried out during this period.
